The Board next considered an item contained in the Memorandum to the Board dated May 12, 1997 requesting authorization for staff to execute the agreement outlined in the Memorandum to the Board with the Virginia Department of Transportation (VDOT) in the amount of \$18,000 to construct new sidewalks along Roberts Road from Nellie White Lane to Collingham Drive.

Supervisor Bulova moved that the Board direct staff to:

- Evaluate the letter from Shawn Coleman, Chairman of the Braddock District Area Plan Task Force Review; and
- Report to the Board with its findings.

This motion was seconded by Chairman Hanley and carried by a vote of nine, Supervisor Frey being out of the room.

(NOTE: Later in the meeting, the Board clarified this item. See Clerk's Summary Item CL#86.)

# 23. I-4 - APPROVAL OF AN AGREEMENT PROVIDING FOR THE CONSTRUCTION OF A NEW SIDEWALK AND BIKE TRAIL ALONG TELEGRAPH ROAD FROM RICHMOND HIGHWAY TO THE FAIRFAX COUNTY PARKWAY (MOUNT VERNON DISTRICT) (Tape 4)

The Board next considered an item contained in the Memorandum to the Board dated May 12, 1997 requesting authorization for staff to execute the agreement outlined in the Memorandum to the Board with the Virginia Department of Transportation (VDOT) in the amount of \$83,000 to provide for the construction of a new sidewalk and bike trail along Telegraph Road from Richmond Highway to the Fairfax County Parkway.

The staff was directed administratively to proceed as proposed.

The Board next considered an item contained in the Memorandum to the Board dated May 12, 1997 requesting authorization for staff to:

- Award a contract to C&F Construction Company in the amount of \$107,885.15; and
- Reallocate funds as outlined in the Memorandum to the Board.

The staff was direct administratively to proceed as proposed.

# ADDITIONAL BOARD MATTERS

# 25. <u>AUTHORIZATION TO SCHEDULE PUBLIC HEARING ON OUT-OF-TURN</u> <u>PLAN AMENDMENT S97-CW-1CP</u> (Tape 5)

Chairman Hanley noted that on November 18, 1996, the Board adopted amendments to the Code of the County of Fairfax, Chapter 112 (Zoning Ordinance) and the Policy Plan element of the Comprehensive Plan concerning telecommunication facilities. These amendments were the first installment of the work produced by the Countywide Telecommunications Task Force and primarily addressed the installation of antenna on existing structures and buildings. At the time of the adoption of these amendments, the Board was informed that the Task Force would continue to work on the development of additional Plan guidance. Recently the Task Force endorsed suggested revisions to the Policy Plan dealing with new or replacement structures.

To bring this material forward for the Planning Commission and the Board's consideration, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and moved that the Board direct staff to schedule a public hearing on Out-of-Turn Plan Amendment S97-CW-1CP, to be held before the Planning Commission on June 11, 1997, and before the Board on July 7, 1997. This motion was seconded by Supervisor Kauffman and carried by a vote of nine, Supervisor Frey being out of the room.

# 26. <u>RESOLUTION DESIGNATING JUNE 1997 AS "TECHNOLOGY BUSINESS</u> <u>MONTH" IN FAIRFAX COUNTY</u> (Tape 5)

Chairman Hanley moved adoption of the Resolution submitted by the Economic Development Authority (EDA) designating June 1997 as **"Technology Business Month"** in Fairfax County. This motion was seconded by Supervisor Connolly and carried by a vote of nine, Supervisor Frey being out of the room.

#### 27. <u>RESOLUTION DESIGNATING WEEK OF MAY 12 THROUGH MAY 16, 1997</u> <u>AS "SMALL BUSINESS WEEK" IN FAIRFAX COUNTY</u> (Tape 5)

Chairman Hanley moved adoption of the Resolution submitted by the Economic Development Authority (EDA) designating the week of May 12 through May 16, 1997 as **"Small Business Week"** in Fairfax County. This motion was seconded by Supervisor Connolly and carried by a vote of nine, Supervisor Frey being out of the room.

# 28. **<u>REGIONAL FORUM ON OUT-OF-WEDLOCK BIRTHS</u>** (Tape 5)

Chairman Hanley stated that, as directed by the Board on February 10, 1997, the Health Care Advisory Board (HCAB) and Health Services staff represented the County at the March 24, 1997 Regional Forum on Out-of-Wedlock Births.

Chairman Hanley referred to a memorandum from the Chairman of the HCAB on the results of the Forum and moved that the Board:

- Encourage and support programs targeting the reduction or elimination of teen pregnancies in the community;
- Direct staff and the HCAB to organize and conduct a town meeting to address the issue of out-of-wedlock births; and
- Enter into a partnership agreement with the State through adoption of the Resolution endorsing efforts by the community to provide accessible family planning services aimed at preventing unintended and/or unplanned pregnancies for all women of childbearing ages.

Following a query from Supervisor Mendelsohn regarding the referenced memorandum, Chairman Hanley withheld further action on this item until a copy of the memorandum is distributed to all Board Members.

(NOTE: Later in the meeting, there was discussion of this matter. See Clerk's Summary Item CL#34.)

# 29. **<u>1997 NATIONAL RACE FOR THE CURE OF BREAST CANCER</u>** (Tape 5)

Chairman Hanley announced that the Fairfax County employee organization, the Network Support Group, invites County employees to bring friends and families on June 7, 1997 to the 1997 National Race for the Cure in the battle against breast cancer. The 5K run/walk and one mile fun walk benefits breast cancer research, education and treatment. The race rally site is located at 15th and Constitution Avenues in Washington, D.C. Registration forms are available in the Office of Personnel and the cafeterias in the Government Center and the Herrity Building.

#### 30. <u>PROCLAMATION DESIGNATING JUNE 1, 1997 AS "NATIONAL STAND FOR</u> <u>CHILDREN DAY" IN FAIRFAX COUNTY</u> (Tape 5)

Chairman Hanley moved that the Board direct staff to:

- Prepare a Proclamation designating June 1, 1997 as "National Stand for Children Day" in Fairfax County; and
- Invite representatives from Head Start, the Family Resource Centers, and the Early Intervention Strategy Team to appear before the Board on May 19, 1997 to receive this Proclamation.

This motion was seconded by Supervisor Connolly and carried by a vote of nine, Supervisor Frey being out of the room.

# 31. **<u>NETWORK AND COMPUTING SERVICES DIVISION</u>** (Tape 5)

Chairman Hanley noted that the Network Services and Data Center Services Divisions,

Department of Information Technology (DIT), have merged into one division called the Network and Computing Services Division as recommended in the recent Peat Marwick study of staffing levels in Fairfax County. Combining these two divisions will enable DIT to improve customer service and will make a more efficient operation.

#### 32. <u>RECOGNITION OF THE FAIRFAX COUNTY GOVERNMENT WEB SITE AS</u> <u>ONE OF THE 50 BEST INTERNET AND 50 BEST INTRANET SITES</u> (Tape 5)

Chairman Hanley announced that the Fairfax County Government Web Site was recently selected among the winners of *WebMaster Magazine's* 50/50 awards recognizing the 50 best Internet and the 50 best Intranet sites. In addition, the County's site is to be one of about a dozen sites profiled in the August 1997 edition of the magazine. *WebMaster*, a national publication, is highly respected in the Web publishing field.

Chairman Hanley extended congratulations for this notable achievement to those members of the Department of Information Technology (DIT) staff responsible for creating and maintaining the County's Web Site.

#### 33. ESTABLISHMENT OF 24-HOUR HOTLINE TO RECEIVE EMPLOYEE AND CITIZEN REPORTS OF POSSIBLE WASTE, FRAUD AND MISMANAGEMENT IN COUNTY GOVERNMENT (Tape 5)

Chairman Hanley stated that last November the Audit Committee to the Board voted to move forward with the process of procuring the services of a private entity to administer a 24-hour hotline to receive employee and citizen reports of possible waste, fraud and mismanagement in County government. The Board concurred at its meeting of November 18, 1996, and authorized staff to procure this service through the competitive contracting process, with preference to be given to companies willing to provide the service on a pro-bono basis. In the intervening months, a Request for Proposal (RFP) was issued, a new Financial and Programs Auditor was hired, and a contract has been awarded.

Chairman Hanley announced that, effective immediately, any County resident can call (703) 876-0526, 24-hours a day, to report any instances of waste, fraud or mismanagement in the County. Telephone calls will be answered by a live operator trained and experienced in dealing with calls from hot lines of a similar nature. The service is being provided on a pro-bono basis with the County paying only for the cost of the telephone line. This expense is being absorbed by the County Auditor's office within his current budget.

Supervisor Dix asked unanimous consent that Board insert the word "alleged" into the second line of the second paragraph above to read, "to report any alleged instances of waste......" Without objection, it was so ordered.

Following discussion, Supervisor Dix asked unanimous consent that the Board direct staff to recirculate the protocols adopted by the Board in November 1996 for the establishment of this hotline. Without objection, it was so ordered.

#### 34. **<u>REGIONAL FORUM ON OUT-OF-WEDLOCK BIRTHS</u>** (Tape 5)

(NOTE: Earlier in the meeting, this matter was discussed. See Clerk's Summary Item CL#28.)

Chairman Hanley distributed to Board Members the Memorandum from the Chairman of the Health Care Advisory Board (HCAB) on the results of the Regional Forum on Out-of-Wedlock Births.

Supervisor Mendelsohn referred to the wording in bullet number three of the written Board Matter and asked unanimous consent that the Board defer consideration of this matter until May 19, 1997. Without objection, it was so ordered.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

# 35. <u>APPOINTMENT TO THE TRANSPORTATION ADVISORY COMMISSION</u> (TAC) (Tape 5)

#### (APPT)

Supervisor Mendelsohn moved the appointment of <u>Mr. George F. Smith, Jr.</u> as the Dranesville District Representative to the Transportation Advisory Commission (TAC) to fill the unexpired term of Mr. Ivan A. Somers. This motion was seconded by Supervisor Connolly and carried by a vote of eight, Supervisor Dix and Supervisor Frey being out of the room.

#### 36. <u>**REVIEW OF PROJECT DESIGN FOR THE GREAT FALLS COMMUNITY**</u> <u>**LIBRARY PROJECT** (Tape 5)</u>

In view of the Board's approval of the Fiscal Years (FY) 1998-2002 Capital Improvement Program (CIP) which accelerated the Great Falls Community Library project to construction commencing in FY 1999, Supervisor Mendelsohn moved that the Board direct staff to initiate review of the project design. This review will incorporate an internal value engineering review and include identification of appropriate adjustments to the design required by the 1996 Virginia Uniform Statewide Building Code and the Chesapeake Preservation Ordinance. In addition, this review will address issues related to access and easement agreements as well as approval of building permits.

Supervisor Mendelsohn noted that it is his understanding that sufficient funds are currently appropriated in Project 004836, Great Falls Community Library, in Subfund 460, Library Construction, to initiate this proposed update and resolve the issues surrounding easements and land rights. He added that this action will facilitate construction of the Great Falls Library in accordance with the CIP. This motion was seconded by Supervisor Connolly and carried by unanimous vote.

# 37. ADVERTISEMENT OF PUBLIC HEARING ON PROPOSED LEASE BY THE MCLEAN CHAMBER OF COMMERCE OF SPACE IN THE MCLEAN GOVERNMENTAL CENTER (Tape 5)

(A) Supervisor Mendelsohn stated that the McLean Chamber of Commerce has volunteered to staff office space in which information about the programs of some 25 McLean-based non-profit groups as well as other community information could be disseminated to the public. This is a very worthwhile endeavor which will result in the Chamber and the groups involved providing a valuable service that might otherwise fall on County government. The logical location for this activity is the former Tax Administration Office in the McLean Governmental Center.

Accordingly, Supervisor Mendelsohn moved that the Board direct staff to:

- Negotiate a draft lease with the McLean Chamber of Commerce that will recognize the value to the County of the Chamber; and
- Advertise a public hearing to be held before the Board on June 9, 1997 at 5:00 p.m.

This motion was seconded by Supervisor Kauffman and carried by a vote of nine, Supervisor McConnell being out of the room.

# 38. **<u>REMOVAL OF ''TAX OFFICES NOW CLOSED'' SIGNS</u>** (Tape 5)

Supervisor Mendelsohn asked unanimous consent that the Board direct staff to remove all "Tax Offices Now Closed" signs from in front of District Governmental Centers. Without objection, it was so ordered.

# 39. INTENT TO DEFER THE PUBLIC HEARING ON PROFFERED CONDITION AMENDMENT APPLICATION PCA 94-H-065 (VAN METRE AT WOODLAND PARK LIMITED PARTNERSHIP) (HUNTER MILL DISTRICT) (Tape 6)

Supervisor Dix announced his intent, later in the meeting at the appropriate time, to defer the public hearing on Proffered Condition Amendment Application PCA 94-H-065.

(NOTE: Later in the meeting, this public hearing was formally deferred. See Clerk's Summary Item CL#88.)

# 40. <u>**REQUEST FOR WAIVER OF ELEVATOR INSPECTION FEES FOR THE</u></u> <u><b>TOWN OF VIENNA** (Tape 6)</u></u>

Supervisor Dix announced that the Vienna Town Hall was recently renovated and one of the improvements was the installation of an elevator. Elevator improvements have also been made at the Vienna Police headquarters. Both are Town owned buildings. Over the years there has been a very cooperative working relationship between the County and the Town of Vienna.

Therefore, Supervisor Dix moved that the Board authorize the waiver of the elevator inspection fees (\$720) for these two facilities. This motion was seconded by Chairman Hanley.

Following input from David P. Bobzien, County Attorney, the question was called on the motion which carried by a vote of eight, Supervisor Mendelsohn and Supervisor McConnell being out of the room.

# 41. **REQUEST FOR CERTIFICATE OF APPRECIATION FOR CONNIE PETTINGER, FORMER EXECUTIVE DIRECTOR OF RESTON INTERFAITH** (Tape 6)

Supervisor Dix announced that Connie Pettinger, former Executive Director of Reston Interfaith has retired after 15 years. He asked unanimous consent that the Board direct staff to invite Ms. Pettinger to appear before the Board to be recognized for her accomplishments. Without objection, it was so ordered.

# 42. **<u>PETS FOR SENIORS PROGRAM</u>** (Tape 6)

Supervisor Dix noted that the Fairfax County Animal Shelter recently celebrated its first Pets for Seniors adoption. He noted that the program makes animals available to senior citizens at no initial cost. He cited the benefits of pet ownership.

Supervisor Dix said that those interested in adopting a pet in the Pets for Seniors Program can contact the Fairfax County Animal Shelter at (703) 830-1100. Anyone interested in donating supplies, services, or volunteer time in support of this program can contact Susan Wooster, Volunteer Services Coordinator at the Shelter at (703) 830-8805.

Supervisor Dix said that those who would like to adopt a pet can view photos and other information about available animals at the County Animal Shelter on the Fairfax County web site, *www.co.fairfax.va.us*. Those without access to Internet-equipped computers can go to their nearest County library where they may find one, or they can visit the Animal Shelter.

Supervisor Dix expressed his appreciation to Mr. Hal Moore for his three-year pursuit of starting this wonderful program, and for his joint efforts with the Animal Shelter in bringing it to fruition.

# 43. **APPOINTMENT TO THE HUMAN SERVICES COUNCIL** (Tape 6)

#### (APPT)

Supervisor Dix moved the appointment of <u>Ms. Baba Freeman</u> to fill the unexpired term of Ms. Charlotte Callif as the Hunter Mill District Representative to the Human Services Council. This motion was seconded by Supervisor Connolly and carried by a vote of eight, Supervisor Mendelsohn and Supervisor McConnell being out of the room.

# 44. <u>ANNUAL ALCOHOL SAFETY PROGRAM (ASAP) AWARDS PRESENTATION</u> (Tape 6)

Supervisor Dix reminded and invited Board Members to the annual Alcohol Safety Program (ASAP) Awards Presentation on Friday, May 16, 1997 at 10:00 a.m.

# 45. <u>METROPOLITAN WASHINGTON COUNCIL OF GOVERNMENTS (COG)</u> <u>SPONSORS CONFERENCE ON FOSTER CARE AND ADOPTION</u> (Tape 6)

Supervisor Dix announced that the Metropolitan Washington Council of Governments (COG) will be sponsoring a conference on foster care and adoption, Friday and Saturday, May 16-17, 1997. He added that the Saturday activities would be held at the Government Center. He invited Board Members to attend.

# 46. <u>MID-DAY EXPRESS BUS SERVICE FROM RESTON TO WEST FALLS</u> <u>CHURCH</u> (Tape 6)

Supervisor Dix moved that the Board authorize a Consideration Item to be included in the Carryover Review - Mid-day Express Bus Service from Reston to West Falls Church in the amount of \$40,000. This motion was seconded by Supervisor Kauffman and carried by a vote of eight, Supervisor Mendelsohn and Supervisor McConnell being out of the room.

# 47. **<u>SUPERVISOR DIX SETS THE RECORD STRAIGHT</u>** (Tape 6)

Supervisor Dix noted that recently there was an article in a community newspaper which contained some inaccuracies about him and he cleared up the misrepresentations.

# 48.. <u>CONGRATULATIONS TO SADIA JAVED, AN EDISON HIGH SCHOOL</u> <u>STUDENT</u> (Tape 6)

Supervisor Kauffman asked unanimous consent that the Board direct staff to invite Sadia Javed, an Edison High School student, to appear before the Board to be congratulated for being the first place winner in the Regional Science and Engineering Fair. Without objection, it was so ordered.

# 49. **SPRINGFIELD DAYS - MAY 29 - JUNE 1, 1997** (Tape 6)

Supervisor Kauffman moved that the Board:

- Declare Springfield Days on May 29 June 1, 1997; and
- Direct staff to invite the participants to appear before the Board to be recognized at the May 19, 1997 Board meeting.

This motion was seconded by Supervisor Dix and carried by a vote of nine, Supervisor Mendelsohn being out of the room.

# 50. INTENT TO DEFER THE PUBLIC HEARING ON REZONING APPLICATION RZ 1996-LE-034 AND PROFFERED CONDITION AMENDMENT APPLICATION PCA 82-L-030-9 (SILVER LAKE, INCORPORATED) (LEE DISTRICT) (Tape 6)

Supervisor Kauffman announced his intent, later in the meeting at the appropriate time, to defer the public hearing on Rezoning Application RZ 1996-LE-034 and Proffered Condition Amendment Application PCA 82-L-030-9 until June 9, 1997 at 5:00 p.m.

(NOTE: Later in the meeting, the public hearing on these applications was formally deferred. See Clerk's Summary Item CL#91.)

# 51. <u>MAY 3, 1997 OIL TANKER TRUCK OVERTURN AT BELTWAY AND</u> <u>ROUTE 236</u> (Tape 6)

Supervisor Gross referred to an accident that occurred last Saturday morning involving a Hahn Truck Company tanker which was traveling eastbound on Route 236 and turned over as it entered the ramp for southbound I-495.

Supervisor Gross deferred to Supervisor Bulova to present this item jointly on behalf of herself and Supervisor Connolly. Supervisor Bulova said that the accident occurred at approximately 12:30 a.m. As a result of the accident, the Beltway (I-495) was closed for nine hours. Fortunately, gasoline spilling from the tanker was mostly contained and very little of the product escaped into nearby streams or close-by Lake Accotink. Actions by the Fire and Rescue Department, Police Department, Virginia Department of Transportation (VDOT) and the State's Department of Environmental Quality were quick, well coordinated and effective.

Supervisor Bulova noted that there have been several other accidents involving tankers at the Route 236/Beltway location. She said that she has contacted Supervisor Connolly, Supervisor Gross and Chairman Hanley who are most closely affected by incidents at this location and they have agreed to organize a meeting in her office to focus on this issue. Specifically:

- To review past incidents and examine commonalities;
- To identify both short term and long term strategies for improving safety at the Route 236/Beltway interchange, for example improved rumble strips? warning message boards activated by a speeding vehicle? underflow dams or retention facilities;
- To examine safety programs and procedures at the Pickett Tank Farm and to initiate changes which will result in a higher level of safety; and
- To examine the safety record of Hahn Transportation Company and other tanker companies using the Pickett facility and to initiate action to improve driver safety and to ensure safe vehicles.

In preparation for the meeting, which has been scheduled for Wednesday, June 4, 1997 at 10:00 a.m., Supervisor Bulova moved that the Board direct staff from the Police Traffic Safety Section and the Fire and Rescue Department to work with VDOT and other appropriate agencies or organizations to respond to the above issues and to prepare recommendations for discussion at the meeting. This motion was jointly seconded by Supervisor Connolly and Supervisor Gross and carried by a vote of eight, Supervisor Dix\* and Supervisor Mendelsohn being out of the room.

A brief discussion ensued among Board Members and members of the Police Department and Fire and Rescue Department.

\*Supervisor Dix asked unanimous consent that he be recorded as voting "AYE" on this item. Without objection, it was so ordered.

(NOTE: Later in the meeting, there was an additional reference to this issue. See Clerk's Summary Item CL#60.)

# 52. <u>SPECIAL EXCEPTION APPLICATION SE 97-M-019 (FIRST UNION BANK)</u> (Tape 6)

Supervisor Gross stated that First Union Bank has filed Special Exception Application SE 97-M-019 for its central Annandale location. As part of its application, First Union worked with the Annandale Central Business District Planning Committee, and intends to install the Annandale streetscape plan along the site's frontage, including landscaping, acorn street lights, and brick sidewalks. To complete the brick work before cold weather arrives, First Union has requested that the Site Plan be processed simultaneously with the Special Exception Application, and that the application be scheduled for public hearing before the Board prior to the August recess.

Therefore, Supervisor Gross moved that the Board direct staff to:

- Process the Site Plan associated with this case concurrently; and
- Schedule a public hearing to be held before the Board on August 4, 1997.

This motion should not be construed as a favorable recommendation on the Special Exception Application by the Board, and does not relieve the applicant of compliance with the provisions of any applicable ordinances, regulations or adopted standards. This motion was seconded by Supervisor Connolly and carried by a vote of nine, Supervisor Mendelsohn being out of the room.

# 53. **ENFORCEMENT OF ILLEGAL SIGNAGE AND LITTERING** (Tape 6)

Supervisor Gross stated that throughout the County she has observed an increase in the number of illegal signs along the roadways. Illegal signs are on telephone poles, trees, Virginia Department of Transportation (VDOT) signs, in medians, and in the right-of-way. This is a form of litter, and Article 12 of the Zoning Ordinance is explicit about what is permitted and what is not.

Therefore, Supervisor Gross moved that the Board direct staff to:

- Prepare a plan to increase enforcement of illegal signage and littering; and
- Report with a plan within the next month.

This motion was seconded by Supervisor Kauffman.

Following discussion, with input from Anthony H. Griffin, Acting County Executive, the question was called on the motion which carried by a vote of nine, Supervisor Mendelsohn being out of the room.

#### 54. <u>REQUEST FOR BROCHURE WHICH DETAILS THE REQUIREMENTS OF</u> <u>THE CODE OF THE COUNTY OF FAIRFAX, CHAPTER 110 (INOPERATIVE</u> <u>MOTOR VEHICLES, TRAILERS AND SEMITRAILERS)</u> (Tape 6)

Supervisor Gross noted that she is impressed with the efforts of the police at enforcing the Code of the County of Fairfax, Chapter 110 (Inoperative Motor Vehicles, Trailers and Semitrailers) violations. She expressed her appreciation to Master Police Officer John Burdette, who has been a one-man enforcement crew, and who has justifiably received attention from the media on several occasions this year.

However, Supervisor Gross suggested that a brochure which details the requirements of Code of the County of Fairfax, Chapter 110 (Inoperative Motor Vehicles, Trailers and Semitrailers) would have a beneficial return, by reducing the number of eyesores in the County, and potentially by increasing the collection rate of County decal fees and outstanding personal property tax. She added that this could be particularly effective if the brochure is available in several languages, and made widely available both from the County and from the Department of Motor Vehicles (DMV).

Supervisor Gross moved that the Board direct staff to contact the DMV, and explore the feasibility of producing such a brochure. This motion was seconded by Supervisor Connolly and carried by a vote of nine, Supervisor Mendelsohn being out of the room.

#### 55. **<u>BAILEY'S DAY 1997</u>** (Tape 6)

Supervisor Gross invited all those interested to Bailey's Day 1997. This year's event will be held on Sunday, May 18, 1997 from 12:00 noon until 4:00 p.m. at the Bailey's Crossroads Shopping Center which is located at the intersection of Route Seven and Columbia Pike.

#### 56. <u>CLOSED MEETINGS TO BE HELD TO INTERVIEW CANDIDATES FOR THE</u> <u>POSITION OF COUNTY EXECUTIVE</u> (Tape 6)

Supervisor Gross announced in accordance with the *Code of Virginia*, Section 2.1-344.1b, that within 15 days the Board will conduct closed meetings for the purpose of interviewing candidates for the position of County Executive.

# 57. <u>A PLACE WHERE PEOPLE COUNT - REPORT OF THE CITY OF FAIRFAX</u> <u>HOUSING SUBCOMMITTEE</u> (Tape 6)

Supervisor Bulova said that she recently learned about an innovative approach to revitalization that the City of Fairfax is considering and she shared the approach as outlined in a Report of the City of Fairfax Housing Subcommittee which she distributed to Board Members.

Supervisor Bulova moved that the Board:

- Refer this report to the Department of Housing and Community Development (HCD); and
- Direct staff to report with an assessment of this approach and recommendation.

This motion, the second to which was indistinguishable, carried by a vote of nine, Supervisor Mendelsohn being out of the room.

# 58. <u>CONCURRENT PROCESSING FOR KORFONTA'S ADDITION TO COUNTRY</u> <u>LANE - REZONING APPLICATION RZ 97-B-005</u> (Tape 6)

Supervisor Bulova said that a rezoning application has been filed on a small parcel of land to create two lots. This parcel on Country Lane in Annandale is adjacent to a larger parcel that will soon be developed.

Supervisor Bulova noted that the applicant is requesting concurrent processing of the final subdivision and profiles along with the rezoning. The reduction in time would allow for possible coordination of frontage improvements along Country Lane for both projects. The present configuration of Country Lane is very narrow with limited site distance.

Therefore, Supervisor Bulova moved that the Board direct staff to concurrently process the final subdivision and profiles with Rezoning Application RZ 97-B-005. The applicant understands that he does so at his own risk and must meet all appropriate Code of the County and Ordinance requirements. This motion was seconded by Supervisor Frey and carried by a vote of nine, Supervisor Mendelsohn being out of the room.

# 59. **PROPOSED CHANGE TO THE BYLAWS OF THE HUMAN SERVICES** <u>COUNCIL</u> (Tape 6)

#### (BACs)

Supervisor Bulova referred to the Bylaws of the Human Services Council regarding the provision that an appointee cannot serve more than two consecutive terms of four years and moved that the Board delete Section Two of the Bylaws which would read as follows:

Section Two, Article Three - Membership - "The term of office shall be determined by the Board of supervisors for four years. No Member shall serve more than two consecutive terms. The terms of members shall be staggered initially on a four year basis with four classes of members..."

This motion was seconded by Supervisor Connolly.

Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and asked to amend the motion to not delete the first sentence of that paragraph, and this was accepted.

Supervisor Frey asked to amend the motion to defer this item and direct staff to report with a Consideration Item, and this was accepted.

Supervisor Connolly asked to amend the motion to direct staff to provide a list of members who fall into this category, and this was accepted.

Chairman Hanley asked to amend the motion to direct the Human Services Council to provide its recommendation regarding this issue, and this was accepted.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

Supervisor Dix asked to amend the motion to direct staff to provide information as to whether there are other Boards, Authorities and Commissions (BACs) who have similar requirements, and this was accepted.

Anthony H. Griffin, Acting County Executive, announced that staff would not be able to get a response from the Human Services Council prior to June.

The question was called on the motion, as amended, which carried by a vote of nine, Supervisor Mendelsohn being out of the room.

# 60. EXPRESSION OF APPRECIATION TO BRADDOCK DISTRICT SUPERVISOR BULOVA (Tape 7)

(NOTE: Earlier in the meeting, Supervisor Bulova presented a Board Matter regarding the tanker truck accident on May 3, 1997 at the intersection of Route 236 and the Beltway. See Clerk's Summary Item CL#51.)

Supervisor Connolly expressed his appreciation to Supervisor Bulova for taking the initiative on the oil tanker issue.

# 61. <u>"MARCH FOR PARKS" A SUCCESS AT EAKIN PARK</u> (Tape 7)

Supervisor Connolly reported on the recent "March for Parks" event which he attended at Eakin Park. This event, begun by the National Parks and Conservation Association in 1990, encourages people to take an active interest in the parks in their communities. He noted that the Eakin Park event raised over \$700 and he expressed his appreciation to the individuals and groups who made the event possible. He mentioned that "March for Parks" events were also held at Eleanor C. Lawrence Park, Frying Pan Park, and Huntley Meadows Park.

# 62. HUMAN RIGHTS AWARD RECIPIENT MRS. ELLA MILLER (Tape 7)

Supervisor Connolly announced that Mrs. Ella Miller, a 116 year old Providence District resident, last week received one of the Fairfax County Human Rights Commissions' 20th Annual Human Rights Awards and he noted her many achievements as a community activist.

Accordingly, Supervisor Connolly moved that the Board direct staff to:

- Invite Mrs. Miller to appear before the Board at its next meeting, or appropriate meeting; and
- Prepare a Certificate to honor her in celebration of her remarkable service to the Providence District community and all of Fairfax County.

This motion was seconded by Supervisor Gross and carried by a vote of nine, Supervisor Dix being out of the room.

# 63. **LAND DESIGN CONSULTANTS** (Tape 7)

Supervisor Connolly explained that Land Design Consultants have recently submitted an application to rezone 5.72 acres of land located south of the intersection of Lord Fairfax Road and Wolf Trap Road. This rezoning application seeks to permit the development of 16 dwelling units at a density of 2.80 dwelling units per acre (du/ac). The applicant has determined that the Board is the owner of the right-of-way along Lord Fairfax Road that was deeded on August 31, 1936. The applicant proposes to include a portion of this right-of-way in the rezoning request being made on this property and acceptance of this application requires concurrence of filing by the Board.

Accordingly, Supervisor Connolly moved that the Board authorize the inclusion of right-of-way in the rezoning application being filed on property located at Tax Map Reference 39-1((9)) parcels 15, 16, 19, and 20. He noted that this motion does not relieve the applicant from complying with any applicable ordinances, regulations, or adopted standards and does not prejudice the consideration of the application in any way. This motion was seconded by Supervisor Gross and carried by a vote of nine, Supervisor Dix being out of the room.

# 64. <u>SPECIAL EXCEPTION APPLICATION SE 97-P-030 FILED BY LOCKHEED</u> <u>MARTIN</u> (Tape 7)

Supervisor Connolly stated that Lockheed Martin has recently filed a special exception application for a building mounted sign at its facility located at 3 Flint Hill in Providence District. This application has been scheduled for a public hearing by the Planning Commission on September 18, 1997.

Supervisor Connolly moved that the Board direct:

- The Acting Director of the Department of Environmental Management (DEM) to expeditiously and concurrently process the building permits associated with Special Exception Application SE 97-P-030; and
- Staff to schedule a public hearing to be held before the Board on September 22, 1997.

Supervisor Connolly noted that this motion does not relieve the applicant from complying with any applicable ordinances, regulations, or adopted standards and does not prejudice the consideration of the application in any way. This motion was seconded by Chairman Hanley and carried by a vote of nine, Supervisor Dix being out of the room.

#### 65. WINCHESTER HOMES REZONING APPLICATION RZ 1997-PR-003 (Tape 7)

Supervisor Connolly explained that Winchester Homes has assembled 4.8 acres of land located in the southeast quadrant of Blake Lane and Chain Bridge Road. The applicant is seeking to rezone the property from R-2 to PDH-12 to allow development of 39 single family attached homes at a density of 8.1 dwelling units per acre (du/ac). This is consistent with the Plan which designates the site for residential development at a density of 8-12 du/ac.

Supervisor Connolly stated that the applicant has determined that 3,541 square feet of right-of-way was dedicated to the Board in 1977 with the approval of the special use permit for the Washington Pastoral Counseling Center. At that time, the 98 foot right-of-way was to allow for construction of a service road along Chain Bridge Road, a concept that has been abandoned. Because the applicant proposes to include this square footage in the rezoning application, Board authorization is necessary.

Accordingly, Supervisor Connolly moved that the Board authorize the inclusion of 3,541 square feet of right-of-way adjacent to Tax Map Parcel 47-2-((1))-81 within land area of Rezoning Application RZ 1997-PR-003. He noted that this motion does not relieve the applicant from complying with any applicable ordinances, regulations, or adopted standards and does not prejudice the consideration of the application in any way. This motion was seconded by Supervisor Mendelsohn and carried by a vote of nine, Supervisor Dix being out of the room.

# 66. **FL PROMENADE LIMITED PARTNERSHIP** (Tape 7)

Supervisor Frey explained that FL Promenade Limited Partnership has filed applications for property known as Land Bay A of the Government Center. The applicant and the County have entered into an agreement for the design of a two phased stormwater management system and construction of the first phase of the system. The agreement includes certain submission deadlines to ensure that all construction is completed in a timely fashion. To facilitate construction to meet the deadlines, the applicant has requested the ability to concurrently process Site Plans, design drawings, and any other plats or plans as may be necessary.

Accordingly, Supervisor Frey moved that the Board direct the Department of Environmental Management (DEM) to accept for concurrent and simultaneous processing, Site Plans, design drawings, and any other plats or plans as may be necessary for the property that is subject to Proffered Condition Amendment Application PCA 86-W-001-7 and Final Development Plan Amendment Application FDPA 86-1-001-5 to be heard concurrently with Proffered Condition Amendment Application PCA 86-P-089-4 and Final Development Plan Amendment Application FDPA 89-P-089. This motion was seconded by Chairman Hanley and carried by a vote of eight, Supervisor Connolly and Supervisor Dix being out of the room.

#### 67. **FEE WAIVER FOR CHANTILLY HIGH SCHOOL BOOSTERS** (Tape 7)

Supervisor Frey stated that the Chantilly High School Boosters sponsored a circus at Bull Run Regional Park to raise money for the school and the students. He moved that the Board waive the fees associated with this circus fundraising event. This motion was seconded by Supervisor Mendelsohn.

Following a query to David P. Bobzien, County Attorney, the question was called on the motion which carried by a vote of eight, Supervisor Connolly and Supervisor Dix being out of the room.

#### 68. **WESTFIELDS** (Tape 7)

Supervisor Frey stated that there are a series of zoning applications filed by Westfields which were scheduled for Planning Commission public hearings this month. To resolve some issues, the hearings have been rescheduled for June 18.

At the request of the applicant, Supervisor Frey moved that the Board direct staff to schedule the public hearings for the following applications to be scheduled at the earliest possible Board meeting following the Planning Commission's recommendation:

- Special Exception Application SE 97-Y-054;
- Proffered Condition Amendment Application PCA 78-S-063-2;
- Rezoning Application RZ 97-SU-002; and
- Special Exception Application SE 97-Y-002.

This motion was seconded by Supervisor Mendelsohn and carried by a vote of nine, Supervisor Dix being out of the room.

# 69. **TRAINING FOR ANIMAL WARDENS** (Tape 7)

Supervisor Frey raised the issue of the training of animal wardens. He explained that new animal wardens undertake the 10-month law enforcement training program at the Public Safety Academy, but receive no specialized training in animal welfare or humane education prior to assuming their duties.

Therefore, Supervisor Frey moved that the Board direct the Acting County Executive and the Director of the Department of Animal Control, in consultation with the Animal Shelter Advisory Commission, to develop a formal program for training beyond the Public Safety Academy and focusing on animal welfare and humane education issues. This motion was seconded by Supervisor McConnell.

Following discussion, Chairman Hanley clarified that the motion directs staff to recommend a program and the cost.

Following further discussion, Supervisor Frey clarified that the goal of the motion is to provide the training for the new hires.

Following additional discussion, Supervisor McConnell suggested that the staff contact local veterinarians for voluntary assistance in training wardens.

The question was called on the motion which carried by unanimous vote.

# 70. **<u>RHYTHM AND CHEER DANCERS</u>** (Tape 7)

Supervisor McConnell announced that the local Rhythm and Cheer Dancers are the Disney Grand National Champions and won a total of 13 trophies in age groups of the eight dance divisions at a competition at Disney World. Accordingly, she asked unanimous consent that the Board direct staff to invite the Rhythm and Cheer Dancers to appear before the Board on May 19, 1997 to be recognized for this achievement. Without objection, it was so ordered.

# 71. **<u>LIGHTS ON THE FAIRFAX COUNTY PARKWAY</u>** (Tape 7)

Supervisor McConnell expressed concern about problems with the traffic lights on the Fairfax County Parkway.

Following discussion, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and asked unanimous consent that the Board direct staff to send a letter to the Virginia Department of Transportation (VDOT) to inquire as to when the problem with the software related to the lights will be implemented. Without objection, it was so ordered.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

# 72. **<u>BRADDOCK NIGHTS</u>** (Tape 7)

Supervisor Bulova referred to the Braddock Nights schedule which was distributed to the Board and announced that free Friday concerts throughout the summer will begin in June and will be held at both Lake Accotink and Royal Lake.

#### 73. **FEE WAIVER FOR LOYAL ORDER OF MOOSE** (Tape 7)

Supervisor Hyland stated that he received a request from the Loyal Order of Moose for a permit reapplication fee waiver and the resubmission of the plat. He explained that some time ago they had submitted a plat and paid \$3000 in permit fees to pave their parking lot. Circumstances intervened and they had to repair the roof of the building which depleted their funds. The permit for the paving has expired and they must resubmit their plat and pay again.

Supervisor Hyland moved that the Board waive the permit fee and submission of the plat, subject to the advice of the County Attorney that such waiver is legally permissible. This motion was seconded by Supervisor Frey.

Following a query to David P. Bobzien, County Attorney, the question was called on the motion which carried by unanimous vote.
