- Adopted the Resolution delegating to the County Executive or the Deputy County Executive for Management and Budget authority to award the bonds to the best bidder. Bond Counsel has advised that this form of authorization is acceptable and consistent with previous bond sales. The winning bid must offer the lowest true interest cost, and the true interest cost rate must not exceed six and one-half percent per annum.

This includes those amendments currently proposed for the County's consideration, along with any future amendments that may be proposed. This motion was seconded by Supervisor Frey and carried by a vote of nine, Supervisor McConnell being out of the room.

So that the Water Authority will have an opportunity to receive information affecting the Occoquan in a timely fashion, Chairman Hanley asked unanimous consent that the Board direct staff to share any information it receives as a result of its participation on the UOSA Board of Directors with the Water Authority. This award is given annually to those principals who extend themselves beyond the daily demands of their positions to help create superior learning environments for their students.

Supervisor Mendelsohn moved that the Board direct staff to invite Ms. Womble to appear before the Board on November 24, 1997 to recognize her for her efforts on behalf of the young people in her school and her school community. This motion was seconded by Chairman Hanley and carried by a vote of eight, Supervisor Frey and Supervisor McConnell being out of the room.

110. **APPOINTMENT TO THE HEALTH CARE ADVISORY BOARD** (Tape 18)

(APPT)

Supervisor Dix moved the appointment of <u>Ms. Gail Savage</u> as the Hunter Mill District Representative to the Health Care Advisory Board. This motion was seconded by Chairman Hanley and carried by a vote of eight, Supervisor Frey and Supervisor McConnell being out of the room.

111. **BUS USE OF SLIP RAMPS - DULLES ACCESS ROAD** (Tape 18)

Supervisor Dix said that since 1987, use of the slip ramps on the Dulles Access Road for commuter buses has been permitted by a Deed of Easement between the Commonwealth of Virginia through the Virginia Department of Transportation (VDOT) and the Metropolitan Washington Airports Authority. Under the current plan for the operation and maintenance of the ramps, which are located just east of the Wiehle Avenue interchange, use is limited to the eastbound direction during the morning rush hour. The State Police open the gates to the ramp, police the use, and close the slip ramp.

Supervisor Dix said that the Toll Road is currently under construction, and since the opening of the Wiehle Park-and-Ride facility in January, commuter bus ridership has steadily increased. In addition, there are occasions, such as adverse traffic conditions and accidents,

which cause significant traffic delays on the Toll Road. He added that his office has received many requests for necessary accommodations to be made to open the slip ramps during the evening rush hour for westbound buses. In addition, there exists the need to be able to open the ramp eastbound during certain traffic emergency situations during the evening rush hours.

Supervisor Dix said that he has been advised that a request would be considered for additional usage of the slip ramps by Fairfax Connector buses, should VDOT and the County agree that this is desired. The State Police responded to an inquiry by VDOT relative to this matter in early 1996, and indicated that they did not have the sufficient numbers of troopers and funding to effectively monitor additional usage of the ramps.

Therefore, Supervisor Dix moved that the Board direct the Office of Transportation to work with the Airports Authority and VDOT to devise a plan that may enable the maximum utilization of these slip ramps, and that this matter return to the Board as an Information Item. Supervisor Dix said that with the opening of the Herndon/Monroe Park-and-Ride facility in late 1998 and with the additional Dulles Corridor Bus Service to be provided in conjunction with that facility, another set of slip ramps will be required at some location west of Wiehle Avenue and he further moved that the Board direct staff to determine what action and resources would be required to both construct and operate these additional ramps and report its findings. This motion was seconded by Supervisor Mendelsohn and carried by a vote of nine, Supervisor McConnell being out of the room.

112 ALCOHOL BEVERAGE CONTROL (ABC) LICENSES ISSUE (Tape 18)

Supervisor Dix said that there has been a change in the issuance of Alcohol Beverage Control (ABC) licenses for on and off premise activities and he asked unanimous consent that the Board refer this issue to the Legislative Subcommittee.

Following discussion, with input from David P. Bobzien, County Attorney, without objection, the request was so ordered.

113. **VENDORS AT PARK-AND-RIDE FACILITIES** (Tape 18)

Supervisor Dix moved that the Board direct staff to review the proper competitive process involving the private sector, to locate vendors for coffee, newspapers, and possibly other sundry items at park-and-ride facilities. This motion was seconded by Supervisor Kauffman and carried by a vote of nine, Supervisor McConnell being out of the room.

114. **EXAMINATION OF DRIVING WHILE INTOXICATED (DWI) LAWS** (Tape 18)

Supervisor Dix referred to an issue he raised at the October 27, 1997 Board meeting regarding an examination of the Driving While Intoxicated Laws (DWI) and he reiterated his request that the Board direct staff to facilitate in a timely manner, an examination of County laws regarding Driving While under the Influence (DWI) and Habitual Offenders, as well as the bonding requirements in terms of setting bonds for those who are charged with being involved with accidents that result in fatalities.

Supervisor Dix asked unanimous consent to add to his request that the Board consider a legislative initiative that includes mandatory minimum sentences for repeat offenders under DWI charges. Without objection, it was so ordered.

115. FAIRHILL ELEMENTARY SCHOOL STUDENTS TO PERFORM AT THE WHITE HOUSE (Tape 18)

Supervisor Connolly stated that the Fairhill Elementary Children's Festival Chorus has been selected to perform for President and Mrs. Clinton and their guests at the reception for the volunteers who decorate the White House for the holiday season. The chorus will be performing for the decorators and the First Family on December 3, 1997 prior to the press tour of the holiday decorations hosted by Mrs. Clinton. That evening the children will also be performing and dining at the Willard Hotel.

Supervisor Connolly moved that the Board direct staff to invite the Fairhill Elementary Children's Festival Chorus to appear before the Board on December 8, 1997 to be recognized and to perform a brief sample of their holiday program. This motion was seconded by Supervisor Mendelsohn and carried by a vote of nine, Supervisor McConnell being out of the room.

Supervisor Connolly noted that his daughter may participate in this program.

116. **LAUREL HILL OUT-OF-TURN PLAN AMENDMENT S95-CW-2CP** (Tape 18)

Supervisor Connolly reminded the Board that at its last meeting, it returned the Laurel Hill Out-of-Turn Plan Amendment to the Planning Commission for reconsideration. A verbatim of the Board's action has been prepared and he moved that the Board clarify its intent and designate the verbatim transcript that the Clerk's office has prepared of the Board's discussion of the Board's motion and the Minutes related to Out-of-turn Plan Amendment S95-CW-2CP to be forwarded to the Planning Commission. This motion was seconded by Supervisor Mendelsohn.

Following discussion, with input from David P. Bobzien, County Attorney, the question was called on the motion which carried by a vote of nine, Supervisor McConnell being out of the room.

117. **DEER HUNTING LIMITS WITHIN THE COUNTY** (Tape 19)

Supervisor Frey raised the issue of legal deer hunting limits in the County. He moved that the Board direct the staff to request the State's Department of Game and Inland Fisheries to remove the existing deer hunting limits for licensed hunters in the County.

Following a brief discussion, this motion was seconded by Supervisor Mendelsohn and carried by a vote of nine, Supervisor McConnell being out of the room.

A brief discussion continued following the vote.

118. **DESIGNATION OF "NATIONAL FAMILY WEEK"** (Tape 19)

Supervisor Bulova stated that Thanksgiving week, November 23-29, 1997, has been designated "National Family Week" by Family Service America (FSA) and by a Proclamation signed by the President of the United States. FSA defines a family as consisting of two or more people, whether living together or apart, related by blood, marriage, adoption or committed to care for one another.

Supervisor Bulova explained that National Family Week is a week set aside to annually recognize and appreciate families and their role in caring for individual members, thus contributing to society. She noted that the week also reinforces and encourages healthy family life and family values.

So that the County can join in the thousand or more organizations across the nation in celebrating National Family Week, Supervisor Bulova moved that the Board direct staff to prepare a Resolution to be presented to members of the Fairfax County Faith Communities in Action at the Board meeting scheduled for November 24, 1997 declaring November 23-29, 1997 as "National Family Week" in Fairfax County. This motion was seconded by Supervisor Frey and carried by a vote of eight, Supervisor McConnell and Supervisor Mendelsohn being out of the room.

119. RETIREMENT OF JAMES HEBERLEIN, DIRECTOR, PARK AUTHORITY (Tape 19)

(NOTE: Earlier in the meeting, the retirement of James Heberlein, Director, Park Authority, was announced. See Clerk's Summary Item CL#12.)

As announced earlier in the meeting, Supervisor Gross stated that James Heberlein, Director, Park Authority, is retiring after 35 years of dedicated service to the County. She noted that he was responsible for the rise of the County's nationally-recognized park system, from his first years with the County to his long tenure as Director.

Accordingly, Supervisor Gross moved that the Board direct staff to invite Mr. Heberlein to appear before the Board at a date to be determined, to be recognized for his service to the County. This motion was seconded by Supervisor Frey and carried by a vote of eight, Supervisor McConnell and Supervisor Mendelsohn being out of the room.

(Later in the meeting, there was further discussion of Mr. Heberlein's retirement. See Clerk's Summary Item CL#122.)

120. CONCURRENT PROCESSING OF SITE PLAN WITH REZONING APPLICATION RZ 1997-MA-044 AND SPECIAL EXCEPTION APPLICATION SE 97-M-044, SKYLINE ENTRE LP (Tape 19)

Supervisor Gross stated that Skyline Entre LP has filed Rezoning Application RZ 1997-MA-044 and Special Exception Application SE 97-M-044 for property located at 5701 Columbia Pike and identified as Tax Map 61-2((1)) parcel 82 and 61-2((43)) parcel 4. The applicant has requested processing of the Site Plan concurrent with the Rezoning and Special Exception applications.

Accordingly, Supervisor Gross moved that the Board direct staff to process the Site Plan associated with these applications concurrently. This motion should not be construed as a favorable recommendation on the Rezoning or Special Exception applications by the Board, and does not relieve the applicant of compliance with the provisions of any applicable ordinances, regulations, or adopted standards in any way. This motion was seconded by Supervisor Connolly and carried by a vote of eight, Supervisor McConnell and Supervisor Mendelsohn being out of the room.

121. CONCURRENT PROCESSING OF SITE PLAN WITH A SPECIAL EXCEPTION APPLICATION FOR PROPERTY LOCATED AT 6318 LEESBURG PIKE (Tape 19)

Supervisor Gross stated that Mubarek Corporation has filed a Special Exception application to construct a gasoline service station with quick service food store on property located a 6318 Leesburg Pike and identified as Tax Map 51-3((1)) parcels 33 and 34. The applicant has requested processing of the Site Plan concurrent with the Special Exception application request.

Accordingly, Supervisor Gross moved that the Board direct staff to process the Site Plan associated with this application concurrently. This motion should not be construed in any way as a favorable recommendation on the Special Exception application by the Board and does not relieve the applicant of compliance with the provisions of any applicable ordinances, regulations, or adopted standards. This motion was seconded by Supervisor Connolly and carried by a vote of nine, Supervisor McConnell being out of the room.

122. FURTHER DISCUSSION REGARDING THE RETIREMENT OF JAMES HEBERLEIN, DIRECTOR, PARK AUTHORITY (Tape 19)

(NOTE: Earlier in the meeting Mr. Heberlein's retirement was discussed. See Clerk's Summary Items CL#12 and CL#119.)

Citing the retirement of James Heberlein, Director, Park Authority, Supervisor Hyland noted that he had a certificate to present to him entitling him to one pound of green peppers from the Mount Vernon Farmers' Market.

123. A NEW INDIVIDUAL RETIREMENT ACCOUNT (IRA) OPPORTUNITY BECOMES AVAILABLE IN 1998 (Tape 19)

With reference to his written Board Matters handout, Supervisor Hyland asked unanimous consent that the Board direct staff to publish information for County employees about the new Roth Individual Retirement Account (IRA) that was referenced in the recent Financial Planning Conference presented by the Office of Personnel. Without objection, it was so ordered.

124. RECOGNITION OF FORMER REPRESENTATIVE OF THE FAIRFAX COUNTY REDEVELOPMENT AND HOUSING AUTHORITY (FCRHA) (Tape 19)

(BACs)

Supervisor Hyland stated that Mr. Joseph Adinaro served for more than eight years on Fairfax County Redevelopment and Housing Authority (FCRHA) and asked unanimous consent that the Board direct staff to invite him to appear before the Board to be recognized for his years of service. Without objection, it was so ordered.

125. "YOU AND YOUR LAND," A PUBLICATION OF THE NORTHERN VIRGINIA SOIL AND WATER CONSERVATION DISTRICT (NVSWCD) (Tape 19)

Supervisor Hyland shared copies of the newest edition of the Norther Virginia Soil and Water Conservation District's (NVSWCD) Homeowner's Guide for the Potomac River Watershed with Members of the Board. He asked unanimous consent that the Board direct staff to invite Dewey Bond, Chairman of the NVSWCD, to make a short presentation on "You and Your Land A Homeowner's Guide for the Potomac River Watershed." Without objection, it was so ordered.

126. LORTON TOWN CENTER REZONING APPLICATION RZ 1996-MV-037 AND PROFFERED CONDITION AMENDMENT APPLICATION PCA 76-L-019 (Tape 19)

With reference to his written Board Matter regarding Rezoning Application RZ 1996-MV-037 and Proffered Condition Amendment Application PCA 76-L-019 for the Lorton Town Center, Supervisor Hyland moved that the Board direct staff to schedule the

public hearing to be held before the Board on February 23, 1998. He noted that this motion does not relieve the applicant from complying with the provisions of any applicable ordinances, regulations or adopted standards and does not prejudice the consideration of the land use application in any way. This motion, the second to which was inaudible, carried by a vote of nine, Supervisor McConnell being out of the room.

127. **GUNSTON HEIGHTS AND WILEY SUBDIVISION** (Tape 19)

With reference to his written Board Matter regarding the failing septic systems in the Gunston Heights and Wiley Subdivision, Supervisor Hyland noted that this issue was discussed in Executive Session. He explained the background of this issue, noting that on March 21, 1994 the Board took action and created a conservation district on behalf of the Gunston Heights and Wiley citizens. On June 27, 1994 the Board amended the Comprehensive Plan and expanded the sewer shed to include only lots with a house located in this subdivision, in order that a pump and haul system could be constructed. The contract for designing the system was given on the same date. The County also took steps to make available to the homeowners low interest loans and appropriated full funding.

Supervisor Hyland noted, however, on the advice of the County Attorney, and as part of the pump and haul system for this community, each homeowner must sign certain restrictive covenants, including, but not limited to, agreeing not to construct any addition to existing homes. Over the next few years, less than 50 percent of the homeowners signed those covenants. It is the opinion of the County Attorney that unless all homeowners sign the Declaration of Covenants, it "will be extremely difficult to restrict the owners of vacant lots (located within this subdivision) from developing their properties and hooking into the sanitary sewer pump and haul system."

Supervisor Hyland stated that the Planning Commission considered a Plan Amendment regarding the issue of running a public sewer pipe through this community, but rejected that Plan Amendment and recommended that the Board proceed with the pump and haul and consider removing the covenant requirement.

Based on the history of this project and the serious health and environmental issues, Supervisor Hyland moved that the Board:

- Authorize an Out-of-Turn Plan Amendment to change the language of the Comprehensive Plan to remove the Covenant restrictions requirement; and
- Direct staff to proceed with construction of the pump and haul system for the Gunston Heights and Wiley Subdivision.

This motion was seconded by Supervisor Kauffman.

Following a brief discussion, the question was called on the motion which <u>FAILED</u> by a recorded vote of five, Supervisor Frey, Supervisor Hyland, Supervisor Kauffman, and Chairman Hanley voting "AYE," Supervisor McConnell being out of the room.

128. **BOARD ADJOURNMENT** (Tape 19)

At 12:40 a.m. on Tuesday, November 18, 1997, the Board adjourned.
