14. A-2 - COMMONWEALTH GAS SERVICES APPLICATION FOR A GENERAL INCREASE IN NATURAL GAS RATES AND APPROVAL OF PERFORMANCE-BASED RATE REGULATION METHODOLOGY, STATE CORPORATION COMMISSION (SCC) CASE NUMBER PUE970455 (Tape 2)

Following discussion, with input from Stephen D. Sinclair, Utilities Analyst, Department of Consumer Affairs, Supervisor Bulova moved that the Board concur in the recommendation of staff and authorize the Department of Consumer Affairs and the Office of the County Attorney to file a Notice of Protest with the State Corporation Commission (SCC), Case Number PUE970455, regarding the application of Commonwealth Gas Services for a general increase in rates and approval of performance-based rate regulation methodology. This motion was seconded by Supervisor Connolly and carried by a vote of nine, Supervisor McConnell not yet having arrived.

15. A-3 - AUTHORIZATION FOR THE FAIRFAX COUNTY REDEVELOPMENT AND HOUSING AUTHORITY (FCRHA) TO FORM HERNDON HARBOR II LIMITED PARTNERSHIP FOR THE OWNERSHIP OF HERNDON HARBOR II (DRANESVILLE DISTRICT) (Tape 2)

On motion of Supervisor Mendelsohn, seconded by Supervisor Hyland, and carried by a vote of nine, Supervisor McConnell not yet having arrived, the Board concurred in the recommendation of staff and authorized the Fairfax County Redevelopment and Housing Authority (FCRHA) to proceed to form the Herndon Harbor II Limited Partnership to be composed initially of the FCRHA and the FCRHA Housing Assistance Corporation for the ownership of Herndon Harbor House II.

(NOTE: Later in the meeting, further action was taken regarding the Herndon Harbor II Limited Partnership. See Clerk's Summary Item CL#18.)

16. A-4 - AUTHORIZATION TO ENTER INTO A CONTRACT FOR CONVERSION OF VACANT OFFICE SPACE TO ORIGINAL RESIDENTIAL APARTMENTS AT STONEGATE VILLAGE APARTMENTS (HUNTER MILL DISTRICT) (Tape 2)

On motion of Supervisor Dix, seconded by Supervisor Hyland, and carried by a vote of nine, Supervisor McConnell not yet having arrived, the Board concurred in the recommendation of staff and authorized the Fairfax County Redevelopment and Housing Authority (FCRHA) to award a contract to D. D. and B. Construction in the amount of \$107,600 from the Fairfax County Housing Trust Fund for conversion of vacated office space to four residential units at Project 013880, Stonegate Village Apartments.

17. C-1 - AUTHORIZATION TO NEGOTIATE UNDER THE PRIVATE DEVELOPER ASSISTANCE PROGRAM FOR KINGSTOWNE LIMITED PARTNERSHIP (LEE DISTRICT) (Tape 2)

The Board next considered an item contained in the Memorandum to the Board dated November 24, 1997 regarding authorization to negotiate under the Private Developer Assistance Program at the request of Kingstowne Limited Partnership for certain land rights on properties identified as Tax Map Numbers 091-3-01-0091 and 091-3-01-0091-A, owned by LandAmerica Property Corporation, Incorporated.

Supervisor Kauffman moved that the Board authorize staff to negotiate, under the Private Developer Assistance Program, and at the request of Kingstowne Limited Partnership, for certain land rights on properties identified in the Memorandum to the Board dated November 24, 1997, and owned by LandAmerica Property Corporation, Incorporated. This motion was seconded by Supervisor Hyland.

Following discussion, the question was called on the motion which carried by a vote of nine, Supervisor McConnell not yet having arrived.

18. <u>C-2 - ISSUANCE AND SALE OF BONDS BY THE FAIRFAX COUNTY REDEVELOPMENT AND HOUSING AUTHORITY (FCRHA) FOR THE FINANCING OF THE DEVELOPMENT OF HERNDON HARBOR HOUSE II (DRANESVILLE DISTRICT)</u> (Tape 2)

The Board next considered an item contained in the Memorandum to the Board dated November 24, 1997 regarding the issuance of tax-exempt Multifamily Housing Revenue Bonds by the Fairfax County Redevelopment and Housing Authority (FCRHA) for the financing of the development of the Herndon Harbor House Phase II project.

Supervisor Mendelsohn moved adoption of the Resolution authorizing the FCRHA to issue tax-exempt bonds in an aggregate principal amount not to exceed \$4,750,000 for the financing of the development of Herndon Harbor House Phase II, a 60-unit multifamily residential rental community for the elderly and a related adult day health care facility. This motion was seconded by Supervisor Kauffman and carried by a vote of nine, Supervisor Bulova, Supervisor Connolly, Supervisor Dix, Supervisor Frey, Supervisor Gross, Supervisor Hyland, Supervisor Kauffman, Supervisor Mendelsohn, and Chairman Hanley voting "AYE," Supervisor McConnell not yet having arrived.

19. <u>I-1 - CONTRACT AWARD - ANNUAL CONTRACT FOR TRAIL</u> <u>MAINTENANCE AND REPAIR (COUNTYWIDE)</u> (Tape 2)

The Board next considered an item contained in the Memorandum to the Board dated November 24, 1997 requesting authorization for staff to award a contract in the amount of \$339,725 to C&F Construction Company for the annual contract for Trail Maintenance and Repair. Construction work will be performed as required on various existing and new trails administered by the Department of Public Works and funding will be provided by individual trail construction projects as required work is identified.

The staff was directed administratively to proceed as proposed.

20. <u>I-2 - PLANNING COMMISSION ACTION ON PUBLIC FACILITIES APPLICATION 456-Y97-11, THE FAIRFAX COUNTY WATER AUTHORITY (SULLY DISTRICT)</u> (Tape 2)

The Board next considered an item contained in the Memorandum to the Board dated November 24, 1997 presenting the Planning Commission action on Public Facilities Application 456-Y97-11, the Fairfax County Water Authority, approving the extension of approximately 1,920 feet of 30-inch water main along the south side of Lee Jackson Memorial Highway, between Fair Ridge Drive and Dorforth Drive, west of Fairfax.

21. <u>I-3 - PLANNING COMMISSION ACTION ON PUBLIC FACILITIES APPLICATION 456-Y97-15, CELLULAR ONE WASHINGTON/BALTIMORE (SULLY DISTRICT)</u> (Tape 2)

The Board next considered an item contained in the Memorandum to the Board dated November 24, 1997 presenting the Planning Commission action on Public Facilities Application 456-Y97-15, Cellular One Washington/Baltimore, approving an already existing telecommunications facility at 4641 West Ox Road, Fairfax.

22. <u>I-4 - REPORT ON GIRLS' FAST PITCH SOFTBALL</u> (Tape 2)

The Board next considered an item contained in the Memorandum to the Board dated November 24, 1997 presenting the report on girls' fast pitch softball and directing the County Executive to:

Work with the Fairfax County Public Schools, Park Authority, and the Department of Community and Recreation Services to examine

funding alternatives for lighting and irrigating the fields at Whittier School, along with a report on the negotiations of the fields at Whittier; and

Provide the Board with a report that answers and explains the questions and issues which were raised during the Public Comment session on August 4, 1997, as outlined in the Memorandum to the Board.

Following discussion, with input from Robert J. O'Neill, Jr., County Executive, Supervisor Kauffman asked unanimous consent that the Board direct staff to include the participation of the Commission for Women in the development of the action plan on girls' fast pitch softball. Without objection, it was so ordered.

Supervisor Dix asked unanimous consent that the Board direct staff to include the participation of the Athletic Council in this effort. Without objection, it was so ordered.

Supervisor Bulova suggested that the Board endorse the formation of an "action plan review team" to work with staff on the action plan and function as an oversight group to monitor this effort.

Following additional input from Mr. O'Neill; Anthony H. Griffin, Deputy County Executive for Planning and Development; and Wes Kendrick, Director, Department of Community and Recreation Services, Supervisor Connolly asked unanimous consent that the Board direct staff to report to the Board on the status of the negotiations with the City of Falls Church on the agreement to maintain the fields at Whittier School. Without objection, it was so ordered.

The staff was directed administratively to proceed as proposed.

ADDITIONAL BOARD MATTERS

23. **ACCESSIBILITY TO COUNTY WEB SITE** (Tape 2)

With a notation that Fairfax County continues to make important government information and services available through the County Web Site, Chairman Hanley cited the importance of making every effort to ensure that the site is accessible to all County residents, even those who have sight or hearing impairments. In fact, the Americans with Disability Act (ADA) requires that accessibility features, or "electronic curbcuts," be built into the design of all governmental web sites. The National League of Cities, in its publication *ADA Update*, suggests a number of steps local government can take to improve the accessibility of its sites.

Therefore, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and moved that the Board direct the Department of Information Technology (DIT) to:

- Review the contents of the County Web Site; and
- Take whatever steps necessary to ensure that every effort is being made to make the information provided as widely accessible as possible.

This motion was seconded by Supervisor Dix and carried by a vote of nine, Supervisor McConnell not yet having arrived.

24. **HEALTH INSURANCE FOR SMALL BUSINESS EMPLOYEES** (Tape 2)

Chairman Hanley stated that in the early 1990's, Fairfax County, the Economic Development Authority (EDA), and Inova Health System investigated the possibility of promoting insurance for small businesses and their employees. At the time, it was concluded that it was financially infeasible.

Chairman Hanley noted, however, that the Commonwealth of Virginia and Inova Health System are presently exploring a possible pilot project to determine if other approaches might work in achieving the important goal of making health insurance affordable to the County's small businesses.

Chairman Hanley moved that the Board direct the County Executive, with the advice of the Health Care Advisory Board (HCAB), to:

- Determine how the County might assist the State and Inova in developing a demonstration health insurance product for the employees of the County's small businesses; and
- Report on how the County might assist in this effort.

This motion was seconded by Supervisor Bulova.

Supervisor Mendelsohn asked to amend the motion to include the participation of the Fairfax County Chamber of Commerce in this effort, and this was accepted.

Following discussion, Supervisor Dix moved to amend the motion to add, following the words "assist the State and Inova" in bullet one above, "or other potential health care providers who might wish to participate...." This motion was seconded by Supervisor Mendelsohn and <u>CARRIED</u> by a recorded vote of seven, Supervisor Gross voting "NAY," Supervisor Frey being out of the room, Supervisor McConnell not yet having arrived.

The question was called on the main motion, as amended, which carried by a vote of eight, Supervisor Frey being out of the room, Supervisor McConnell not yet having arrived.

25. FAIRFAX COUNTY SIXTH ECONOMIC DEVELOPMENT CONFERENCE FOR SMALL, MINORITY, AND WOMEN-OWNED BUSINESS ENTERPRISES (Tape 2)

Chairman Hanley announced that the Fairfax County Sixth Economic Development Conference for Small, Minority, and Women-owned Business Enterprises was held November 19-20, 1997. In addition to the workshops and exhibitors, this year's conference featured an awards banquet to recognize excellence among small, minority and women-owned businesses and the community as follows:

Accordingly, Chairman Hanley moved that the Board direct staff to prepare letters of congratulations to the award recipients and commend the Department of Purchasing and Supply Management Agency (P&SMA), Department of Housing and Community Development (HCD), the Office for Women, and the Small and Minority Business Enterprise Program Advisory Commission in sponsoring the conference. This motion was seconded by Supervisor Connolly and carried by a vote of eight, Supervisor Frey being out of the room, Supervisor McConnell not yet having arrived.

26. <u>RECOGNITION OF TWO MEMBERS OF THE MEDICAL CARE FOR CHILDREN PARTNERSHIP ADVISORY COUNCIL</u> (Tape 2)

Chairman Hanley stated that the Office for Partnerships wishes to recognize two members of the Medical Care for Children Partnership (MCCP) Advisory Council, Renette Oklewicz of the Freddie Mac Foundation, Council Chair in 1997; and Jeffrey Carlton of Smith Barney, Council Chair for 1998. Both were instrumental in ensuring the success of the recent MCCP Masquerade and Awards Ball. The event raised enough funds to enroll nearly 500 additional children into the program.

Therefore, Chairman Hanley moved that the Board direct staff to invite the two outstanding individuals, Ms. Oklewicz and Mr. Carlton, to appear before the Board to be recognized for their contributions to the MCCP programs. This motion was seconded by Supervisor Connolly and carried by a vote of eight, Supervisor Frey being out of the room, Supervisor McConnell not yet having arrived.

27. <u>INCLUSION OF MULTI-PURPOSE TRAILS IN THE DESIGN AND CONSTRUCTION OF ROAD PROJECTS</u> (Tape 2)

Chairman Hanley noted that the Fairfax County Countywide Non-Motorized Transportation Committee has brought to her attention the fact that several road projects, including the I-95/I-395/I-495 interchange and the Route 28 and I-66 bridge widening, have failed to include the multi-purpose trails which were approved as part of the Comprehensive Plan. The Committee has also alerted the Chairman to the fact that bicycle and pedestrian access is rarely considered as part of the early design phase of road construction projects.

Based on the recommendations received from the Committee, Chairman Hanley moved that the Board direct staff to:

- Develop a County Policy to ensure that trails included in the Comprehensive Plan are included in the design and construction of road projects; and
- Submit this Policy to the Board for approval.

This motion was seconded by Supervisor Connolly.

Following discussion, Supervisor Kauffman asked to amend the motion to include the words "or acceptable substitutes" after Comprehensive Plan in the first bullet above, and this was accepted.

The question was called on the motion, as amended, which carried by a vote of eight, Supervisor Frey being out of the room, Supervisor McConnell not yet having arrived.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

28. <u>FLEXIBLE TRANSPORTATION FUNDING FOR PURCHASE OF REPLACEMENT METRO BUSES</u> (Tape 2)

Supervisor Dix moved that the Board respond to the letter from the Washington Metropolitan Area Transit Authority (WMATA) stating that the WMATA letter does, in fact, provide an answer to the concerns that the Board has expressed relative to its contributions of flexible transportation funding for the purchase of replacement Metro buses. This motion was seconded by Supervisor Bulova and carried by a vote of eight, Supervisor Frey being out of the room, Supervisor McConnell not yet having arrived.

29. INTENT TO DEFER PUBLIC HEARING ON REZONING APPLICATION

RZ 94-P-051 (J. A. LOVELESS HOMES, INCORPORATED) (Tape 2)

Supervisor Connolly announced his intent, at the appropriate time later in the meeting, to defer indefinitely the public hearing on Rezoning Application RZ 94-P-051.

Supervisor Connolly moved that the Board invite a representative of the Fairfax Area Disability Services Board to join the Transportation Advisory Commission (TAC). This motion was seconded by Supervisor Hyland and carried by a vote of eight, Supervisor Frey being out of the room, Supervisor McConnell not yet having arrived.

- 31. **RESOLUTION PERSONAL PROPERTY TAX ISSUE** (Tapes 2-3)
- (R) Supervisor Connolly called attention to the Board's adoption on September 22, 1997 of a Resolution of Fiscal Principles which he introduced. He moved adoption of a <u>revised</u> Resolution distributed this date to Board Members which reads:
 - **WHEREAS**, the personal property tax represents \$340 million in revenue, or 20 percent of Fairfax County's budget; and
 - **WHEREAS**, 51 percent of that revenue is dedicated to Fairfax County Public Schools;
 - **WHEREAS**, the General Assembly has failed in the past to keep fiscal commitments it has made to Fairfax County and other jurisdictions in the areas of public safety (HB599), education (Cost of Competing Teacher Salary Differential for Northern Virginia) and transportation (the 1989 promise on State recordation tax receipts); and
 - **WHEREAS**, the personal property tax is one of two ad valorem taxes available to local governments in Virginia upon which bond ratings are based; and
 - **WHEREAS,** Fairfax County is one of only a handful of counties in the United States to have achieved a AAA bond rating; and
 - **WHEREAS**, responsible fiscal policy requires that local government identify and secure a stable revenue base;

NOW, THEREFORE, BE IT RESOLVED THAT, the Fairfax County Board of Supervisors supports only those legislative proposals for elimination or reduction of the personal property tax that guarantee full revenue replacement (including future growth and inflation), or State assumption of service responsibilities, local or shared between the State and local government, equal in amount to the revenue proposed to be reduced or eliminated; and

BE IT FURTHER RESOLVED THAT, copies of this Resolution be provided to the Governor-elect and the members of the Northern Virginia legislative delegation.

This motion was seconded by Supervisor Hyland.

Following discussion, Supervisor Bulova asked to amend the motion to change the language in the second Whereas to read:

WHEREAS, 51 percent of all <u>General Fund</u> revenue is dedicated to Fairfax County Public Schools;

and this was accepted.

Supervisor Mendelsohn asked to amend the motion to change the language in the Now, therefore, be it resolved, to read:

NOW, THEREFORE BE IT RESOLVED THAT, the Fairfax County Board of Supervisors supports efforts to phase out or eliminate the personal property tax, provided that such legislative proposals for elimination or reduction of the personal property tax guarantee full revenue replacement (including future growth and inflation), or State assumption of service responsibilities, local or shared between the State and local government, equal in amount to the revenue proposed to be reduced or eliminated;

and this was accepted.

The question was called on the motion, as amended, which carried by a vote of nine, Supervisor Bulova, Supervisor Connolly, Supervisor Dix, Supervisor Frey, Supervisor Gross, Supervisor Hyland, Supervisor Kauffman, Supervisor Mendelsohn, and Chairman Hanley voting "AYE," Supervisor McConnell not yet having arrived.

Supervisor Frey asked unanimous consent that the Board direct staff to provide this year's numbers for the State-mandated Standards of Quality (SOQ) items for Fairfax County. Without objection, it was so ordered.

Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and asked unanimous consent that the Board direct staff to provide information on the State-mandated shares for resources other than the SOQs. Without objection, it was so ordered.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

Supervisor Dix asked unanimous consent that the Board direct staff to:

- Provide a clean, revised copy of the Resolution to Board Members; and
- Include this item in the position part of the Board's Legislative Program.

Without objection, it was so ordered.

(NOTE: Later in the meeting, a revised copy of the Resolution was provided to Board Members.)

Supervisor Dix called the Board's attention to discussions at the Virginia Municipal League (VML) and the Virginia Association of Counties (VACo) relative to suing the Commonwealth of Virginia should such a proposal to phase out or eliminate the personal property tax take place. Supervisor Dix emphasized a need to express to VML and VACo that Fairfax County would strongly urge that action of that nature not be pursued.

32. **JOINT REQUEST TO DESIGNATE SPECIAL STUDY AREA** (Tape 4)

Supervisor Hyland said that in the spring of this year, many citizens in the Mount Vernon and Lee Districts began working diligently with several County-commissioned consultants to formulate a Richmond Highway "vision." At the same time, the consultants were also preparing a market analysis to determine the development potential of the Richmond Highway Corridor. Ultimately, in combining both the "vision" and the market analysis, several Comprehensive Plan change recommendations were made by the study consultants. In addition, the Southeast Fairfax Development Corporation (SFDC) has submitted a number of Plan nominations as part of the 1997-1998 Area Plans Review (APR) process that would promote revitalization.

Accordingly, Supervisor Hyland and Supervisor Kauffman jointly moved that the Board:

Designate the Richmond Highway Corridor as a special study area for the purpose of considering changes to the Comprehensive Plan that would support community revitalization efforts. These changes may include, but are not limited to, planning objectives, land use and transportation recommendations and urban design guidelines; and

Direct that all Schedule "B" APR nominations submitted for the Richmond Highway Corridor Area be considered as part of the Special Study so that the Planning Commission and the Board can consider a comprehensive package of amendments for this area.

This motion was seconded by Supervisor Mendelsohn.

Following discussion, with input from James P. Zook, Director, Office of Comprehensive Planning (OCP), and Fred Selden, OCP, the question was called on the motion which carried by a vote of nine, Supervisor McConnell not yet having arrived.

33. **REQUEST FOR MULTI-WAY STOP SIGNS** (Tape 4)

Supervisor Hyland referred to his written Board Matters and noted that he has received requests regarding multi-way stop signs. Therefore, he asked unanimous consent that the Board refer the following requests to the Office of Transportation for prompt review and implementation:

- Multi-way stop signs at:
 - Radford Avenue and Jackson Place;
 - Bangor Drive and Jamaica Drive;
 - Bangor Drive and Fairhaven Avenue;
 - Bangor Drive and Fort Drive;
 - Rixey Drive and Fairhaven Avenue;
 - Croton Drive at Conover Place;
 - Waynewood Boulevard at Conover Place; and
 - Waynewood Boulevard at Dalebrook Drive.
- Three-way stop sign at:
 - Byrd Lane and Rixey Drive.

Without objection, it was so ordered.

Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and asked unanimous consent that the Board direct staff to develop a standardized method for bringing forward requests for multi-way stops. Without objection, it was so ordered.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

34. REQUEST FOR CERTIFICATE OF APPRECIATION FOR MARGO DANIELS, RESTON REGIONAL LIBRARY'S REGIONAL MANAGER (Tape 4)

Supervisor Dix announced that Margo Daniels, Reston Regional Library's Regional Manager, is retiring and her last day will be December 10, 1997. He moved that the Board direct staff to invite Ms. Daniels to appear before the Board on December 8, 1997 to receive a Certificate of Appreciation for her years of dedicated public service to the citizens of Hunter Mill District and Fairfax County. This motion was seconded by Supervisor Kauffman and carried by a vote of eight, Chairman Hanley being out of the room, Supervisor McConnell not yet having arrived.

35. REQUEST FOR CONCURRENT PROCESSING OF THE SITE PLAN WITH SPECIAL EXCEPTION APPLICATION SE 97-H-069 (Tape 4)

Supervisor Dix said that 1775 Wiehle, L.L.C. has filed Special Exception Application SE 97-H-069 requesting an increase in Floor Area Ratio (FAR) on a parcel in the I-5 District in Reston.

Therefore, Supervisor Dix moved that the Board authorize the Director of the Department of Environmental Management (DEM) to accept the Site Plan for concurrent processing with the Special Exception request. This motion does not relieve the applicant from complying with the provisions of any applicable conditions, regulations or adopted standards, and it does not prejudice the consideration of this application in any way. This motion was seconded by Supervisor Mendelsohn and carried by a vote of eight, Chairman Hanley being out of the room, Supervisor McConnell not yet having arrived.

36. MS. ELLA MILLER WILL BE CELEBRATING HER 117TH BIRTHDAY ON DECEMBER 5, 1997 (Tape 4)

Supervisor Dix announced that Ms. Ella Miller will be celebrating her 117th birthday at a celebration on December 5, 1997 at Sunrise Valley Elementary School in Reston. He asked unanimous consent that the Board direct staff to prepare a Certificate of Recognition for presentation at the December 5, 1997 birthday celebration expressing the Board's appreciation for her many outstanding accomplishments and her years of loving dedication to the citizens of her community. Without objection, it was so ordered.

37. <u>INFORMATION TECHNOLOGY POLICY ADVISORY COMMITTEE (ITPAC)</u> (Tape 4)

(BACs)

Supervisor Dix referred to the Information Technology Policy Advisory Committee (ITPAC) that the Board established and noted that Board also invited representatives from the community to participate. He expressed concern about a provision that indicates that business owners that do business in the County and potentially with the County are precluded from serving on the Committee.

Following discussion, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland asked unanimous consent that the Board refer this issue to the County Attorney for review and with a goal towards developing a disclosure provision. Without objection, it was so ordered.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

38. **WEAPONS FREE ZONES AROUND TEEN CENTERS** (Tape 4)

Supervisor Dix moved that the Board add a provision to its Legislative Package that seeks to create Weapons Free Zones in and around Teen Centers to the Legislative Committee. This motion was seconded by Supervisor Kauffman.

Following discussion, with input from David P. Bobzien, County Attorney; and Michael A. Long, Assistant County Attorney, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and asked to amend the motion to proceed with the proposed legislation should a situation arise where this item is not scheduled or if there is an adverse court decision.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

Following additional discussion, Supervisor Dix withdrew his motion and asked unanimous consent that the Board defer this issue until December 8, 1997. Without objection, it was so ordered.

Supervisor Mendelsohn asked unanimous consent that the Board direct the County Attorney to provide the motion that was made regarding the regulation. Without objection, it was so ordered.

For the record, Supervisor Dix stated that his approach and view on this issue has remained consistent.

39. **EXAMINATION OF DRIVING WHILE INTOXICATED (DWI) LAWS** (Tape 4)

Supervisor Dix referred to the issue of Driving While Intoxicated Laws (DWI) (repeat offenders) and asked unanimous consent that the Board authorize staff to:

Continue to work with the Oversight Committee on Drinking and Driving, Mothers Against Drunk Driving (MADD), and other

organizations that are seeking to reduce the carnage that is occurring; and

Review legislation that the Board can pursue in the upcoming General Assembly that would create and establish mandatory minimum sentencing and the classification of charges under which individuals are brought forward.

Without objection, it was so ordered.

Supervisor Connolly asked unanimous consent that the Board direct staff to review the penalties for driving with a suspended license. Without objection, it was so ordered.

40. <u>DEFERRAL OF AN APPEAL OF PUBLIC FACILITIES APPLICATION</u> 456-195-034 (Tape 4)

Supervisor Kauffman moved that the Board defer its consideration of an appeal of Public Facilities Application 456-L95-034 until February 9, 1998, at the request of the applicant. This motion was seconded by Supervisor Connolly and carried by a vote of nine, Supervisor McConnell not yet having arrived.

41. **NEW INTERN FOR SUPERVISOR KAUFFMAN** (Tape 4)

Supervisor Kauffman introduced to Board Members a new intern in his office, Andrew Painter, a senior from Hayfield High School.

42. TOLL BROTHERS/REZONING APPLICATION RZ 1997-SU-046 (Tape 4)

Supervisor Frey stated that Toll Brothers, Incorporated, has filed an application to rezone approximately 33 acres located on both sides of Avery Road off West Ox Road. The applicant previously received permission from the Board to include Avery Road right-of-way in their application, and the applicant intends to vacate it and develop a different road network if the rezoning application is approved. It has now come to the applicant's attention that a small portion (0.0912 acre) of West Ox Road right-of-way will also need to be included in the application and subsequently vacated.

Supervisor Frey moved that the Board concur in the inclusion of a 0.0912 acre portion of existing West Ox Road right-of-way in pending rezoning application RZ 1997-SU-046. This motion should not be construed as a favorable recommendation by the Board of Supervisors on the proposed rezoning application and does not relieve the applicant from compliance with the provisions of all applicable ordinances, regulations, or adopted standards. This motion was seconded by Supervisor Bulova and carried by a vote of eight, Supervisor Dix being out of the room, Supervisor McConnell not yet having arrived.

43. CONCURRENT PROCESS OF PLANS ASSOCIATED WITH PROFFERED CONDITION AMENDMENT APPLICATION PCA 88-S-065 (Tape 4)

Supervisor Frey stated that Proffered Condition Amendment Application PCA 88-S-065 has been filed for property located on tax map 44-2 ((1)) parcels 25, 26 and 27, to delete a proffered requirement to provide an oil and grit separator as the site's Best Management Practices (BMP) measure. Once the proffered requirement is eliminated, a more standard water quality method will be substituted.

Supervisor Frey said that because the mini-storage facility associated with this application is already under construction, the applicant is anxious to have this issue resolved in a timely manner. He moved that the Board direct staff to expedite the scheduling and allow concurrent processing of the plans associated with Proffered Condition Amendment Application PCA 88-S-065. This motion should not be construed as a favorable recommendation by the Board of Supervisors on the proposed application and does not relieve the applicant from compliance with the provisions of all applicable ordinances, regulations, or adopted standards. This motion, the second to which was inaudible, carried by a vote of eight, Supervisor Dix being out of the room, Supervisor McConnell not yet having arrived.

44. SCHEDULING OF APPLICATIONS FILED BY FAIRFAX NURSING CENTER, INCORPORATED (Tape 4)

Supervisor Frey stated that Fairfax Nursing Center, Incorporated, has filed applications for a nursing center in Sully District. The applicant is quite anxious to proceed with the proposal and has incurred delays in an effort to amend the applications to respond to staff comments. The Planning Commission hearing on this application is currently scheduled for January 7, 1998. At the request of the applicant, and with the concurrence of staff, Supervisor Frey moved that the Board direct staff to schedule a public hearing to be held before the Board on Rezoning Application RZ 1997-SU-027, Special Exception Applications SE 97-Y-035 and SE 97-Y-036 on January 26, 1998. This motion should not be construed as a favorable recommendation by the Board on the proposed applications and does not relieve the applicant from compliance with the provisions of all applicable ordinances, regulations, or adopted standards. This motion was seconded by Supervisor Bulova and carried by a vote of eight, Supervisor Dix being out of the room, Supervisor McConnell not yet having arrived.

45. <u>SIMULTANEOUS PROCESSING OF ALL PLANS ASSOCIATED WITH PROFFERED CONDITION /FINAL DEVELOPMENT PLAN AMENDMENT APPLICATIONS FDP 86-S-071 FILED IN THE NAME OF TRINITY CENTER (Tape 4)</u>

Supervisor Frey stated that KSI Services, Incorporated, has submitted a Proffered Condition Amendment and a Final Development Plan Amendment application to revise the proffers and approved Final Development Plan for Trinity Center to include a health club and revised hotel and office building locations. Trinity Center is slated to be Centreville's Town Center. At the request of the applicant, Supervisor Frey moved that the Board approve simultaneous processing of all plans associated with Proffered Condition Amendment Application/Final Development Plan Amendment Application PCA/FDPA 86-S-071 filed in the name of Trinity Center pending action on the applications. This motion should not be construed as a favorable recommendation by

the Board on the proposed applications and does not relieve the applicant from the requirement to make changes which might be approved or compliance with the provisions of all applicable ordinances, regulations, or adopted standards. This motion was seconded by Supervisor Bulova and carried by a vote of eight, Supervisor Dix being out of the room, Supervisor McConnell not yet having arrived.

46. **NEW BRANCH POST OFFICE** (Tape 4)

Supervisor Frey moved that the Board concur with the proposed name of the new Branch Post Office - Sully Station Branch Post Office. This motion was seconded by Supervisor Bulova and carried by a vote of eight, Supervisor Dix being out of the room, Supervisor McConnell not yet having arrived.

47. **DEER MANAGEMENT** (Tape 4)

Supervisor Frey referred to deer management issues and noted that there is an article in the *Fairfax Journal* regarding individuals and domestic pets being accidentally shot by deer hunters.

48. "TECHNOLOGY, EDUCATION AND EMPLOYMENT EXPO" (Tape 5)

(BACs)

Supervisor Gross reported that the Commission on Aging recently held their first "Technology, Education and Employment Expo" at the Doubletree Hotel. The Commission will provide a report to the Board in the spring on this successful endeavor. She congratulated the efforts of the Commission on Aging.

49. **BUS SHELTER AT LOEHMAN'S PLAZA** (Tape 5)

Supervisor Gross explained that there used to be a bus shelter at Loehman's Plaza in Mason District which is across the street from Providence District. She noted that it is scheduled for reconstruction in the spring. Because of the necessity of cover during the inclement winter weather for residents of both districts, Supervisor Gross moved that the Board direct staff to accelerate the schedule for the installation of that shelter. This motion was seconded by Supervisor Connolly and carried by a vote of eight, Supervisor Frey being out of the room, Supervisor McConnell not yet having arrived.

50. **HOLIDAY DISPLAY AT GREEN SPRING GARDENS PARK** (Tape 5)

Supervisor Gross announced that beginning Saturday, December 6, 1997 Green Spring Gardens Park in Mason District will celebrate the season with decorations with a theme of "A Gardeners' Holiday." Season decorations throughout the grounds will be highlighted by a Victorian Christmas at the park's historic Manor House. The decorations are the result of efforts by the Camelot, Waynewood, and Willow Brook Garden Clubs.

Supervisor Gross noted that the opening reception is on December 6 from 1:00-4:00 p.m., with refreshments at the Manor House and Horticulture Center. Decorations will remain through the end of December. She invited the Board and all County residents to visit this display.

51. NO BOARD MATTERS FOR BRADDOCK DISTRICT SUPERVISOR SHARON BULOVA (Tape 5)

Supervisor Bulova announced that she had no Board Matters to present today. She did note that as the result of a bet with Supervisor Frey, he will be treating her to lunch in the cafeteria today.

52. **PUMP AND HAUL ISSUE** (Tape 5)

Supervisor Mendelsohn asked unanimous consent that the Board revisit the pump and haul issue during Executive Session today. Without objection, it was so ordered.

(NOTE: Later in the meeting, action was taken by the Board on this item. See Clerk's Summary Item CL#61.)

53. SUPERVISOR DIX TO PRESENT BOARD MATTERS FOR SPRINGFIELD DISTRICT SUPERVISOR ELAINE MCCONNELL (Tape 5)

Supervisor Dix announced that he would present Supervisor McConnell's Board Matters in her absence. Chairman Hanley provided the history of another instance when Supervisor Dix had presented Supervisor McConnell's Board Matters during a very late night Board meeting, and is referred to as "The Guiding Light" Board Matters.

54. RECOGNITION OF YOUNG HO CHANG, ACTING DISTRICT ADMINISTRATOR, VIRGINIA DEPARTMENT OF TRANSPORTATION (VDOT) (Tape 5)

On behalf of Supervisor McConnell, Supervisor Dix noted that Young Ho Chang, Acting District Administrator, Virginia Department of Transportation (VDOT), will be leaving VDOT for the private sector at the end of the month. Noting his accomplishments on behalf of the County, Supervisor Dix asked unanimous consent that the Board direct staff to invite Mr. Chang to appear before the Board on December 8, 1997 to be recognized for his excellent service to the residents of the County. Without objection, it was so ordered.

55. STATUS OF HOMES PURCHASED BY THE STATE FOR THE WIDENING OF ROUTE 123 (Tape 5)

Supervisor Dix stated that Supervisor McConnell had been contacted by several constituents and homeowner associations located on Route 123 who expressed concern about the homes that are being purchased by the State for the widening of that road. He noted that only those homes that fell into the category of hardship cases were considered for advanced land acquisition on this project. Some of the now vacant homes have not been maintained and are becoming eyesores. Supervisor McConnell had faced a similar situation during the construction of the Fairfax County Parkway when homes were not maintained and demolition was delayed. She does not want a repeat of that situation with the widening of Route 123 and indicated that these homes need to be either leased or demolished as soon as possible.

Accordingly, on behalf of Supervisor McConnell, Supervisor Dix moved that the Board direct staff to identify those homes that have been acquired as part of the Route 123 widening project and to work with the Virginia Department of Transportation (VDOT) to develop a solution to this problem. This motion was seconded by Chairman Hanley and carried by a vote of nine, Supervisor McConnell not yet having arrived.

56. <u>USE OF WILD ANIMAL HIGHWAY REFLECTOR SYSTEM AS A WARNING</u> <u>TO DEER</u> (Tape 5)

Supervisor Dix reported that Supervisor McConnell had recently been contacted by John Strieter, President of the Strieter Corporation located in Rock Island, Illinois. His company manufactures the Strieter-Lite Wild Animal Highway Reflector System which is used to warn animals against crossing the road at night when vehicles are present. Supervisor Dix noted that Supervisor McConnell understands that Montgomery County is currently testing the system in their large deer population areas. She believes that this system could serve as a viable alternative in making the roads safer in particular sections of Fairfax County where deer accidents have become common.

Accordingly, on behalf of Supervisor McConnell, Supervisor Dix moved that the Board direct staff to:

- Identify the pros and cons of the Strieter Reflector System, and other similar systems, to be included in the December 8, 1997 report to the Board on deer management; and
- Provide any information regarding Montgomery County's pilot program.

This motion was jointly seconded by Supervisor Bulova and Supervisor Frey.

Supervisor Mendelsohn asked to amend the motion to direct staff to provide the number of miles and, therefore, the cost of implementing this type of system in the County, and this was accepted.

The question was called on the motion, as amended, which carried by a vote of nine, Supervisor McConnell not yet having arrived.

57. **RECESS/EXECUTIVE SESSION** (Tape 5)

At 12:35 p.m., Supervisor Connolly moved that the Board recess and go into Executive Session for discussion and consideration of matters enumerated in *Virginia Code* Section 2.1-344 and listed in the agenda for this meeting and in addition:

- Status of Erroneous Tax Assessment Litigation;
- Letter Agreement between Fairfax County and the Upper Occoquan Sewage Authority (UOSA);
- Conversion of Contract Employees to Merit Regular Status;
- Howard S. Schwartz versus the Board of Supervisors of Fairfax County, Virginia, et al., In Chancery Number 143876; and
- Tracey Finnell, et al., versus Robert J. O'Neill, In Chancery Number 151722.

This motion was seconded by Supervisor Gross and carried by a vote of nine, Supervisor McConnell not yet having arrived.

Chairman Hanley announced that the Executive Session will be convened at 1:45 p.m.

58. **ORDERS OF THE DAY** (Tape 6)

Chairman Hanley announced that there would be a change in the Orders of the Day to proceed with Appointments and then continue with the scheduled agenda.

ACTIONS FROM EXECUTIVE SESSION

59. <u>CERTIFICATION BY BOARD MEMBERS REGARDING ITEMS DISCUSSED</u> <u>IN EXECUTIVE SESSION</u> (Tape 6)

Supervisor Bulova moved that the Board certify that, to the best of its knowledge, only public business matters lawfully exempted from the open meeting requirements prescribed by the Virginia Freedom of Information Act and only matters identified in the motion to convene Executive Session were heard, discussed, or considered by the Board during the Executive Session. This motion was seconded by Supervisor Connolly and carried by unanimous vote, Supervisor Bulova, Supervisor Connolly, Supervisor Dix, Supervisor Frey, Supervisor Gross, Supervisor Hyland, Supervisor Kauffman, Supervisor McConnell, Supervisor Mendelsohn, and Chairman Hanley voting "AYE."

60. AGREEMENT BETWEEN FAIRFAX COUNTY BOARD OF SUPERVISORS AND THE UPPER OCCOQUAN SEWAGE AUTHORITY (UOSA) (Tape 6)

Supervisor Frey moved that the Board support the terms of the letter agreement between the Fairfax County Board of Supervisors and the Upper Occoquan Sewage Authority (UOSA) regarding the health hazard which exists within a portion of the Lehigh Village Subdivision according to the terms and conditions as outlined by the County Attorney in Executive Session. This motion was seconded by Supervisor McConnell and CARRIED by a recorded vote of eight, Supervisor Bulova and Supervisor Connolly voting "NAY."
