Following discussion, with input from Nancy Vehrs, Clerk to the Board, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and asked unanimous consent that the Board direct staff to review the appointments to the History Commission to ensure that the Representatives are accurately designated to the appropriate categories. Without objection, it was so ordered.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

Following additional discussion, Supervisor Gross moved deferral of this item. The motion, the second to which was inaudible, carried by a vote of nine, Supervisor Frey being absent.

## 20. A-3 – APPROVAL OF ADDITIONAL SECURITY FOR THE SECTION 108 LOAN FOR NEIGHBORHOOD IMPROVEMENTS IN CONSERVATION AREAS (LEE, MOUNT VERNON, MASON, AND PROVIDENCE DISTRICT) (Tape 4)

Supervisor Hyland moved that the Board concur in the recommendation of staff and approve additional security for the \$9.3 million in loan funds guaranteed under Section 108 of the Housing and Community Development Act of 1974, as amended, for neighborhood improvements in the Bailey's, Fairhaven, Gum Springs, James Lee, and Jefferson Manor Conservation Areas. This motion was seconded by Supervisor Connolly.

Following discussion, with input from Robert J. O'Neill, Jr., County Executive; Verdia L. Haywood, Deputy County Executive; and Bruce A. LaVal, Director, Community Development Division, Department of Housing and Community Development (HCD), Supervisor Mendelsohn moved deferral of this item until November 16, 1998. This motion was seconded by Supervisor Dix.

Supervisor Hyland asked unanimous consent that the Board direct staff to ask the United States (US) Department of Housing and Urban Development (HUD) whether there are other alternatives to provide additional security for the \$9.3 million in loan funds guaranteed under Section 108. Without objection, it was so ordered.

Supervisor Kauffman asked unanimous consent that the Board direct staff to provide information as to the level of risk of the Block Grant Program ceasing to exist. Without objection, it was so ordered.

The question was called on the motion to defer this item, which carried by a vote of nine, Supervisor Frey being absent.

The Board next considered an item contained in the Memorandum to the Board dated October 19, 1998 presenting the status of the Photo Red Light Monitoring System.

Following discussion, with input from Bruce Taylor, Department of Transportation, Supervisor Gross asked unanimous consent that the Board refer to the Legislative Committee the issue of being unable to issue tickets to vehicles which are leased. Without objection, it was so ordered.

Supervisor Dix asked unanimous consent that the Board direct staff to provide the date that the Policy on red light monitoring was approved. Without objection, it was so ordered.

### 24. I-3 - CONTRACT AWARD - HILLSIDE ROAD TRAIL, PHASE I AND II (SPRINGFIELD DISTRICT) (Tape 4)

The Board next considered an item contained in the Memorandum to the Board dated October 19, 1998 requesting authorization for staff to award a contract to Alter B. Stanley and Sons Incorporated in the amount of \$217,344.00 for the construction of Project 002062, Hillside Road Trail, Phase I and II, in Fund 307, Sidewalk Construction.

The staff was directed administratively to proceed as proposed.

#### 25. I-4 – SAFE TRAIL INITIATIVE (Tape 4)

The Board next considered an item contained in the Memorandum to the Board dated October 19, 1998 requesting authorization for staff to initiate the "Park and Trail Watch" program and continue to extend the Neighborhood Watch partnerships into new areas.

Following discussion, Lieutenant Colonel J. Thomas Manger, Acting Chief of Police, announced that the kick off for the "Park and Trail Watch" will be held on October 26, 1998 at 7:00 p.m. in the Government Center Board Auditorium.

The staff was directed administratively to proceed as proposed.

### ADDITIONAL BOARD MATTERS

### 26. PROCLAMATION DESIGNATING THE WEEK OF NOVEMBER 16-20, 1998 AS "SUBSTANCE ABUSE AWARENESS WEEK" IN FAIRFAX COUNTY (Tape 5)

Chairman Hanley stated that the Alcohol and Drug Services, an agency of the Fairfax-Falls Church Community Services (CSB), has requested that the week of November 16-22, 1998 be proclaimed as Substance Abuse Awareness Week.

Therefore, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and moved that the Board direct staff to:

- Prepare a Proclamation designating the week of November 16-22, 1998 as "Substance Abuse Awareness Week" in Fairfax County; and
- Invite representatives of the CSB to appear before the Board to receive this Proclamation.

This motion was seconded by Supervisor Dix and carried by a vote of nine, Supervisor Frey being absent.

### 27. WASHINGTON REGIONAL PEDESTRIAN PLANNING AND DESIGN WORKSHOP (Tape 5)

Chairman Hanley stated that the planners and engineers across the County are turning their attention to pedestrian access as a means to reduce auto trips, improve access to transit, and revitalize neighborhoods. Pedestrian safety has also surfaced as an important national and regional concern. The National Capital Region Transportation Planning Board will host a workshop on pedestrian issues on Thursday, November 12, 1998 at the Washington Metropolitan Council of Government's (COG) first floor training room at 777 North Capitol Street. NE. The cost is \$20 and includes materials and lunch.

Chairman Hanley asked unanimous consent that the Board direct staff to place a notice in the *Courier* and *The Weekly Agenda* as well as any other way the County has of publicizing the workshop so that those who are interested may attend. Without objection, it was so ordered.

## 28. REQUEST TO THE VIRGINIA DEPARTMENT OF TRANSPORTATION (VDOT) TO EXPAND THE SCOPE OF PUBLIC INFORMATION ON THE CAPITAL BELWAY MAJOR INVESTMENT STUDY (MIS) (Tape 5)

Chairman Hanley said that in the last several months, citizen interest in the proposed expansion of the Capital Beltway has increased. This subject has been discussed in citizen association and district council programs around the County which have included members of the Virginia Department of Transportation's (VDOT) staff and elected officials.

Chairman Hanley further stated that an area of concern is the citizen dissatisfaction with VDOT's public information format which permits information about a proposed construction and design project to be displayed, but during which there is no formal presentation or opportunity for citizens to comment.

Chairman Hanley said that VDOT has tentatively scheduled a series of three public information meetings for mid-November on the completed Capital Beltway Major Investment Study (MIS). While the MIS process on the Capital Beltway is finished, citizen organizations are concerned that there has not been adequate opportunity to comment during this process.

Therefore, Chairman Hanley moved that the Board:

- Write a letter to Secretary of Transportation, Shirley Ybarra requesting that VDOT hold an expanded public information meeting on the Capital Beltway MIS following the November meetings which would include:
- A formal presentation of their Plans:
- An opportunity for citizens to present their comments as questions and submit written concerns; and

• A request that announcement of all public information meetings be well publicized in the local media.

This motion was seconded by Supervisor Kauffman and carried by a vote of nine, Supervisor Frey being absent.

### 29. FAIRFAX JOINT LOCAL EMERGENCY PLANNING COMMITTEE (FJLEPC) (Tape 5)

Chairman Hanley stated that she had received a letter from the Fairfax Joint Local Emergency Planning Committee (FJLEPC) requesting certificates of recognition be prepared for their December meeting to be given to members who have served 10 or more years on the Committee.

Therefore, Chairman Hanley moved that the Board direct staff prepare the appropriate certificates. This motion was seconded by Supervisor Connolly and carried by a vote of nine, Supervisor Frey being absent.

#### 30. LETTER FROM NATIONAL ENVIRONMENTAL TRUST (Tape 5)

Chairman Hanley circulated a letter she had received from the National Environmental Trust and asked unanimous consent that this letter be referred to the Legislative Committee. Without objection, it was so ordered.

### 31. VIRGINIA DEPARTMENT OF SOCIAL SERVICES COMPUTER ACCESS RESTRICTION (Tape 5)

Chairman Hanley referred to a memorandum regarding the Virginia Department of Social Services computer access restriction. Chairman Hanley stated that the restriction is the result of the State's mainframe capacity shortfall which will only allow 67 Countywide users at any one time during regular work hours, and affects a number of computer applications including the new Application Benefit Delivery Automation Project (ADAPT) and the Virginia Automated Client Information System (VACIS).

Chairman Hanley asked unanimous consent that the Board direct staff to monitor this situation for approximately four weeks and advise the Board as to what is happening to the Fairfax County access in terms of inability to access the system and overtime costs associated with system use after regular working hours. Without objection, it was so ordered.

Supervisor Connolly asked unanimous consent that the Board direct staff to determine if there is any legislative remedy and if so, that those recommendations be referred to the Legislative Committee. Without objection, it was so ordered.

#### 32. "GUN TURN-IN DAY" IN FAIRFAX COUNTY (Tape 5)

Chairman Hanley announced that the Turn-off-the-Violence Coalition, the Fairfax County Police Department, the Fairfax County Office of the Sheriff and the Virginia State Police is sponsoring a "Gun Turn in Day" in Fairfax County.

Chairman Hanley further stated that citizens wishing to turn in firearms and/or ammunition can do so from 8:00 a.m. to 4:00 p.m., Saturday, October 24, 1998 at one of the following locations:

- The Fairfax Police Department, Mount Vernon or Mason District Stations; and
- Virginia State Police, 7th Division Headquarters, 9801 Braddock Road, Fairfax, Virginia.

Supervisor Connolly asked unanimous consent that the Board direct the Police Department to provide a report of the success of this campaign. Without objection, it was so ordered.

#### 33. **DEER MANAGEMENT** (Tape 5)

(NOTE: Earlier in the meeting, the Board deferred action on the issue of deer management. See Clerk's Summary Item CL#21.)

Chairman Hanley referred to an article in the *New York Times* regarding deer management and noted that one individual discovered that a deterrent for deer feeding on his Eagle Bay Hosta Gardens is playing upscale country music.

### 34. ENVIRONMENTAL QUALITY ADVISORY COUNCIL (EQAC) PUBLIC HEARING (Tape 5)

Chairman Hanley announced that the Environmental Quality Advisory Council (EQAC) will hold a public hearing on November 11, 1998 at 7:30 p.m. in Conference Center Rooms 2 and 3 of the Government Center.

#### 35. CELLULAR TOWER ZONING BILL (Tape 5)

Chairman Hanley stated that the Cellular Tower Zoning Bill is dead and the Board will not need to write a letter for now.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

#### 36. SCHOOL CROSSING GUARDS (Tape 5)

Supervisor Mendelsohn referred to a Board Matter he presented on September 14, 1998 regarding the shortage of school crossing guards.

Following discussion with input from Robert J. O'Neill, Jr., County Executive, Supervisor Mendelsohn asked unanimous consent that the Board direct staff to provide an update on this problem. Without objection, it was so ordered.

### 37. BOARD POSITION REGARDING STATE CONSTITUTIONAL AMENDMENTS THREE AND FOUR (Tape 5)

Supervisor Mendelsohn referred to a Board Matter he presented on October 12, 1998 regarding State Constitutional amendments three and four.

Supervisor Mendelsohn moved that the Board take a position in opposition to State Constitutional amendments three and four. This motion was seconded by Supervisor Dix and carried by a vote of nine, Supervisor Frey being absent.

#### 38. **MIDDLETON FARM/SPOT IMPROVEMENTS** (Tape 6)

Supervisor Dix referred to the recent rezoning of the Middleton Farm and asked unanimous consent that the Board direct staff to provide an update regarding the examination and pursuit of spot improvements at the intersection of West Ox Road and Monroe Street. Without objection, it was so ordered.

Supervisor Dix asked unanimous consent that the Board direct staff to provide an update regarding the Board's action to direct staff to prepare a letter to the Virginia Department of Transportation (VDOT) regarding the funding in the Six Year Plan for Centreville Road and West Ox Road Improvements. Without objection, it was so ordered.

#### 39. GOVERNMENT CENTER BASEBALL FIELD RESTROOMS (Tape 6)

Supervisor Dix asked unanimous consent that the Board direct staff to respond to the issue of alternatives to address the need for restrooms at the Government Center Baseball Field.

Following input from Robert J. O'Neill, Jr., County Executive, without objection, it was so ordered.

#### 40. **MAPSCAPE PROJECT** (Tape 6)

Supervisor Dix said that the Reston Environmental Educational Foundation is interested in proceeding with a mapscape project of the Chesapeake Bay Watershed.

Supervisor Dix asked unanimous consent that the Board direct staff to identify grant opportunities that might be utilized to support this project. Without objection, it was so ordered.

#### 41. **RESTON ASSOCIATION REQUEST** (Tape 6)

Supervisor Dix said that Dawn Biggs, Watershed Manager for the Reston Association, has planned a stream stabilization project within the Resource Protection Area of Snakeden Branch. The project is located in Reston located off Soapstone Drive within Association owned natural area. An unnamed tributary, over five feet deep at its

mouth and with no vegetation on its mouth and with no vegetation on its banks, is highly erosive and adding untold quantities of sediment to downstream facilities.

Supervisor Dix said that the plan calls for creating a new centerline for the tributary and replacing the sinuosity to eliminate the erosive scour that now exists. In addition, the plan will create three shallow pool areas to serve as storm water retention areas and aid in ground water recharge. These areas will replace floodplain wetlands that were lost. The existing and proposed vegetation will trap sediment, nutrients, and other pollutants, effectively creating a retrofit Best Management Practice (BMP). No additional fill is associated with the project.

Supervisor Dix explained that the purpose of the project is to eliminate sediment loss from the existing system to improve greatly the condition of the natural environment and the water quality on downstream systems. The entire length of the project is 275 feet.

Supervisor Dix moved that the Board direct staff to:

- Waive the fee for the Rough Grading Plan and any other project associated fees; and
- Consider whether the submission of a Water Quality Impact Assessment can be waived.

This motion was seconded by Chairman Hanley.

Following discussion, with input from David P. Bobzien, County Attorney, the question was called on the motion which carried by a vote of nine, Supervisor Frey being absent.

#### 42. **DESIGNATION OF FIELDS AND UTILIZATION** (Tape 6)

Supervisor Dix said that he received a copy of a letter to Alta Newman, Chair, Commission for Women, from the Park Authority regarding the report of the Commission for Women.

Supervisor Dix asked unanimous consent that the Board direct staff to prepare a response to the issue that clears up any confusion as to how fields are designated and how they get utilized. Without objection, it was so ordered.

Supervisor Gross said that Ms. Marian "Mixie" Houk has retired as the Executive Director, Children's Day Care Center at ACCA. She asked unanimous consent that the Board direct staff to invite Ms. Houk to appear before the Board before the end of the year to honor her. Without objection, it was so ordered.
