The meeting was called to order at 9:35 a.m., with all Members being present, with the exceptions of Supervisor Bulova and Supervisor McConnell, and with Chairman Hanley presiding.

35. INTENT TO DEFER THE PUBLIC HEARING ON SPECIAL EXCEPTION AMENDMENT APPLICATION SEA 84-D-100-2 (Tape 6)

Supervisor Mendelsohn announced his intent, later in the meeting, to defer the public hearing on Special Exception Amendment Application SEA 84-D-100-2 until June 5, 2000, at 3 p.m.

(NOTE: Later in the meeting the public hearing was formally deferred. See Clerk's Summary Item CL#81.)

36. <u>CONCURRENT PROCESSING FOR SPECIAL EXCEPTION</u> <u>APPLICATION SE 00-D-019</u> (Tape 6)

Supervisor Mendelsohn said that the Holladay Corporation is the applicant for Special Exception Application SE 00-D-019 to build a cluster development of ten

single family dwellings on property along Lewinsville Road in McLean. The property to be developed is located at Tax Map number 29-1((1))51 and 51A. He noted that the applicant continues to work diligently with the McLean community on this project to increase tree save and to connect a significant number of trails in the Lewinsville Road corridor. The applicant has spent valuable time on these issues with the community and would benefit from concurrent processing of its plans to move this project forward as soon as possible.

Therefore, Supervisor Mendelsohn moved that the Board direct staff of the Department of Public Works and Environmental Services and the Department of Planning and Zoning to proceed with concurrent processing of this application. This motion does not relieve the applicant from compliance with the provisions of any and all applicable ordinances, regulations, or adopted standards and does not constitute support by the Board for the special exception application in any way. Chairman Hanley seconded the motion and it carried by a vote of eight, Supervisor McConnell being out of the room, Supervisor Bulova being absent.

37. **DISPOSAL OF HOUSEHOLD HAZARDOUS WASTE** (Tape 6)

Supervisor Mendelsohn pointed out that prior to the economic downturn of the early 1990s, Fairfax County offered citizens the opportunity to periodically bring hazardous wastes such as paints, solvents, and pesticides to designated locations in each supervisor district. This program supplemented the ongoing Hazardous Waste Program operated by the Solid Waste Disposal and Recovery Resource Division of the Department of Public Works and Environmental Services.

As a result, there are currently only two locations where citizens may dispose of such items. These locations are the I-66 Transfer Station on West Ox Road and the I-95 Sanitary Landfill in Lorton. Both facilities are open for the disposal of residential hazardous waste for half days on Thursdays and Fridays and from 9 a.m. until 4 p.m. on Saturdays.

Supervisor Mendelsohn pointed out that with a land area of 399 square miles, it is advisable from an environmental standpoint for Fairfax County to offer its citizens the opportunity to dispose of hazardous waste at locations closer to their homes. Many citizens will not take the time to make the trip to the two existing collection points to dispose of a few paint cans or leftover solvents from a household project. Often these items collect in garages and basements and finally end up in the weekly trash pickup or are poured down the drain or emptied into backyards. He suggested an annual collection day (in each supervisor district) would be beneficial.

Therefore, Supervisor Mendelsohn moved that the Board direct staff to provide:

• Detailed cost estimates for such an annual collection of hazardous waste and to recommend specific procedures for implementation and evaluation of such a program.

• This information to the Board prior to the summer recess and that this pilot program be added as a consideration item as part of the Carryover Review.

Supervisor Hyland seconded the motion.

Following discussion, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and asked to amend the motion to give staff flexibility regarding the annual pick-up day in each supervisor district, and this was accepted.

Vice-Chairman Hyland returned the gavel to Chairman Hanley. Supervisor Frey asked to amend the motion to direct staff to include utilization rates when the stations were previously open, and this was accepted.

The question was called on the motion, as amended, which carried by a vote of eight, Supervisor McConnell being out of the room, Supervisor Bulova being absent.

(APPTS) Supervisor Mendelsohn moved that the Board confirm the following appointments to the Governing Board of the McLean Community Center:

Supervisor Connolly seconded the motion and it carried by a vote of eight, Supervisor McConnell being out of the room, Supervisor Bulova being absent.

39. **HERNDON FESTIVAL** (Tape 6)

Supervisor Mendelsohn announced that the twentieth anniversary of the Herndon Festival will be held on Thursday - Sunday, June 1-4, 2000. He added that there will be a business expo, craft vendors, food vendors, amusement rides, three stages of entertainment and a free hands-on children's art area.

Supervisor Mendelsohn invited all to attend.

40. **MOUNT OLIVE BAPTIST CHURCH** (Tape 6)

Supervisor Frey said that the Mount Olive Baptist Church has filed a rezoning and special exception applications to rezone and add land area and to subject the entire church site to a special exception. The application proposes to increase the size of the church sanctuary, build an educational wing to be used for Sunday School classes and a weekday pre-school, to add administrative space, and to allow temporary trailers to be utilized during construction. A portion of the property will be available for recreational uses associated with the church and/or the community until such time as the land may be needed for additional structures or parking. The applications are scheduled to be heard by the Planning Commission on June 14, 2000. The applicant has requested that the Board authorize concurrent processing of the site plans.

Therefore, Supervisor Frey moved that the Board direct staff to process the subdivision and site plans concurrently with the consideration of Rezoning Application RZ 00-Y-001 and Special Exception Application SE 00-Y-004. The applicants understand that this motion will not prejudice the consideration of the applications in any way. Chairman Hanley seconded the motion and it carried by a vote of eight, Supervisor McConnell being out of the room, Supervisor Bulova being absent.

41. CHANTILLY HIGH SCHOOL'S AMANDA KOPPEL WINS TOP AWARD AT THE 2000 INTEL SCIENCE AND ENGINEERING FAIR (Tape 6)

Supervisor Frey announced that Chantilly High School's Amanda Koppel won top award at the 2000 Intel Science and Engineering Fair, an international science fair.

Supervisor Frey asked unanimous consent that the Board direct staff to invite Ms. Koppel to appear before the Board to be recognized for the outstanding achievement that she has accomplished. Without objection, it was so ordered.

42. **<u>NOTTOWAY NIGHTS CONCERT SERIES</u>** (Tape 6)

Supervisor Connolly announced that the Nottoway Nights concert series will begin June 1, 2000, at Providence District's Nottoway Park. The concerts, which will take place every Thursday evening from June 1 through August 31, 2000, will be free to the public and showcase an array of local and regional talent. The variety and quality of the acts is a reflection of Fairfax County's diversity and community spirit.

Supervisor Connolly invited the Board and the public to join him for opening night on June 1, 2000, and throughout the summer for this community celebration of the arts.

(NOTE: Later in the meeting this issue was discussed again. See Clerk's Summary Item CL#49.)

43. EXPEDITED AND CONCURRENT PROCESSING FOR WEST*GROUP MANAGEMENT LLC - PROFFERED CONDITION AMENDMENT APPLICATION PCA 92-P-001-2 AND SPECIAL EXCEPTION AMENDMENT APPLICATION SEA 98-P-051 (Tape 6)

(A) Supervisor Connolly said that West*Group Properties, LLC is the owner of a 42-acre parcel of land known as the Old Springhouse Road Land Bay. Capital One Financial Corporation will be acquiring 28 acres of the land bay to develop approximately 1.1 million square feet of office. The site will allow Capital One to consolidate its Northern Virginia offices into Tysons Corner. West*Group has already dedicated land in the Old Springhouse Road Land Bay for use as a future Metro station. Upon extension of rail through Tysons Corner, the subject site's location will provide employees of Capital One with an easily accessible Metro station.

Supervisor Connolly said that Capital One is on a strict development schedule that will require closing in the year 2000 with the land use cases complete by the end of October 2000.

Therefore, Supervisor Connolly moved that the Board direct staff to:

- Schedule a public hearing to be held before the Board on <u>October 16, 2000, at 3:30 p.m.</u> on Proffered Condition Amendment Application PCA 92-P-001-2 and Special Exception Amendment Application SEA 98-P-051.
- Concurrently process the site plans, plats, building permits, and any other plans associated with Proffered Condition Amendment Application PCA 92-P-001-2 and Special Exception Amendment Application SEA 98-P-051.

This action does not prejudice the consideration of this review in any way. Supervisor Gross seconded the motion and it carried by a vote of eight, Supervisor McConnell being out of the room, Supervisor Bulova being absent.

44. <u>NATIONAL CAPITAL CHAPTER OF THE AMERICAN RED CROSS</u> <u>CELEBRATES NINETY-FIFTH ANNIVERSARY</u> (Tape 6)

Supervisor Connolly said that in 1989 the American Red Cross chapter serving Fairfax County was closed. Since February of 1989 the National Capital Chapter located in the District of Columbia (DC), has served Fairfax. On the May 15,

2000, the National Capital Chapter celebrated 95 years of service to the people of DC.

Therefore, Supervisor Connolly moved that the Board direct staff to invite representatives of the National Capital Chapter of the American Red Cross to appear before the Board to receive a certificate of appreciation marking its ninetyfifth anniversary. Chairman Hanley seconded the motion and it carried by a vote of eight, Supervisor McConnell being out of the room, Supervisor Bulova being absent.

45. **<u>TYSONS TELECOM CENTER LP</u>** (Tape 6)

Supervisor Connolly said that Tysons Telecom Center LP recently submitted a special exception application to permit a telecommunications center on property zoned I-5 located on Spring Hill Road in Tysons Corner. This facility will provide voice, image, and data Internet connectivity for Tysons with little traffic impact. The Planning Commission's public hearing is scheduled for September 21, 2000. The applicant requests concurrent processing of the site plan so construction can begin this calendar year.

Supervisor Connolly moved that the Board direct staff to concurrently process the site plans for Special Exception Application SE 00-P-020. This action does not prejudice the consideration of this review in any way. Chairman Hanley seconded the motion and it carried by a vote of eight, Supervisor McConnell being out of the room, Supervisor Bulova being absent.

46. <u>CONSIDERATION ITEM AT CARRYOVER - SACRAMENTO</u> <u>NEIGHBORHOOD CENTER</u> (Tape 6)

Supervisor Kauffman said that as a part of the Board's recent budget action, it approved funds for land acquisition and the planning of what will ultimately be the permanent Sacramento Neighborhood Center. Until such time as this permanent home is realized, County staff will soon be opening the door on a storefront operation in the Sacramento Shopping Center at the intersection of Route One and Sacramento Drive.

Supervisor Kauffman said that the Center will have a special focus on neighborhood youth. Supervisor Kauffman pointed out that to get full value out of this effort, there is a need for funding of two positions (one full time and the other part time) to ensure proper coordination and use of the center by the community, local police, and Fairfax County Human Services personnel.

Therefore, Supervisor Kauffman moved that the Board direct staff to include as a Consideration Item at Carryover an amount not to exceed \$60,000. This funding would support a Request for Proposal process for a community-based organization to provide the staffing. Chairman Hanley and Supervisor Hyland jointly seconded the motion.

Following discussion, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and asked to amend the motion to direct the County Executive to review this issue to determine if existing personnel could be re-deployed, and this was accepted.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

The question was called on the motion, as amended, which carried by a vote of seven, Supervisor McConnell and Supervisor Mendelsohn being out of the room, Supervisor Bulova being absent.

47. **<u>GIRL POWER PROGRAM</u>** (Tape 6)

Supervisor Kauffman noted that the Fairfax-Falls Church Community Services Board conducts several Girl Power programs for 9- to 14-year-olds in County schools and community centers. Based on the national Girl Power public education campaign launched in 1996, this substance abuse prevention program helps give girls the confidence to resist negative peer pressure. On Wednesday, June 28, 2000, Alcohol and Drug Services will host its first annual Girl Power conference at Mount Vernon Woods Elementary School.

Therefore, Supervisor Kauffman moved that the Board direct staff to:

- Prepare a Proclamation designating June 28, 2000, as "Girl *Power Day*" in Fairfax County.
- Invite Ms. Clara Marshall and other conference organizers to the June 26, 2000, meeting to be recognized and to receive the proclamation.

Chairman Hanley seconded the motion and it carried by a vote of seven, Supervisor McConnell and Supervisor Mendelsohn being out of the room, Supervisor Bulova being absent.

48. <u>E-MAIL AND WEBSITE ADDRESS TO BE INCLUDED IN THE WEEKLY</u> <u>AGENDA</u> (Tape 6)

Supervisor Gross said that on the back page of the *Weekly Agenda*, contact information is provided for each of the 10 Members of the Board. That information, however, does not presently include e-mail or website addresses. In fact, nowhere on the publication does it mention the County's main website address.

Therefore, Supervisor Gross moved that the Board direct staff to add to the *Weekly Agenda* the e-mail and website addresses for each Supervisor, and the County website address, along with directions on how to find out more information on Fairfax County government through the website. Chairman Hanley seconded the motion.

Supervisor Hudgins asked to amend the motion to include that the Board direct staff to be sure that e-mail addresses are included on publications, and this was accepted.

The question was called on the motion, as amended, which carried by a vote of seven, Supervisor McConnell and Supervisor Mendelsohn being out of the room, Supervisor Bulova being absent.

49. <u>CONCERT SERIES</u> (Tape 6)

(NOTE: Earlier in the meeting this issue was discussed. See Clerk's Summary Item #42.)

Supervisor Gross congratulated Supervisor Connolly for putting together the *Nottoway Nights* concert series. She added that the Mason District Concert series *Spotlight by Starlight* will start on Friday, June 2, 2000. She noted that there are three concerts per week.

50. **<u>PINE RIDGE PARK WATCH</u>** (Tape 6)

Supervisor Gross said that for more than a year, the Pine Ridge Park Watch has proudly served the County, ensuring that Pine Ridge Park is a safe place for all citizens. She added that this innovative program is now expanding Countywide, taking the Neighborhood Watch concept to the parks and trails.

Supervisor Gross moved that the Board direct staff to invite representatives of the Pine Ridge Park Watch, along with the many individuals who have been instrumental in the founding of the Fairfax County Park Watch, to appear before the Board at the June 5, 2000, meeting to be thanked for their efforts, and to share the details of this exciting new program. Chairman Hanley seconded the motion and it carried by a vote of seven, Supervisor McConnell and Supervisor Mendelsohn being out of the room, Supervisor Bulova being absent.

51. CAMELOT ELEMENTARY SCHOOL CELEBRATING THIRTIETH BIRTHDAY (Tape 7)

Supervisor Gross announced that Camelot Elementary School is celebrating its thirtieth birthday this year, with festivities culminating with a special celebration on June 9, 2000. Accordingly, she moved that the Board direct staff to:

- Prepare a Certificate of Recognition, on the occasion of Camelot's thirtieth birthday, to be presented at the celebration on June 9.
- Obtain the signatures of Chairman Hanley, Supervisor Connolly, and Supervisor Gross on the certificate.

Chairman Hanley seconded the motion, which carried by a vote of six, Supervisor Frey, Supervisor McConnell, and Supervisor Mendelsohn being out of the room, Supervisor Bulova being absent.

52. BREAST CANCER AWARENESS EVENT AT ANNANDALE POST OFFICE (Tape 7)

Supervisor Gross stated that on July 15, 2000, the United States Postal Service will host a Breast Cancer Awareness Event on site at the Annandale Post Office. She said that she will provide further details to the Board once plans for the day are finalized.

Noting that the post office has reserved the County's Showmobile for the event, Supervisor Gross moved that the Board waive the fees associated with the use of the Showmobile for this community event on July 15. Supervisor Connolly seconded the motion, which carried by a vote of six, Supervisor Frey, Supervisor McConnell, and Supervisor Mendelsohn being out of the room, Supervisor Bulova being absent.

53. VIRGINIA TRAVEL GUIDE 2000 (Tape 7)

Supervisor Gross stated that a constituent called to her attention that the *Virginia is for Lovers - Travel Guide 2000* is printed under the auspices of the Commonwealth of Virginia. She noted that Fairfax County is not well represented in the guide. Accordingly, she asked unanimous consent that the Board direct the staff of the Office of Public Affairs to determine how this guidebook is compiled, including:

- Who is asked for information.
- How additional information can be added to this guidebook.

Following discussion, without objection, it was so ordered.

54. INCLUSION OF THREE PUBLIC STREETS INTO PENDING REZONING APPLICATION FILED BY DULLES CONSOLIDATION LLC (Tape 7)

Supervisor Hudgins moved that the Board permit three public streets known as Greg Roy Lane, Fox Hunt Lane, and Roy Road to be included in the pending rezoning application filed by Dulles Consolidation LLC. She noted for the record that the inclusion of these streets within the pending rezoning application has been reviewed by and has the support of the Virginia Department of Transportation. As in all cases of matters such as this, the passage of this motion shall in no way be deemed to prejudice or be construed as an endorsement of the pending rezoning by the Board. Chairman Hanley seconded the motion, which carried by a vote of seven, Supervisor Frey and Supervisor McConnell being out of the room, Supervisor Bulova being absent.

55. **<u>HUNTER MILL DISTRICT COMMUNITY EVENTS</u>** (Tape 7)

Supervisor Hudgins announced that the Vienna community will celebrate the Seventeenth Annual Viva Vienna Festival on Saturday, May 27, 2000, from 10 a.m. until 11 p.m. and Sunday, May 28, 2000, from 12:30 p.m. until 7 p.m., along historic Church Street in Vienna.

Supervisor Hudgins announced that the Reston Festival will be held on Saturday, May 27, 2000, and Sunday, May 28, 2000, at Lake Anne Plaza in Reston. The headliner for Saturday's event is Tito Puento. Additional information is available at the website <u>www.restonfestival.com</u>.

Supervisor Hudgins invited the Board and the community to attend these special events.

Chairman Hanley remarked that recent events proceeded despite the rain over the weekend and that most community events are not canceled because of rain.

56. **DOG PARKS** (Tape 7)

Supervisor Hudgins stated that the Reston Dog Park Coalition (RDPC) is a membership organization comprised of a seven-member Board of Directors, volunteer committees, and over 255 members from Reston, Herndon, and other areas of the County. Currently RDPC is working with the Park Authority and other governmental agencies to identify viable sites for a dog park in Reston. RDPC also works within the community to promote responsible dog ownership and to publicize the need for off-leash areas.

Supervisor Hudgins said that RDPC has initiated the process to start an off-leash dog area by forwarding to the Park Authority site recommendations as a basis for identifying an off-leash dog area. Accordingly, she moved that the Board direct the Park Authority to review the site recommendations made by the RDPC and proceed to initiate an additional off-leash dog area. Supervisor Connolly seconded the motion.

Following discussion, Supervisor Gross asked to amend the motion to request the Park Authority to proceed expeditiously on the identification of other areas in the County suitable for dog parks, and this was accepted.

Following further discussion, the question was called on the motion, as amended, which carried by a vote of seven, Supervisor Frey and Supervisor McConnell being out of the room, Supervisor Bulova being absent.

57. **REVIEW AND INSPECTION FEE WAIVER FOR TOWN OF VIENNA'S NORTHSIDE PUBLIC WORKS FACILITY** (Tape 7)

Supervisor Hudgins stated that on May 8, 2000, the Vienna Town Council approved plans for construction of a Northside Public Works Facility. Currently the County's Department of Public Works and Environmental Services is reviewing those plans.

Noting that the Vienna Town Council has forwarded a request for a waiver of review and inspections fees for the project, Supervisor Hudgins moved that the Board waive the review and inspection fees for the Northside Public Works Facilities Project. Supervisor Connolly seconded the motion.

Following input from the David P. Bobzien, County Attorney, the question was called on the motion, which carried by a vote of seven, Supervisor Frey and Supervisor McConnell being out of the room, Supervisor Bulova being absent.

58. **<u>REQUEST FOR VACATION OF NALLS ROAD</u>** (Tape 7)

With reference to his written Board Matter regarding a request for a vacation of Nalls Road, Supervisor Hyland moved that the Board authorize the inclusion of the undeveloped portion of Nalls Road in Special Exception Application SE 00-V-12 submitted by C.N. Morris, Jr., Incorporated, the developer of Dawson Woods. He noted that this motion does not relieve the applicant from complying with the provisions of any applicable ordinances, regulations, or adopted standards, and does not prejudice the consideration of the land use application in any way. Supervisor Connolly seconded the motion, which carried by a vote of seven, Supervisor Frey and Supervisor McConnell being out of the room, Supervisor Bulova being absent.

59. REQUEST FOR PROFFERED CONDITION AMENDMENT APPLICATION PUBLIC HEARING DATE AND SIMULTANEOUS PROCESSING (Tape 7)

At the request of the applicant, Supervisor Hyland moved that the Board direct staff to:

- Schedule the public hearing to be held before the Board on August 7, 2000, for Proffered Condition Amendment Application PCA 1996-MV-037-3, South Station LC.
- Simultaneously process the subdivision and site plans for this single family detached development.

Supervisor Hyland noted that this motion does not relieve the applicant from complying with the provisions of any applicable ordinances, regulations, or adopted standards, and does not prejudice the consideration of the land use application in any way.

Supervisor Kauffman seconded the motion, which carried by a vote of seven, Supervisor Frey and Supervisor McConnell being out of the room, Supervisor Bulova being absent. 60.

APPRECIATION TO SENATOR JOHN WARNER AND CONGRESSMANTOMDAVISFOREXPRESSINGSUPPORTFORLOCATINGNATIONAL ARMY MUSEUM AT FORT BELVOIR(Tape 7)

Supervisor Hyland moved that the Chairman send a letter to Senator John Warner and Congressman Tom Davis expressing appreciation for their efforts in lending support for locating the National Army Museum in Fairfax County at Fort Belvoir. They both sent letters to Louis Caldera, Secretary of the Army, expressing support for the museum as well as support for locating it in the County. Supervisor Connolly seconded the motion.

Following discussion, the question was called on the motion, which carried by a vote of seven, Supervisor Frey and Supervisor McConnell being out of the room, Supervisor Bulova being absent.

Supervisor Hyland expressed appreciation to everyone on the committee in Mount Vernon District for their efforts.

Discussion continued briefly.

61. <u>"STINKING TRUCKS"</u> (Tape 7)

Supervisor Hyland reported that he recently experienced the offensive odor on an industrially zoned private property site at the intersection of Hassett Street and Giles Run Road in Lorton where many loaded trash, garbage, and sludge tractor trailer trucks park. He stated his understanding that truckers use this area as a layover stop on weekends and during the week. He said that the stench from these trucks is overwhelming to the extent that when the general public conducts business at nearby locations, they often cannot conclude their business because of the offensive odor. This adversely impacts the productivity of the surrounding businesses.

Following discussion, Supervisor Hyland moved that the Board refer this matter to the County Attorney to:

- Determine what, if anything, can be done to stop this continuing activity.
- If it is determined that the County has no authority over this matter, to make recommendations to the Board as to what needs to be done to give the County this authority.
- Return with recommendations as soon as possible.

Chairman Hanley seconded the motion.

Following discussion, Supervisor Gross asked to amend the motion to include this issue in the Board's next legislative program, which will be discussed this fall. This was accepted.

The question was called on the motion, as amended, which carried by a vote of seven, Supervisor Frey and Supervisor McConnell being out of the room, Supervisor Bulova being absent.

62. <u>SOUTH COUNTY CENTER</u> (Tape 7)

Supervisor Hyland stated that on May 11, 2000, the Mount Vernon Council of Citizens Associations' Board of Directors passed a resolution requesting the rescheduling of public hearings for the South County Center. The directors believe that there is not adequate time for citizens to review the report.

Accordingly, Supervisor Hyland moved that the Board direct the County Executive to reschedule the public hearings to be held before the Planning Commission and Board, respectively, to dates not earlier than July 2000. This motion died for lack of a second.

63. <u>MASON NECK CITIZENS ASSOCIATION REQUEST FOR MULTI-WAY</u> <u>STOPS</u> (Tape 7)

Supervisor Hyland moved that the Board direct the Department of Transportation to:

- Review the request from the Mason Neck Citizens Association for multi-way stop signs to be installed at the intersection of Old Colchester Road (Route 611) and Furnace Road (also Route 611).
- Prepare a Board resolution supporting this request.

Supervisor Hyland noted that the Virginia Department of Transportation has completed its review and concurs with this request.

Chairman Hanley seconded the motion, which carried by a vote of seven, Supervisor Frey and Supervisor McConnell being out of the room, Supervisor Bulova being absent.

64. BOARD MATTERS FOR SPRINGFIELD DISTRICT SUPERVISOR MCCONNELL (Tape 7)

Chairman Hanley noted that Supervisor McConnell was out of the room and that if she had Board Matters to present, the Board would consider them later in the meeting.

(NOTE: Later in the meeting, Supervisor McConnell did not present any Board Matters.)

65. **<u>RECESS/CLOSED SESSION</u>** (Tape 7)

At 12:50 p.m., Supervisor Connolly moved that the Board recess and go into closed session for discussion and consideration of matters enumerated in *Virginia Code* Section 2.1-344 and listed in the agenda for this meeting, and in addition:

- Mustang Crossing Owners Incorporated versus the Board of Zoning Appeals of Fairfax County, Record Number 991991, Virginia Superior Court.

Supervisor Hyland seconded the motion.

Chairman Hanley announced that should this motion carry, closed session would commence at 1:30 p.m.

The question was called on the motion, which carried by a vote of seven, Supervisor Frey and Supervisor McConnell being out of the room, Supervisor Bulova being absent.
