This proposed development is one section of the Lerner property that eventually will contain significant public open space and pedestrian connections. The office building and these amenities will help to create transit-oriented development around future rail stations in Tysons Corner.

Supervisor Connolly moved that the Board direct the Director of the Department of Public Works and Environmental Services to concurrently process the site plans and other associated plans related to the applications with the review of these applications. This action does not prejudice the consideration of this review in any way. Supervisor Bulova seconded the motion and it carried by unanimous vote.

34. **EARTHQUAKE DEVASTATES EL SALVADOR** (Tape 4)

Supervisor Connolly said that on January 13, 2001, Central America was devastated by an earthquake measuring 7.6 on the Richter scale. The hardest hit was El Salvador, leaving more than 46,000 people homeless and more than 1,200 people dead. Many of the deaths were caused by mudslides that covered several towns leaving the residents buried. Because many of El Salvador's citizens were left homeless, much aid is needed to help care for the victims of this earthquake. The Hispanic Community has begun to raise money to help the victims. A Spanish-Language Radiothon Fundraiser was held on Saturday January 20, 2001, with local area restaurants collecting donations.

Supervisor Connolly said that much more money is needed to help the victims during this time of need. St. Anthony's Catholic Church in Northern Virginia is collecting money that will be personally taken to El Salvador by Father Eugino Hoyos. The League of United Latin American Citizens (LULAC) and the American Salvadoran Association of Virginia is collecting money to help aid the victims. All donations are tax deductible and will go to rebuild El Salvador. The American Red Cross and many other non- profit organizations will also be taking donations.

Supervisor Connolly asked unanimous consent that the Board direct the Office of Public Affairs to publicize through Channel 16 and the County website the opportunities to make donations which will help rebuild the

lives of many who have lost everything during this natural disaster. Without objection, it was so ordered.

AN INVITATION TO MOUNT VERNON'S FOURTEENTH ANNUAL TOWN MEETING – SATURDAY, JANUARY 27, 2001 (Tape 4)

Supervisor Hyland announced that Mount Vernon's fourteenth Annual Town meeting is to be held on Saturday, January 27, 2001, 8 a.m. until 1 p.m. at Mount Vernon High School's Little Theatre, 8515 Old Mount Vernon Road, Alexandria (Fairfax County). This meeting generates an attendance of 350 to 450 persons.

Supervisor Hyland announced that Chairman Hanley; Supervisor Kauffman; Anthony H. Griffin, County Executive; and School Superintendent, Daniel Domenech will be participating. Although the Town Meeting is directed primarily to residents of Mount Vernon and those along Richmond Highway, the meeting is open to all citizens of Fairfax County, providing a local forum to hear first hand the significant issues involving Mount Vernon, as well as Countywide, while creating the opportunity for citizens to meet their elected representatives and express their views and concerns.

41. CHRISTIAN RELIEF SERVICES (CRS) (Tape 4)

Supervisor Hyland said that he was recently sent a copy of the CRS Annual Report commemorating 15 years of service to those locally, nationally, and around the world living under conditions of poverty, illness, and despair.

Supervisor Hyland moved that the Board direct staff to invite the Executive Director of CRS to appear before the Board to be recognized for its contributions to persons in need in Fairfax County. Supervisor Kauffman seconded the motion and it carried by unanimous vote.

ANALERTFROMTHEIMMIGRATIONANDNATURALIZATION SERVICE (INS)(Tape 4)

Supervisor Hyland said that he recently received a letter from Mr. Orantes, regarding an information campaign recently adopted by the Board of Supervisors of Los Angeles County, California, concerning the extension of Section 245(I) of the Legal Immigration and Family Equity (LIFE) Act.

Supervisor Hyland said that the INS advisory notifies the public that the agency is moving very quickly to develop application procedures for immigration benefits created by the LIFE Act. The public will be informed as procedures are finalized.

Supervisor Hyland said that one of the provisions of the LIFE Act is the temporary reinstatement of Section 245(I) of the Immigration and Nationality Act (INA). Section 245(I) is not amnesty for all persons

unlawfully in the US. This provision only applies to certain persons residing in the US who, although otherwise eligible for an immigrant visa, are barred from adjusting their status in the US. It allows such persons to adjust their status in the US instead of acquiring their visa abroad.

Supervisor Hyland said that a fact sheet on the LIFE Act can be found on the INS website: <u>www.ins.usdoj.gov</u>.

Accordingly, Supervisor Hyland asked unanimous consent that the fact sheet be disseminated through the Office of Public Affairs for appropriate action and publicity. Without objection, it was so ordered.

<u>REZONING APPLICATION RZ 2000-MV-060</u> (Tape 4)

Supervisor Hyland moved that the Board authorize the County Executive to serve as the Board's authorized agent for purposes of completing the affidavit for Rezoning Application RZ 2000-MV-060 on behalf of the Board and to certify that the County Executive is authorized to act as the Board's agent with regard to this matter. Supervisor Kauffman seconded the motion and it carried by unanimous vote.

44. <u>MOTION TO DECLINE OFFER OF DEDICATION OF OPEN</u> <u>SPACE</u> (Tape 4)

Supervisor Hyland referred to his written Board Matters in which Beazer Homes, the developer of Section Three of Worthington Woods, proposes a resubdivision of that section that would delete a small portion of the common open space shown on the current recorded plat. This area is 20,395 square feet in size. The resubdivision would redistribute this area into some existing lots to increase their size. The increase in the size of these lots will permit construction of more upscale units. No increase in the number of lots is proposed.

These common open space areas are not readily usable for recreational purposes, nor would their deletion adversely affect properties outside the boundaries of the subdivision. As reconfigured, the common open space will still exceed site plan open space requirements of the Zoning Ordinance. Since there is no proffered plan, there is no specific amount of open space proffered.

The reduction in size of the common space will constitute a "disposal of common open space" under Section 2-702(4) of the Zoning Ordinance. The County Attorney's office interprets this provision as requiring Beazer Homes to first offer the small open space area for dedication to the County.

Since this open space area is of no real value to the County, it would be appropriate for the Board to decline the offer of dedication and allow the open space to remain within the community.

Supervisor Hyland moved that the Board, pursuant to Section 2-702(4) of the Zoning Ordinance, decline the offer of dedication of the 20,395 square feet of open space described in the Resubdivision Plat. Supervisor Kauffman seconded the motion and it carried by unanimous vote.

45. ANNANDALE HIGH SCHOOL RESIDENTIAL PERMIT PARKING DISTRICT (RPPD) (Tape 4)

Supervisor Bulova said that student parking on residential streets around Annandale High School continues to be a serious problem and expansion of the Annandale RPPD is needed.

Supervisor Bulova said she has forwarded to the Department of Transportation petitions for the expansion of the Annandale RPPD on Erie Street from Manion Street to Heritage Drive, and for the entire length of Barr Place and Hoy Place.

Therefore, Supervisor Bulova moved that the Board direct staff to waive the number of parking spaces and the fees, and to proceed as expeditiously as possible. Supervisor Mendelsohn seconded the motion and it carried by unanimous vote.

46. <u>COUNTYWIDE NON-MOTORIZED (TRAILS) COMMITTEE</u> (Tape 4)

(BACs) Supervisor Bulova asked unanimous consent that the Board direct staff to report with the composition of the County Non-motorized (Trails) Committee and for recommendations if there is not user representation. Without objection, it was so ordered.

47. **INCREASED ENERGY COSTS** (Tape 5)

Supervisor Hudgins stated that the Energy Information Administration of the US Department of Energy and the District of Columbia Energy Office made a presentation to the Washington Metropolitan Council of Governments Board of Directors meeting on January 10, 2001, on the expected increase in the cost of energy adversely affecting home heating bills this winter. Those bills could increase by 50 percent or more this winter as a result of colder weather, low fuel availability, and increased costs. The supply of electricity has been insufficient in parts of the US, especially California, causing the need for brownouts and rolling blackouts. While the local region has not been affected to that extent, the increased cost has caused a hardship for some homeowners.

Accordingly, Supervisor Hudgins moved that the Board direct:

- Staff to review the impact that increased energy costs and low fuel inventory has had on Fairfax County citizens.
- The Office of Public Affairs to publicize information on the Energy Assistance Programs available in the County, how citizens may participate in the programs, and the importance for citizens to conserve all energy sources.

Supervisor Bulova seconded the motion, which carried by unanimous vote.

> Supervisor Bulova asked to amend the motion to include on handwritten page 57 of the proposed Ordinance, lines 14 through 16 to read as follows: "...a grantee shall provide Public, Educational and Governmental (PEG) access support as authorized by federal law, 47 U.S.C. Section 531, and as specified in the Franchise Agreement. Terms to be established by the Board."

Discussion ensued with input from Michael Long, Senior Assistant County Attorney.

A Certificate of Publication was filed from the editor of the *Fairfax Journal* showing that notice of said public hearing was duly advertised in that newspaper in the issues of January 4 and January 11, 2001.

Following the public hearing, which included testimony by 15 speakers, there was input from James P. Zook, Director, Department of Planning and Zoning, and Jeffrey L. Blackford, Deputy Director, Office of Site Development Services, Department of Public Works and Environmental Services.

Supervisor Mendelsohn, jointly with Supervisor Kauffman, moved approval of the Planning Commission recommendations, including its established priorities, with the following modifications:

- Return SC-5, "Allow cluster development by-right," to staff for further evaluation. Given likely State legislation which could mandate cluster-by-right, it is imperative that staff closely monitor that legislation and be prepared to begin drafting criteria that limits the impact of cluster development as soon as possible after the 2001 General Assembly session. This must include items such as:
 - Tree preservation
 - Buffer areas
 - Conservation easements and parkland dedications
 - Limits on clearing and grading
 - EQC preservation
 - Setbacks greater than the minimum yard requirements
 - Innovative stormwater management and BMPs
 - Right-of-way dedication and road improvements

In addition, any consideration that would allow cluster development by-right should be strictly limited to residential zones of R-2 and above and be limited to cases where cluster plans would allow no more homes than can be built by-right, taking into account reductions in land area for RPAs.

• Modify SC-9, "Modify bulk regulation provisions in the Zoning Ordinance," with a directive to staff to come back to the Board with amendments to the dated (1977) "Transitional Screening" requirements. Specifically, staff needs to consider adding screening requirements between residential uses.

- Return TP-1, "Reduce grading to increase • tree preservation," to staff for further review. Staff review should include an evaluation of additional environmental benefits associated with tree preservation above and beyond reductions in grading and runoff. The review should examine other methodology besides the coefficients looked at in this study.
- Amend TR-4A, to delete references to "sidewalks" and replace it with "sidewalks or trails." Supervisor Kauffman and Supervisor Mendelsohn support additional language to allow trails to meander around trees or other environmentally sensitive areas where possible.

Supervisor Kauffman seconded the motion.

Supervisor Bulova asked to amend the motion and include in bullet number 4 "....sidewalks, trails, or paths." This was accepted.

The question was called on the motion, as amended, and it carried by unanimous vote.
