The meeting was called to order at 9:35 a.m., with all Members being present, with the exception of Supervisor Hyland, and with Chairman Hanley presiding.

Supervisor Hyland arrived at 3:15 p.m.

#### **BOARD MATTER**

#### 1. **MOMENT OF SILENCE** (Tape 1)

Chairman Hanley asked everyone to keep in thoughts and prayers the family of Ms. Florence Mendelsohn, Supervisor Stuart Mendelsohn's mother, who died on February 26, 2002. On behalf of the Board, Chairman Hanley offered condolences to Supervisor Mendelsohn and his family, and said that the Board will contribute \$300 to the American Heart Association, the Mid-Atlantic affiliate's memorial processing center.

Chairman Hanley asked everyone to keep in thoughts and prayers the family of Clive DuVal II, former Virginia state Senator, who died last week. He was a shining example of civility in politics.

Chairman Hanley asked everyone to keep in thoughts and prayers the family of Mr. Michael Giguere, who died last week. He was involved with the land use process for the County.

Chairman Hanley asked everyone to keep in thoughts and prayers the family of Ms. Mary Ann Hurt who died last week. She lived in Lake Barcroft, and was a community activist in the Mason District.

Supervisor Kauffman asked everyone to keep in thoughts and prayers the family of Delegate Kristen Amundson, whose father died last week.

Supervisor Mendelsohn asked everyone to keep in thoughts and prayers the family of Ms. Martha Seeley, who died recently.

Supervisor Bulova moved approval of the Proclamation designating March as "*Development Disabilities Inclusion Month*" in Fairfax County. Supervisor Connolly seconded the motion and it carried by a vote of nine, Supervisor Hyland not yet having arrived.

#### 4. PROCLAMATION DESIGNATING MARCH AS "COLON CANCER AWARENESS MONTH" IN FAIRFAX COUNTY (Tape 1)

Chairman Hanley moved approval of the Proclamation designating March as *"Colon Cancer Awareness Month"* in Fairfax County. Supervisor Connolly and Supervisor McConnell jointly seconded the motion and it carried by a vote of eight, Supervisor Frey being out of the room, Supervisor Hyland not yet having arrived.

#### 5. <u>PROCLAMATION DESIGNATING MARCH AS "PURCHASING</u> <u>MONTH" IN FAIRFAX COUNTY</u> (Tape 1)

Chairman Hanley moved approval of the Proclamation designating March as "*Purchasing Month*" in Fairfax County. Supervisor Bulova seconded the motion and it carried by a vote of nine, Supervisor Hyland not yet having arrived.

#### 6. <u>10 A.M. – PRESENTATION BY THE LONG TERM CARE (LTC) TASK</u> <u>FORCE</u> (Tapes 1-2)

(BACs) Barry Ingram, Chairman, LTC Task Force, gave remarks. Eileen Dohmann, Member, LTC Task Force, presented the report.

Discussion ensued with input from Martha Glennan and Marlene Blum, Members of the LTC Task Force.

Supervisor Hudgins moved that the Board:

- Accept the LTC Task Force report and recommendations.
- Direct staff to return with input on the recommendations, in order to allow the:
  - Board to begin a series of meetings.
  - Human Services Committee to begin addressing the recommendations.

The second to this motion was inaudible.

Chairman Hanley relinquished the Chair to Acting-Chairman McConnell and asked to amend the motion that the Board:

- Refer the report to staff.
- Direct staff to return immediately with a structure report on the LTC Council.

Supervisor Connolly seconded the motion.

Supervisor Hudgins clarified that her motion to have input from staff would have a 60 day turn around time frame.

Following discussion, with input from Anthony H. Griffin, County Executive, Chairman Hanley asked unanimous consent that the Board direct staff to return at the next Board meeting scheduled for March 18, 2002, with the structure report on the LTC Council. Without objection, it was so ordered.

Acting-Chairman McConnell returned the gavel to Chairman Hanley.

Supervisor Connolly asked to amend the motion that the Board direct staff to send the report to the Members of the Fairfax County Delegation of the General Assembly with a cover letter that addresses the concerns regarding the State's lack of assistance with Medicare funding. This was accepted.

Following further discussion, the question was called on the motion, as amended, and it carried by a vote of nine, Supervisor Hyland not yet having arrived.

#### 7. <u>10:15 A.M. – PRESENTATION BY THE HOMELESS OVERSIGHT</u> <u>COMMITTEE</u> (Tape 2)

Sharon Kelso, Peyton Whiteley, and Carla Taylor, Co-Chairs, Homeless Oversight Committee, presented its report.

Discussion ensued with input from Michael Finkle, Acting Director, Division of Housing Management, Department of Housing.

Noting that a report had been previously requested, Supervisor Hudgins asked unanimous consent that the Board direct staff to report with how many units have become unavailable as a result of integrating incomes, in terms of the program. Without objection, it was so ordered.

Following discussion, with input from Mr. Finkle, Supervisor McConnell asked unanimous consent that the Board direct staff to report with information regarding whether there is any County property available for placing modular homes. Without objection, it was so ordered.

Further discussion ensued with input from Anthony H. Griffin, County Executive, and Mr. Finkle.

#### 12. I-2 - CONTRACT AWARD - DESIGN SERVICES FOR DEVELOPMENT OF A MINIATURE GOLF COURSE AT BURKE LAKE PARK (SPRINGFIELD DISTRICT) (Tape 2)

The Board next considered an item contained in the Board Agenda dated March 4, 2002, requesting authorization for staff to award a contract to William H. Gordon Associates, Incorporated, in the amount of \$139,950 for design, permitting, bidding, construction administration, and supplemental services for the design of a miniature golf course at Burke Lake Park located at 7315 Ox Road, Fairfax Station, Tax Map Number 87-4(1)) 6. Funds are currently available in Project 004748, General Park Improvements, in Fund 371, Park Capital Improvement Fund.

The staff was directed administratively to proceed as proposed.

#### 13. **ABSENCE OF SUPERVISOR HYLAND** (Tape 3)

Chairman Hanley noted that Supervisor Hyland was representing the County along with the Police Chief and the Fire Chief at a National Association of Counties presentation in Washington, DC this morning.

(NOTE: Later in the meeting, Supervisor Hyland reported on his appearance there. See Clerk's Summary Item CL#55.)

#### 14. **FOSTER CARE MONTH** (Tape 3)

Chairman Hanley announced that in conjunction with the national observances, the Fairfax County Foster Care Association has requested that the County observe May as Foster Care Month.

Therefore, Chairman Hanley relinquished the Chair to Acting-Chairman McConnell and moved that the Board direct staff to invite representatives from the foster care community to appear before the Board at the May 6, 2002, meeting to receive a Proclamation declaring May as *"Foster Care Month"* in Fairfax County. Supervisor Connolly seconded the motion and it carried by a vote of seven, Supervisor Gross and Supervisor Mendelsohn being out of the room, Supervisor Hyland not yet having arrived.

#### 15. **<u>NATIONAL PUBLIC HEALTH WEEK</u>** (Tape 3)

Chairman Hanley announced that "Healthy People, Healthy Communities" is the theme of National Public Health Week to be celebrated April 1-7, 2002. To coincide with the national observance and to recognize the regional efforts made to respond to bioterrorism, Chairman Hanley moved that the Board direct staff to invite representatives from the Health Department, the Health Care Advisory Board, Inova Health Systems, and the Health Departments in Arlington, Alexandria, and Winchester to appear before the Board at the March 18, 2002, meeting to receive a proclamation declaring April 1-7, 2002, *as "Public Health Week"* in Fairfax County. Supervisor Connolly seconded the motion and it carried by a vote of eight, Supervisor Gross being out of the room, Supervisor Hyland not yet having arrived.

#### 16. WORLD TUBERCULOSIS DAY (Tape 3)

Chairman Hanley announced that World Tuberculosis Day is designated as March 24, 2002. To encourage all Fairfax County residents to recognize the importance of TB screenings, she moved that the Board direct staff to invite representatives from the Health Department and a physician working closely with TB patients to appear before the Board at the March 18, 2002, meeting to receive a proclamation declaring March 24, 2002, as *"TB Awareness Day"* in Fairfax County. Supervisor Connolly seconded the motion and it carried by a vote of nine, Supervisor Hyland not yet having arrived.

#### 17. **AREA PLANS REVIEW (APR) PROCESS** (Tape 3)

Chairman Hanley said that the ongoing APR process has raised the need for Policy Plan guidance regarding the process and the types of property that are generally appropriate for public parks, as well as a clarification and affirmation of the County Policy supporting privately initiated open space transactions, such as the donation of conservation easements to non-profit organizations.

Chairman Hanley reminded the Board that there were a number of propertyspecific "park option" nominations submitted in the ongoing APR process. She asserted that there should be clear and concise Countywide guidance in the Policy Plan about the type of properties that might be appropriate for public park use. Furthermore, it should be clear that a property-specific designation in an Area Plan is not required for consideration of a property for public park acquisition.

Chairman Hanley noted that it is important to recognize that the County enthusiastically supports the efforts of the Northern Virginia Conservation Trust, the Park Authority, and other groups that enable private land owners the opportunity to donate development rights and receive favorable Internal Revenue Service (IRS) treatment as thank yous for their generosity. One of the criteria the IRS uses to evaluate the validity of a conservation easement dedication is the support from state and local policies. To make sure there is no misunderstanding at the IRS about County endorsement of these transactions, the Policy Plan should incorporate a concise statement of support for privately initiated conservation transactions.

Therefore, Chairman Hanley moved that the Board direct staff to draft appropriate Plan language regarding County policies supporting parks and open space and return to the Board for advertisement. Supervisor Connolly seconded the motion.

Following discussion, the question was called on the motion, which carried by a vote of nine, Supervisor Hyland not yet having arrived.

#### 18. **IMPORTANCE OF VIRGINIA SCHOOL CENSUS FORMS** (Tape 3)

Chairman Hanley reminded Board Members that they had received a letter from the Superintendent of Schools requesting assistance in publicizing the importance of the Virginia School Census forms. The results of the census affect school funding. Accordingly, she asked unanimous consent that the Board direct staff to publicize the importance of the forms on the County's website. Without objection, it was so ordered.

#### 19. **LEGAL RULING REGARDING PAINT** (Tape 3)

Chairman Hanley called the Board's attention to a press release she had received with the headline "Milestone Ruling in Rhode Island's Lawsuit Against Paint Companies." She asked unanimous consent that the Board direct the County Attorney to examine this case and report with information regarding lead paint class action suits in the legal community. Without objection, it was so ordered.

The Board briefly discussed the County's population in comparison with Rhode Island and other states.

Acting-Chairman McConnell returned the gavel to Chairman Hanley.

#### 20. MADEIRA SCHOOL'S GIRLS' SWIM AND DIVE TEAM (Tape 4)

Supervisor Mendelsohn announced that the Madeira School's Girls' Swim and Dive Team defended its title at the Virginia State Independent Schools Championship in Chatham, Virginia. These young women scored 295 points and dominated the competition, amassing 49 more points than runners-up in this field of 32. This was Madeira's second State athletic title in its 96-year history.

Supervisor Mendelsohn said that leading the Snails to victory were senior captains, Lauren Edmondson and Katie Mims.

Supervisor Mendelsohn moved that the Board direct staff to invite the Madeira School's Girls' Swim and Dive Team, and coaching staff to appear before the Board at a date to be determined to be recognized for these significant accomplishments. Connolly seconded the motion and it carried by a vote of nine, Supervisor Hyland not yet having arrived.

#### 21. <u>CERTIFICATE OF RECOGNITION FOR MS. CHRISTINA GHANI</u> (Tape 4)

Supervisor Bulova announced that Christina Ghani of Lake Braddock Secondary School is the State's Individual All Around Gymnastics Champion.

Therefore, Supervisor Bulova moved that the Board direct staff to invite Ms. Ghani to appear before the Board to be recognized for her significant accomplishment. Supervisor Frey seconded the motion and it carried by a vote of nine, Supervisor Hyland not yet having arrived.

#### 22. <u>TELEVISING COUNTY CONCERTS</u> (Tape 4)

Supervisor Bulova moved that the Board direct staff to investigate the possibility of taping the summer concert series held in the County's parks during the summer and broadcasting those shows on Channel 16 throughout the year. Supervisor Connolly seconded the motion and it carried by a vote of nine, Supervisor Hyland not yet having arrived.

#### 23. **DIGITAL GUIDE FOR CABLE CHANNEL 16** (Tape 4)

Supervisor Bulova asked unanimous consent that the Board direct staff to determine if additional programming information could be provided on the digital guide for cable Channel 16. Without objection, it was so ordered.

#### 24. **FAIRFAX COUNTY LICENSE PLATE** (Tape 4)

Supervisor Gross reminded the Board, interested citizens, and employees that they now have an opportunity to show pride in Fairfax County by reserving a new license plate commemorating the County's history. The Fairfax County license plate features the County coat-of-arms and the motto "Home of the Bill of Rights." Proceeds from the purchase of a Fairfax County license plate will help to support the County's historic preservation activities and programs.

The Virginia Department of Motor Vehicles (DMV) requires that the County collect 350 pre-paid applications before plate production can begin. To date, 250 more applicants are needed to reach the goal of 350 by June 2002. Once 350 pre-paid registrations have been received, the County will submit them to the DMV and the license plates will be produced and issued directly to the applicant. The annual fee for the Fairfax County plate is \$25 and a personalized Fairfax County plate is \$35. After a total of 1000 plates are sold, the DMV will forward \$15 from the sale of each plate to Fairfax County.

#### 25. <u>"IMPACT OF WOMEN IN PUBLIC OFFICE"</u> (Tape 4)

Supervisor Gross said that the March 2, 2002, newsletter of the League of Women voters of the Fairfax area has an article entitled "The Impact of Women in Public Office." She briefly outlined the article.

Supervisor Gross asked unanimous consent that the Board direct staff to:

- Refer this article to the Office for Women.
- Send the article to the School System.

Chairman Hanley noted that there was an inaccuracy in the article. She said that the article reported that since 1952 there has always been at least one woman elected to the Board with a high of five serving today. She pointed out that at one time there were six women on the Board when the total number of members on the Board was nine.

Supervisor Gross asked to amend the request that the error be corrected, and this was accepted.

Following discussion, without objection, as amended, the request was so ordered.

#### 26. <u>**RESTON CELEBRATES LONGEVITY WITH AN "OVER 90"**</u> <u>**CELEBRATION** (Tape 4)</u>

Supervisor Hudgins said that on Monday, February 18, 2002, yesterday's teenagers of Reston celebrated their longevity at Lake Anne's Fellowship House with an "over 90" celebration. One of Reston's oldest citizens, Mr. Vartan Anooshian, celebrated his 108th birthday. Mr. Anooshian is believed to be Reston's oldest citizen. There were a total of 18 nonagenarians honored at the "Over 90" party.

Therefore, Supervisor Hudgins moved that the Board recognize Mr. Anooshian with a proclamation commemorating his longevity as well as his 108<sup>th</sup> birthday. Chairman Hanley seconded the motion and it carried by a vote of nine, Supervisor Hyland not yet having arrived.

#### 27. <u>APPOINTMENT OF THE STUDENT MEMBER OF THE</u> ENVIRONMENTAL QUALITY ADVISORY COUNCIL (EQAC) (Tape 4)

(APPT) Supervisor Hudgins said that recently the student member of EQAC resigned from this position. EQAC has recommended that Sonya Khan be appointed to complete the Student Member's term, which runs through June, 2002. Ms. Khan is a resident of the Hunter Mill District and is a junior at South Lakes High School. She was the alternate for the Student Member position as selected by EQAC in June 2001.

Therefore, Supervisor Hudgins moved the appointment of <u>Ms. Sonya Khan</u> as the Student Member of EQAC to fill the unexpired term of Ms. Priyanka Tandon for a term to run through June 2002. Supervisor Connolly seconded the motion and it carried by a vote of nine, Supervisor Hyland not yet having arrived.

#### 28. <u>REZONING APPLICATIONS RZ 2001-SP-041 AND RZ 2001-SP-043</u> (Tape 4)

Supervisor McConnell said that Centex Homes has submitted rezoning applications for the DixCenGato area of Fairfax Center. The main application proposes to rezone the subject property from the R-1 and R-2 Districts to the PDH-12 District. A smaller application proposes a rezoning from the R-1 District to the R-5 District.

The Planning Commission public hearing on these applications is currently scheduled for April 24, 2002. The Planning Commission public hearing was deferred from March 20, 2002, to give the applicant time to resolve outstanding issues. The applicant has requested that the Board schedule its public hearing to occur on May 6, 2002.

Therefore, Supervisor McConnell moved that the Board direct staff to schedule the public hearing to be held before the Board on Rezoning Applications RZ 2001-SP-041 and RZ 2001-SP-043 to occur on May 6, 2002. This motion does not relieve the applicant from complying with all regulations, ordinances, or adopted standards, and does not prejudice the consideration of the rezoning applications in any way. Chairman Hanley seconded the motion and it carried by a vote of nine, Supervisor Hyland not yet having arrived.

#### 29. **RESULTS OF SURVEY TO BE PRESENTED** (Tape 4)

Supervisor McConnell announced that at the next Board meeting she would be presenting the results of the survey completed by her office. She added that two major concerns in the Springfield District are education and traffic.

Supervisor Kauffman announced that Supervisor Hyland indicated to him his intent to defer the public hearing on Special Exception Application SE 01-V-035 later in the meeting at the appropriate time.

#### 32. **OLDER AMERICANS MONTH** (Tape 5)

Supervisor Kauffman stated that seniors contribute to the community in significant ways. They are community leaders, providing volunteer assistance to other seniors, leading civic groups, mentoring school children, and supporting parks and cultural institutions. To recognize the important contributions older Americans make in the community, this year's theme for Older Americans Month will be "America: A Community for All Ages."

Accordingly, Supervisor Kauffman moved that the Board direct staff to:

Supervisor Frey said that Ratcliffe Associates, LC has submitted a rezoning application to request approval for development of a mix of single family attached and detached homes on 22.5 acres located on Lee Highway. Due to the large number of sellers that are participating in this rezoning application, the applicant is anxious to proceed with the Board public hearing. #### **ADDITIONAL BOARD MATTERS**

#### 50. **PROPOSAL FOR TAX RELIEF** (Tape 7)

Supervisor Hyland referred to his written Board Matter regarding tax relief in light of double-digit real estate tax assessments and noted that he was resurrecting a proposal he had made some years ago.

Accordingly, Supervisor Hyland moved that the Board refer the following two proposals to staff and the Board's Legislative Committee:

- Placing an annual cap of not more than ten percent on real estate assessment increases on residential property representing the principal domicile of County homeowners.
- Allowing deferral of all or a portion of annual real estate tax assessment increases for those residents who are over age 65 and retired for payment in full to the County until the residents sell their homes or die. At that time, their deferred taxes plus interest would be collected and made payable to Fairfax County.

Without objection, it was so ordered.

Supervisor Frey asked unanimous consent that the Board direct staff to determine what other states and jurisdictions around the country are implementing for tax relief for the elderly. Without objection, it was so ordered.

Following further discussion, Supervisor Connolly asked unanimous consent that the Board direct staff to include in the information about other jurisdictions additional information about their differences in regard to Fairfax County and its reliance on the real estate tax. Without objection, it was so ordered.

#### 51. <u>REQUEST FOR AN ANALYSIS OF PRESENT AND FUTURE</u> <u>DEVELOPMENT AT FORT BELVOIR</u> (Tape 7)

Supervisor Hyland referred to his written Board Matter regarding development at Fort Belvoir. In it he noted recent reports that Fort Belvoir had just begun the process of building 2,569 new residences on the base known as the "Residential Communities Initiative." The Army Materiel Command, with its 800 - 1,000 employees will be locating to Fort Belvoir by July 2002. The Southwest Administrative Park, which will serve as a work center for 15,000 army and military-affiliated personnel, is proposed to be placed at Fort Belvoir near the entrance to the Fairfax County Parkway. In addition, the National Army Museum to be located at Fort Belvoir is expected to attract one million visitors annually.

Supervisor Hyland asked unanimous consent that in light of all these developments and activities at Fort Belvoir, as well as proposed development there, that the Board direct staff to analyze present and proposed changes to Fort Belvoir and provide the Board with a report of the development conditions and proffers which would be required if a private developer were to develop and/or make such changes. He noted that he hoped to share the results of the analysis with the County's Congressional Delegation as well as the Department of the Army. Without objection, it was so ordered.

#### 52. <u>REQUEST FOR "NO THROUGH TRUCK TRAFFIC" AND "WATCH</u> <u>FOR CHILDREN" SIGNS ON HUNTINGTON DRIVE</u> (Tape 7)
