The meeting was called to order at 8:35 a.m., with all Members being present, with the exception of Supervisor McConnell, and with Chairman Hanley presiding.

Supervisor McConnell arrived at 8:45 a.m.

BOARD MATTER

1. CONGRATULATIONS TO ROBERT AND EDITH STAMPER ON THEIR SIXTIETH WEDDING ANNIVERSARY (Tape 1)

Chairman Hanley announced that this past Sunday Board Room photographer Robert Stamper and his wife Edith celebrated their sixtieth wedding anniversary and she congratulated them on the happy event.

2. <u>CERTIFICATE OF RECOGNITION PRESENTED TO MR. PETER BRINITZER</u> (Tape 1)

Supervisor Hyland moved approval of the Certificate of Recognition presented to Mr. Peter Brinitzer for his service to the community and Fairfax County. Supervisor Connolly and Chairman Hanley jointly seconded the motion and it carried by a vote of nine, Supervisor McConnell not yet having arrived.

3. PROCLAMATION DESIGNATING OCTOBER AS "NATIONAL DISABILITY EMPLOYMENT AWARENESS MONTH" IN FAIRFAX COUNTY (Tape 1)

Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and moved approval of the Proclamation to designate October as "National Disability Employment Awareness Month" in Fairfax County. Supervisor Hyland seconded the motion and it carried by unanimous vote.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

Supervisor Bulova asked unanimous consent that the Board direct the County Executive to provide the Board with a report on the progress for accommodating people with disabilities in Fairfax County employment by answering the following questions:

- How is Fairfax County doing?
- What were the accommodations to the *disabled employees*?
- What has the County's progress been?
- Is the County doing these things as quickly as they can?

Without objection, it was so ordered.

26. <u>"PEDESTRIAN SAFETY MONTH" IN FAIRFAX COUNTY</u> (Tape 6)

Chairman Hanley noted that the County has been working with other local jurisdictions at the Washington Metropolitan Council of Governments (COG) to increase public awareness for pedestrian safety issues. COG has developed a regional Pedestrian Safety Awareness Ad Campaign to begin on October 1, 2002.

Chairman Hanley pointed out that the Board has supported several initiatives to improve pedestrian safety. As a result of the Transportation Advisory Commission's recommendations, the Board:

- Designated a Pedestrian Program Manager position.
- Approved new "Yield to Pedestrian Signs."
- Funded the Bus Stop Pedestrian Safety Study.

Therefore, since Fairfax County is on record as committed to pedestrian safety efforts and to the COG Pedestrian Safety Awareness Ad Campaign, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and moved that the Board direct staff to:

- Prepare and send to COG a proclamation declaring October as "Pedestrian Safety Month" in Fairfax County.
- Utilize \$50,000 of the Bus Stop Pedestrian Safety Study to support the regional Pedestrian Safety Awareness Ad Campaign.

Supervisor Connolly seconded the motion and it carried by unanimous vote.

27. **COMMUNITIES IN MOTION DAY** (Tape 6)

Chairman Hanley said that to acknowledge the vital role that public transportation plays in the community, the American Public Transportation Association as well as other national transit organizations have established, October 3, 2002, as "Communities in Motion Day." Fairfax County will participate in this national event to thank all the transit users and to use this opportunity to appeal to more people to use public transportation. The Department of Transportation staff plans to have public transportation "ambassadors" at six transit stations the morning of October 3 to celebrate "Communities in Motion." They will provide bus schedules and hand out small thank you gifts to passengers. In addition, an information display will be located in the lobby of the Pennino Building from September 23-27, in the lobby of the Herrity Building from September 30-October 4, and in the lobby of the Government Center from October 7-11. An information tent and Mobile Commuter Store will be part of the *Fall for Fairfax* celebration on October 5.

Accordingly, Chairman Hanley asked unanimous consent that the Board direct staff to publicize this event, as well as the location of the displays. Without objection, it was so ordered.

28. <u>"FINANCIAL PLANNING WEEK" IN FAIRFAX COUNTY</u> (Tape 6)

Chairman Hanley said that the County has been contacted by the Financial Planning Association of the National Capital Area to request recognition for Financial Planning Week.

Chairman Hanley moved that the Board direct staff to prepare and send a proclamation declaring October 7 - 13, 2002, as "Financial Planning Week" in Fairfax County. Supervisor Connolly seconded the motion and it carried by unanimous vote.

31. <u>LETTER FROM STATE SENATOR CUCCINELLI REGARDING FORT</u> <u>BELVOIR (MOUNT VERNON)</u> (Tape 6)

Chairman Hanley distributed to the Board copies of a letter she had received from State Senator Kenneth Cuccinelli regarding housing at Fort Belvoir. Following discussion, she asked unanimous consent that the Board direct staff to provide her with all the recent communications regarding Fort Belvoir and she would follow up with a cover letter. Without objection, it was so ordered.

Further discussion ensued.

32. <u>VIRGINIA MUNICIPAL LEAGUE (VML) UPDATE ARTICLE</u> REGARDING CAR TAX GUIDELINES TO TAKE EFFECT JANUARY 1 (Tape 6)

Chairman Hanley distributed to the Board copies of an article regarding the car tax guidelines for local compliance in *Update*, the newsletter of the VML. She reminded the Board that members of the General Assembly had expressed concern that the car tax break was possibly being granted to a significant number of business vehicles that were ineligible. The State issued new guidelines to localities to ensure compliance with the law.

Accordingly, Chairman Hanley asked unanimous consent that the Board direct staff to report with any costs to the County of this compliance program. Without objection, it was so ordered.

33. MEMORANDUM REGARDING THE COST TO THE COUNTY FOR THE USE OF SCHOOLS FOR COMMUNITY AND RECREATION SERVICES (Tape 6)

Chairman Hanley called the Board's attention to a memorandum from the County Executive regarding the cost to the County for the use of schools for community and recreation services as requested by the Board on August 5, 2002.

Supervisor Connolly asked unanimous consent that the Board direct the County Executive to provide the Board with information regarding the charges to the School Division for schools and school facilities located on County land.

Following discussion, with input from Anthony H. Griffin, County Executive, the request was so ordered.

34. <u>LETTER FROM THE ALLIANCE FOR HUMAN SERVICES</u> REGARDING THE FEDERAL TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) PROGRAM (Tape 6)

Chairman Hanley called the Board's attention to a letter from the Fairfax County Alliance for Human Services regarding the reauthorization of the federal TANF program.

Following a brief discussion, Chairman Hanley asked unanimous consent that the Board refer this issue to the Legislative Committee, for the next meeting which is scheduled for October 11, 2002. Without objection, it was so ordered.

Supervisor Hudgins asked unanimous consent that the Board refer the housing trust fund issue to the Legislative Committee. Without objection, it was so ordered.

35. **DROUGHT UPDATE** (Tape 6)

Chairman Hanley noted that the Board had received a memorandum from the County Executive regarding the continuing drought in the Potomac River basis. A drought WATCH was issued in February 2002 and it encourages customers to use water wisely. A drought WARNING will be issued if the combined storage of the reservoirs falls to 60 percent capacity for five consecutive days. The WARNING would call for voluntary restrictions on water use.

Accordingly, Chairman Hanley asked unanimous consent that the Board direct staff to include a tag line on the website and on public communications to use water wisely. Without objection, it was so ordered.

Additional discussion ensued.

36. BOARD'S TRANSPORTATION COMMITTEE TO MEET OCTOBER 18 (Tape 6)

Chairman Hanley announced that the Board's Transportation Committee will meet October 18, 2002, from 2-4 p.m. in Conference Room 232. It will include a workshop on the Dulles Rail report, which is scheduled to be distributed at least a week prior to the meeting.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

Supervisor Mendelsohn announced that Shirley Long, Assistant Principal of Spring Hill Elementary School in McLean, has been selected as Virginia's 2002 Outstanding Elementary Assistant Principal of the Year by the Virginia Association of Elementary School Principals. She will receive this recognition at the September 26, 2002, Virginia Board of Education meeting in Richmond.

Supervisor Mendelsohn referred to his written Board Matter which outlined Ms. Long's accomplishments. He moved that the Board direct staff to invite Assistant Principal Long to appear before the Board, at a time to be determined, to be recognized and congratulated for this significant honor. Supervisor Bulova seconded the motion and it carried by a vote of nine, Supervisor Kauffman being out of the room.

38. NO BOARD MATTERS FOR SPRINGFIELD DISTRICT SUPERVISOR ELAINE McCONNELL (Tape 6)

Supervisor McConnell announced that she had no Board Matters to present today.

39. CROSSWALK AT THE INTERSECTION OF GLADE DRIVE AND SOAPSTONE DRIVE IN RESTON (HUNTER MILL DISTRICT) (Tape 6)

Supervisor Hudgins said that she has been working with the Department of Transportation (DOT) and the Virginia Department of Transportation (VDOT) to have a crosswalk striped at the intersection of Glade Drive and Soapstone Drive in Reston. She said that she was initially told that VDOT had to install a pedestrian receiving pad at the southwest corner of the intersection for a crosswalk to be striped. However, this is no longer possible because VDOT is allowing a utility box to be installed at the location of the pad. She noted that this demonstrates a lack of coordination with VDOT. Because of this, the community is held without a crosswalk at the location.

Therefore, Supervisor Hudgins moved that the Board direct DOT to:

- Request VDOT to stripe the crosswalk without the receiving pad as an initial solution.
- Work with the County Attorney's office on the Americans with Disabilities Act requirements for the installation of a pad.
- Encourage VDOT to install such a pad as a final solution at Glade Drive and Soapstone Drive.

Chairman Hanley seconded the motion.

Following a brief discussion, the question was called on the motion, which carried by a vote of nine, Supervisor Kauffman being out of the room.

40. PROPOSED AMENDMENT TO THE CODE OF THE COUNTY OF FAIRFAX TO PROHIBIT PARKING OF ALL VEHICLES ON THE SOUTH SIDE OF STEVENAGE ROAD (HUNTER MILL DISTRICT) (Tape 6)

Supervisor Hudgins referred to her written Board Matter which noted that for over two years there has been concern raised by the residents adjacent to Stevenage Road in Reston. Stevenage Road is zoned commercial on the south side and residential on the north side. The concern lies in the commercial vehicles that park overnight, leaving motors running during the night and trailers parked on the road for extended periods of time on the south side of Stevenage Road. The Hunter Mill District office has worked with the Department of Transportation and the Reston District Police Station to remedy the situation.

Supervisor Hudgins said that after many attempts to resolve the safety and aesthetic issues, on July 1, 2002, she introduced a Board Matter and the Board approved the installation of "No Parking" signs to be installed along the residential side of Stevenage Road. In addition to that action, Supervisor Hudgins requested staff to identify ways to prohibit parking on the south side of the road. After consulting with the commercial owners, she said that it appears that the best solution to the problem for residential and commercial communities is to prohibit parking on the south side of Stevenage Road through passage of an ordinance that would specifically address the prohibition of vehicles parking on the south side of Stevenage Road, regardless of the area's zoning.

Therefore, Supervisor Hudgins moved that the Board direct staff to schedule a public hearing to be held before the Board regarding the prohibition of the parking of all vehicles on the south side of Stevenage Road. If approved, this

would require an amendment to the Code of the County of Fairfax and the approval of the Commonwealth Transportation Board. Supervisor Bulova seconded the motion and it carried by unanimous vote.

(NOTE: Later in the meeting the Board discussed this issue further. See Clerk's Summary Item CL#42.)

41. **RESTON MULTICULTURAL FESTIVAL** (Tape 6)

Chairman Hanley noted that both she and Supervisor Hudgins attended the Reston Multicultural Festival on Saturday.

42. PROPOSED AMENDMENT TO THE CODE OF THE COUNTY OF FAIRFAX TO PROHIBIT PARKING OF ALL VEHICLES ON THE SOUTH SIDE OF STEVENAGE ROAD (Tape 6)

(NOTE: Earlier in the meeting the Board took action on this item. See Clerk's Summary Item CL#40.)

In reference to restricted parking where there is commercial zoning on one side of a street and residential zoning on the other side, discussion ensued with input from David P. Bobzien, County Attorney.

43. **PARK FESTIVAL (MASON DISTRICT)** (Tape 6)

Supervisor Gross distributed a flyer on the twenty-third annual Mason District Park Festival which will take place on Saturday, September 28, 2002, from 10 a.m. to 4 p.m. This festival is free of charge and includes entertainment, children's activities, public safety demonstrations, food, and crafters. She encouraged everyone to attend.

44. **NEWSLETTER (MASON DISTRICT)** (Tape 6)

Supervisor Gross distributed to the Board copies of the latest edition of *Mason Matters*, her district newsletter.

45. PINE SPRING COMMUNITY CELEBRATES ITS FIFTIETH ANNIVERSARY (PROVIDENCE DISTRICT) (Tape 7)

Supervisor Connolly announced that the Pine Spring community is celebrating its fiftieth anniversary this year.

Therefore, Supervisor Connolly moved that the Board direct staff to prepare a Certificate of Recognition to honor the anniversary and to invite leaders from the

Pine Spring community to appear before the Board at an appropriate time. Chairman Hanley seconded the motion and it carried by unanimous vote.

46. **INTENT TO DEFER PUBLIC HEARINGS** (Tape 7)

Supervisor Connolly announced his intent to:

- Indefinitely defer the public hearing regarding the leasing of a portion of County-owned property at Fairfax County Fire Station #29 at 1560 Spring Hill Road to Tysons Firehouse LLC.
- Defer the public hearing on Rezoning Application RZ 2002-PR-053 and Special Exception Application SE 2002-PR-018 until October 28, 2002.

47. <u>"RETT SYNDROME MONTH" IN FAIRFAX COUNTY</u> (Tape 7)

Supervisor Connolly said that Rett Syndrome is a rare neurological disorder that affects only females and is often misdiagnosed as autism or cerebral palsy. First recognized by the medical community in 1983, many doctors are still unfamiliar with Rett Syndrome, which occurs in one out of every 10,000 to 20,000 girls. More information about combating Rett Syndrome and contributing to a cure may be found through the Rett Syndrome Association at 1-800-818-RETT or the web site at www.rettsyndrome.org.

Therefore, Supervisor Connolly asked unanimous consent that the Board:

- Declare October as "Rett Syndrome Month" in Fairfax County.
- Direct the Office of Public Affairs to once again publicize information about this little known but devastating disease through a news release, the County's web site, and the Channel 16 bulletin board.

Without objection, it was so ordered.

48. <u>SCHEDULING OF A PUBLIC HEARING FOR SPECIAL EXCEPTION</u> <u>APPLICATION SE 2001-PR-017 (PROVIDENCE DISTRICT)</u> (Tape 7)

Supervisor Connolly said that Capital One is nearing the completion of the Phase I building of its office park headquarters in Tysons Corner with plans to begin occupying the building on October 15, 2002. Phased move-ins will be occurring over the next few months until the building is at full occupancy.

Therefore, Supervisor Connolly moved that the Board direct staff to schedule a public hearing to be held before the Board on October 28, 2002, for Special

Exception Application SE 2001-PR-017. Supervisor Bulova seconded the motion.

Following discussion, Supervisor Connolly amended the motion to direct staff to schedule the public hearing for November 18, 2002, instead of October 28, and this was accepted. The question was called on the motion, as amended, and it carried by unanimous vote.

49. **MEALS ON WHEELS PROGRAM** (Tape 7)

Supervisor Connolly said that the Meals on Wheels program delivers meals to homebound older adults in the County. He noted that the Meals on Wheels program is experiencing difficulty filling several key volunteer positions including the volunteer group coordinator, volunteer driver-coordinator and volunteer drivers. Volunteers are urgently needed in the Fairfax City area. Interested citizens can call the Area Agency on Aging at 703-324-5846 or 703-324-5406 for more information or to volunteer.

Therefore, Supervisor Connolly moved that the Board direct staff to publicize the need for volunteers as appropriate. Supervisor Hyland seconded the motion and it carried by unanimous vote.

50. WHO WILL MATCH THIS? (Tape 7)

Supervisor Connolly said that September 11, 2002, marked the beginning of an increased understanding of the complexity of fire fighting as well as the dangers faced by the brave men and women of public safety. One of the best ways to reduce the risks is to enhance training opportunities.

Supervisor Connolly announced that the Stanley Martin companies responded to his request for the use of a house slated for demolition. A house on Lee Highway will be available to Public Safety for training for six weeks next spring. The extended period of time for training is important because it allows for critiquing and then a return to the property for additional exercises. There has been a concern in the past that some properties are too close to trees or other homes to allow for safe burning. The house on Lee Highway will not be burned, but it will be put to excellent use for training.

Supervisor Connolly challenged Board Members to match this house and raise him one or more. He moved that the Board direct staff to invite a representative from the Stanley Martin companies and all other developers and citizens who have made properties for training available for Fairfax County Public Safety to appear before the Board at the meeting closest to September 11, 2003, to be recognized for their contributions as well as their partnership with public safety. Supervisor Gross seconded the motion and it carried by unanimous vote.

51. **SHOWMOBILE UPGRADES** (Tape 7)

Supervisor Connolly said this year's Nottoway Nights concert series in the Providence District enjoyed unprecedented attendance and excellent weather. All attendance records were broken with an estimated 2000 residents gathering to hear the Seldom Scene in July and averaged 450 concert-goers weekly. Sponsorship from the business community grew so that, once again, residents enjoyed this popular Thursday night event - after only three years, a Providence community tradition - completely free of cost. John Hopkins, Nottoway Park Manager; Joanne Malone, Providence District's outstanding Park Authority representative; Sousan Frankenberger; and the dedicated Friends of Nottoway Nights volunteer committee, provided enthusiastic volunteers every week and a beautiful setting on the lawn of Hunter House. The single sour note all summer was the inadequate sound system of the Showmobile.

Supervisor Connolly said that the current sound system is functional at best for some performances. When a group features more than a couple of vocalists or musicians, the showmobile sound system was poor and at times non-existent. He said that it was his understanding that the lack of "area" microphones, a shortage of traditional microphones, low quality speakers, and the fact that there are no monitors for the musicians are all part of the problem. While the County has two showmobiles, only one is used for concerts. The second unit is adequate for the many other types of events the community uses it for.

Therefore, Supervisor Connolly moved that the Board direct staff to investigate what upgrades are needed to correct the sound system of the concert showmobile and report its findings as to the cost of these improvements and how they can best be funded. Supervisor Bulova seconded the motion.

Following discussion, Supervisor Gross asked to amend the motion to direct staff to determine the feasibility of obtaining another truck to haul the second showmobile, and this was accepted.

The question was called on the motion, as amended, and it carried by unanimous vote.

52. **NEWSLETTER (BRADDOCK DISTRICT)** (Tape 7)

Supervisor Bulova distributed copies of the fall issue of her district newsletter, the *Braddock Byline* which contains information about the fall town meeting which will be on the subject of homeland security in "your" neighborhood.

Supervisor Frey announced that he had no Board Matters to present today.

Supervisor Kauffman announced that he had no Board Matters to present today.
