The meeting was called to order at 9 a.m., with all Members being present, with the exception of Supervisor Connolly and with Chairman Hanley presiding.

Supervisor Connolly arrived at 9:05 a.m.

### **BOARD MATTER**

#### 1. **MOMENT OF SILENCE** (Tape 1)

Chairman Hanley asked everyone to remember in thoughts and prayers all of those who are being called up and away to serve their country and to also remember their families.

Supervisor Gross asked everyone to remember in thoughts and prayers Mrs. Helen Langford, a wonderful volunteer in Mason District, who was the head of the Friends of the George Mason Regional Library and was very active in the Annandale Christian Community for Action.

### 2. **ORDERS OF THE DAY** (Tape 1)

Chairman Hanley announced that there would be a change in the Orders of the Day and that the Board would proceed with the Certificate of Recognition presented to Major Audrey Slyman.

### 3. <u>CERTIFICATE OF RECOGNITION PRESENTED TO MAJOR AUDREY SLYMAN</u> (Tape 1)

Supervisor McConnell moved approval of the Certificate of Recognition presented to Major Audrey Slyman for more than 28 years with the Fairfax County Police Department. Supervisor Hyland seconded the motion and it carried by unanimous vote.

### 4. <u>CERTIFICATES OF RECOGNITION PRESENTED TO THE MEN'S</u> FIREFIGHTER COMBAT CHALLENGE TEAM (Tape 1)

Supervisor Connolly moved approval of the Certificates of Recognition presented to the members of the men's Firefighter Combat Challenge Team for their achievement in besting 640 competitors representing 150 fire departments from 42 states, provinces, and Europeans Air Force bases to place fifth in the 2002 World Championships held in Deerfield Beach, Florida and Soza and Company, the team's sponsor. Vice-Chairman Hyland returned the gavel to Chairman Hanley.

taxpayers who are otherwise current in their tax and parking ticket obligations to the County. Supervisor Bulova seconded the motion.

Discussion ensued with input from Kevin C. Greenlief, Director, Department of Tax Administration, and Anthony H. Griffin, County Executive.

Supervisor Connolly asked to amend the motion to direct staff to:

- Provide a one-year status review to the Board.
- Provide the Policy for reaffirmation in two years.
- Include information on other jurisdictions that have abolished the use of decals as well as other options regarding decals in the review.

Following further discussion, with input from Mr. Greenlief, the question was called on the motion, as amended, which carried by unanimous vote.

### 15. <u>A-2 – MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE</u> <u>COUNTY AND CELEBRATE FAIRFAX, INCORPORATED</u> (Tape 2)

(BACs) On motion of Supervisor Bulova, seconded by Supervisor Connolly, and carried by unanimous vote, the Board concurred in the recommendation of staff and approved the MOU that continues the relationship between Celebrate Fairfax, Incorporated, and the County.

### 16. A-3 – SALE OF GENERAL OBLIGATION REFUNDING BONDS, SERIES 2003A (Tape 2)

(Bonds) Supervisor Hyland moved that the Board concur in the recommendation of staff and:

- Adopt a Resolution authorizing the sale of General Obligation Refunding Bonds on or about February 6, 2003.
- Approve the form of the Escrow Deposit Agreement for the General Obligation Refunding Bonds.

Following discussion, with input from Leonard P. Wales, Assistant Director, Department of Management and Budget, Supervisor Connolly seconded the motion and it carried by unanimous vote, Supervisor Bulova, Supervisor Connolly, Supervisor Frey, Supervisor Gross, Supervisor Hudgins, Supervisor Hyland, Supervisor Kauffman, Supervisor McConnell, Supervisor Mendelsohn, and Chairman Hanley voting "AYE."

### 17. A-4 – AMENDED PARKING REDUCTION FOR FAIRFAX CORNER TOWN CENTER (SPRINGFIELD DISTRICT) (Tape 2)

On motion of Supervisor McConnell, seconded by Supervisor Hyland, and carried by unanimous vote, the Board concurred in the recommendation of staff and approved a parking reduction of 20.8 percent for Phase IB of the Fairfax Corner Town Center and a 24.7 percent reduction of the required on-site parking at the completion of the entire development, pursuant to Paragraph 4(B), Section 11-102 of the Code of the County of Fairfax, Chapter 112 (Zoning Ordinance), based on the Board's prior approval of a parking reduction for this site subject to the conditions outlined in the Board Agenda Item dated January 6, 2003.

A-5 – APPROVAL OF A COOPERATIVE AGREEMENT BETWEEN CHILDHELP **USA** CHILDREN'S **CENTER** OF **VIRGINIA** FAIRFAX COUNTY POLICE DEPARTMENT (FCPD), FAIRFAX COUNTY **DEPARTMENT OF FAMILY SERVICES** (DFS), FAIRFAX/FALLS CHURCH COMMUNITY SERVICES BOARD (CSB), OFFICE OF THE COMMONWEALTH'S ATTORNEY OF FAIRFAX COUNTY, INOVA FAIRFAX HOSPITAL FOR CHILDREN, AND HISPANICS AGAINST CHILD ABUSE AND NEGLECT (HACAN) (Tape 2)

On joint motion of Supervisor Connolly and Supervisor Gross, seconded by Supervisor Hyland, and carried by unanimous vote, the Board concurred in the recommendation of staff and authorized the signing of a cooperative agreement between the FCPD, DFS, CSB, Office of the Commonwealth's Attorney of Fairfax County, ChildHelp USA Children's Center of Virginia, INOVA Fairfax Hospital for Children, and HACAN.

### 19. <u>A-6 – BOARD POSITION OF PROPOSED AMENDMENTS TO THE</u> BUILDING CODE (Tape 2)

Supervisor Hyland moved that the Board concur in the recommendation of staff and approve the sending of the draft letter, signed by the Chairman, requesting the Virginia Board of Housing and Community Development (BHCD) action on the proposed amendments to the Virginia Uniform Statewide Building Code. Supervisor Connolly seconded the motion.

Discussion ensued with input from Zofia A. Zager, Director, Office of Building Code Services, Department of Public Works and Environmental Services.

Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and asked unanimous consent that the Board direct staff to send the entire history of the issues to the new members of the BHCD. Without objection, it was so ordered.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

Following further discussion with input from Ms. Zager, Supervisor Gross asked unanimous consent that the Board direct staff to change the nature of the letter to more strongly reflect the requests of the Board. Without objection, it was so ordered.

Supervisor Frey asked unanimous consent that the Board direct staff to provide a current list of the members of the BHCD. Without objection, it was so ordered.

The question was called on the motion and it carried by unanimous vote.

# 20. A-7 - BOARD ACTION TO APPROVE A MEMORANDUM OF AGREEMENT WITH THE RESTON ASSOCIATION TO UTILIZE CERTAIN PROPERTY FOR THE ESTABLISHMENT OF A SOUTHGATE COMMUNITY CENTER (Tape 2)

Supervisor Hudgins moved that the Board concur in the recommendation of staff and approve the Memorandum of Agreement concerning the establishment and operation of a new community center in the Reston area to be called the Southgate Community Center. Chairman Hanley seconded the motion.

Following discussion, the question was called on the motion and it carried by a vote of nine, Supervisor Frey being out of the room.

The Board next considered an item contained in the Board Agenda dated January 6, 2003, requesting authorization for staff to award a contract to Berry Paving and Concrete Construction Company, Incorporated, in the amount of \$329,734 for the extension of the existing stream valley trail as part of Project W00100, Braddock District Walkways, Detail W1050, Long Branch Stream Valley Park, in Fund 307, Sidewalk Construction.

The staff was directed administratively to proceed as proposed.

# 26. I-6 – APPROVAL OF REIMBURSEMENT AGREEMENTS FOR THE OPERATION AND MAINTENANCE OF ACORN STREET LIGHTING FIXTURES ON DECORATIVE FLUTED FIBERGLASS POLES IN THE TOWN OF VIENNA COMMERCIAL REVITALIZATION AREA, MAPLE AVENUE PHASE II AND III (HUNTER MILL DISTRICT) (Tape 2)

The Board next considered an item contained in the Board Agenda dated January 6, 2003, requesting authorization for staff to execute the:

- Reimbursement Agreements between the Town of Vienna and the County
- Agreements for the Purchase of Electricity between Dominion Virginia Power and the County

for the operation and maintenance of acorn street lighting fixtures on decorative fluted fiberglass poles in the Vienna Commercial Revitalization Area,

Maple Avenue, Phase II and III.

The staff was directed administratively to proceed as proposed.

### 27. <u>I-7 – DEVELOPMENT AND IMPLEMENTATION OF A FAIRFAX COUNTY CITIZEN CORPS COUNCIL</u> (Tape 2)

The Board next considered an item contained in the Board Agenda dated January 6, 2003, requesting authorization for staff to continue with the development of a Citizen Corps Council. The group will work with the Emergency Management Coordinating Committee to consider and invite additional, appropriate members as needed and to develop a charter consistent with its intended purpose, the needs of the County, and an integrated approach. Once these activities are completed, the Council will be formally established by the County Executive.

Following discussion, the staff was directed administratively to proceed as proposed.

## 28. <u>I-8 - CONTRACT AWARD - CONSULTING SERVICES FOR DEVELOPMENT OF A SOLID WASTE MANAGEMENT PLAN</u> (Tapes 2-3)

The Board next considered an item contained in the Board Agenda dated January 6, 2003, requesting authorization to award a contract to Logistics Management Institute in an amount not to exceed \$321,467 over two years for the provision of consultant services for a contractor to work with County staff to identify current and future solid waste capacity requirements for commercial and residential needs of Fairfax County.

Discussion ensued with input from Joyce M. Doughty, Director, Division of Solid Waste, Disposal and Resource Recovery, Department of Public Works and Environmental Services.

Supervisor Hyland asked unanimous consent that the Board direct staff to provide a timeline for the work to be performed by the consultant. Following input from Ms. Doughty, without objection, it was so ordered.

The staff was directed administratively to proceed as proposed.

### **ADDITIONAL BOARD MATTERS**

### 29. **NBC4 HEALTH AND FITNESS WEEKEND** (Tape 4)

Chairman Hanley announced that the tenth annual NBC4 Health and Fitness Expo will take place at the Washington Convention Center on January 18 and 19, 2003. To mark the milestone regional exposition, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and moved that the Board direct staff to prepare and send a proclamation declaring January 18 and 19, 2003, as "NBC4 Health and Fitness Weekend" in Fairfax County. Supervisor McConnell seconded the motion, which carried by a vote of nine, Supervisor Connolly being out of the room.

### 30. **AFRICAN AMERICAN HISTORY MONTH** (Tape 4)

Chairman Hanley said that the month of February is nationally recognized as African American History Month. In conjunction with federal observances, the Office of Equity Programs requested the County to observe February as African American History Month.

Accordingly, Chairman Hanley moved that the Board direct staff to invite representatives from the African American community and the Office of Equity Programs to appear before the Board at January 27, 2003, meeting to receive a proclamation declaring February as "African American Month" in Fairfax County. Supervisor McConnell seconded the motion, which carried by a vote of nine, Supervisor Connolly being out of the room.

### 31. **CHILD ABUSE PREVENTION MONTH** (Tape 4)

Chairman Hanley stated that the Advisory Social Services Board requested that the County recognize April as Child Abuse Prevention Month. Accordingly, she moved that the Board direct staff to invite representatives from the Advisory Social Services Board to appear before the Board at the March 24, 2003, meeting to receive a proclamation declaring April as "Child Abuse Prevention Month" in Fairfax County. Supervisor McConnell seconded the motion, which carried by unanimous vote.

### 32. **NATIONAL INFANT IMMUNIZATION MONTH** (Tape 4)

Chairman Hanley announced that the month of April is National Infant Immunization Month. While the County has an 80 percent compliance rate for this important area of public health, as a commitment to all children, the Board needs to encourage all County residents to take advantage of timely childhood immunizations.

Therefore, Chairman Hanley moved that the Board direct staff to invite representatives from the Health Department and the Health Care Advisory Board to appear before the Board on April 7, 2003, to receive a proclamation declaring April as "Immunization Month" in Fairfax County. Supervisor McConnell seconded the motion, which carried by unanimous vote.

### 33. **CLEAN AIR EFFORTS** (Tape 4)

Chairman Hanley stated that reducing pollution has become a top priority for jurisdictions in the Eastern United States, including Fairfax County, through the Metropolitan Washington Air Quality Committee (MWAQC), that face federal deadlines for reducing ozone and smog. These pollutants are caused in part by transport from older coal-fired plants located primarily in the midwestern states, including one owned by Pepco in West Virginia.

Chairman Hanley said that on Tuesday, December 31, 2002, nine northeastern states (Connecticut, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Rhode Island, and Vermont) filed suit challenging the Administration's decision to relax national industrial pollution restrictions for the first time since enactment of the Clean Air Act in 1970.

Chairman Hanley noted that the Board has been proactive in:

- Supporting State legislation (Board action 8/6/01).
- Asking the Board's Legislative Committee to address the issue of the Board supporting federal legislation that would end the grandfathering of coal-fired plants (Board action 9/10/02).
- Directing the Chairman to sign a letter in support of such legislation (HR 1256) to the Virginia Congressional delegation and asking that members agree to co-sponsor and support the legislation (Board action 10/1/02).

Chairman Hanley said that Virginia does not appear to be among the states that have joined the suit despite the fact that the Washington metropolitan area is in serious, now severe, non-attainment for high levels of air pollutants.

Accordingly, Chairman Hanley moved that the Board direct staff to send a letter to Governor Mark Warner, copied to the Congressional Delegation, reiterating Board support for stronger action against coal-fired power plants that pollute the County's air and asking that Virginia join the suit. Supervisor Bulova and Supervisor McConnell jointly seconded the motion.

Following discussion, the question was called on the motion, which carried by unanimous vote.

Chairman Hanley noted that January 2004 is the deadline for a new state implementation plan for air and therefore, a new constrained long range plan that will be in conformance with it.

With reference to a mobile model regarding the mix of on road vehicles that was presented to members of the MWAQC which Chairman Hanley cited, Supervisor Mendelsohn asked consent that the Board direct staff to provide copies of it to all Members of the Board. Without objection, it was so ordered.

Following discussion, with input from Anthony H. Griffin, County Executive, and James Gorby, Director, Department of Vehicle Services, Chairman Hanley asked unanimous consent that the Board direct staff to provide information as to the effect on the County's fleet as well as other fleets of the proposed closure of compressed natural gas fueling stations by Washington Gas.

Supervisor Connolly asked to amend the motion to direct staff also to request from Washington Gas its rationale for the phase out as well as its assessment of the effect on the region.

Without objection, the request, as amended, was so ordered.

Chairman Hanley called the Board's attention to a memorandum to the TPB Technical Committee regarding a vehicle fleet inventory for public sector agencies. She noted that she offered the County as a test case for using the form.

Accordingly, Chairman Hanley asked unanimous consent that the Board direct staff to complete the form expeditiously. Without objection, it was so ordered.

### 34. <u>UNDERGROUND UTILITY FACILITIES</u> (Tape 4)

Chairman Hanley stated that to protect underground utility facilities in Northern Virginia, the Miss Utility Program coordinates proposed excavation locations to prevent damage. Currently a call center operating in the metropolitan area notifies all stakeholders of the pending excavations.

Chairman Hanley said that it had been called to her attention that as of July 1, 2003, the notification structure now in place will be altered and local calls will be answered in Roanoke through a central call center for all of Virginia. To support the essential level of service needed to maintain the highest level of public safety and the least economic disruption for area ratepayers, she moved that the Board direct staff to evaluate the proposed changes and to make a recommendation to the Board as to whether the County should prepare testimony on behalf of County ratepayers. Supervisor Gross seconded the motion and discussion ensued.

In regard to the financing of the new call center, Chairman Hanley clarified that the motion included an evaluation of all aspects of the proposed changes.

The question was called on the motion, as clarified, which carried by a vote of eight, Supervisor Bulova and Supervisor Mendelsohn being out of the room.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

### 35. MOUNT VERNON DISTRICT'S SIXTEENTH ANNUAL TOWN MEETING (Tape 4)

Supervisor Hyland announced that the Mount Vernon District's Sixteenth Annual Town Meeting will be held Saturday, January 25, 2003, from 8 a.m. to 1 p.m. at Mount Vernon High School's Little Theatre Auditorium, 8515 Old Mount Vernon Road. He announced that refreshments would be served during the first hour and that participants could view the many exhibits provided by County agencies and nonprofit groups. He invited everyone to attend.

# 36. EXPEDITED PROCESSING FOR PROFFERED CONDITION AMENDMENT APPLICATION PCA 85-V-151 (MOUNT VERNON DISTRICT) (Tape 4)

Supervisor Hyland stated that he was formally asked by a representative of the applicant, Del-Ray Glass, to request that the Board grant expedited processing for Proffered Condition Amendment Application PCA 85-V-151. He noted that since the property in question is within the Richmond Highway Commercial Revitalization District, it may already be qualified for expedited review.

Accordingly, Supervisor Hyland moved that the Board direct staff to grant expedited processing for Proffered Condition Amendment Application PCA 85-V-151. He noted that this motion does not relieve the applicant from complying with the provisions of any applicable ordinances, regulations, or adopted standards and does not prejudice the consideration of the land use application in any way. Supervisor Connolly seconded the motion, which carried by a vote of eight, Supervisor Bulova and Supervisor Mendelsohn being out of the room.

### 37. <u>CONSIDERATION OF SPLIT SHIFTS FOR ELECTIONS OFFICERS</u> (Tape 4)

Supervisor Hyland stated that he received a request from a constituent, Mr. Tom Fina, asking the Board to consider split shifts for elections officers. The League of Women Voters, at the 1998 General Assembly session, requested and received enabling legislation to permit localities throughout the state to experiment with split shifts for election poll workers. He distributed an article

that pinpoints the reason split shifts are being requested in Virginia, specifically the difficulties in recruiting because of long hours and generally token pay.

Accordingly, Supervisor Hyland asked unanimous consent that the Board refer this matter to staff for further review and recommendations. Without objection, it was so ordered.

# 38. MOUNT VERNON COUNCIL RESOLUTION REQUESTING TRAFFIC COURT AT THE SOUTH COUNTY CENTER (MOUNT VERNON DISTRICT) (Tape 4)

Supervisor Hyland distributed to the Board copies of a letter and formal resolution from the Mount Vernon Council requesting that the Board direct the County Executive to develop and implement a plan in conjunction with the Chief Judge, Sheriff, and Police Department to establish and operate a satellite traffic court in the South County Center. He noted that Supervisor Kauffman raised this issue in the past. The council believes that the request is justified because of the long distance citizens and police must travel to testify at Traffic Court. This is time consuming for the citizen and hampers the Police Department's efficiency.

Accordingly, Supervisor Hyland asked unanimous consent that this matter be referred to the County Executive for review and an official recommendation. Without objection, it was so ordered.

### 39. <u>CLARIFICATION OF NEWSPAPER ARTICLE (SPRINGFIELD DISTRICT)</u> (Tape 4)

Supervisor McConnell called the Board's attention to an article in the January 6, 2003, edition of *The Washington Post* regarding a store in Clifton. She clarified that she will do whatever it takes to protect her name against "all accusations of doing illegal things."

### 40. <u>LEGISLATIVE ACTION REGARDING A CAP ON REAL ESTATE</u> TAXES (Tape 4)

Supervisor Mendelsohn asked unanimous consent that the Board direct staff to provide copies of bills regarding a five percent cap on real estate taxes. Without objection, it was so ordered. Chairman Hanley stated that they would be provided at the Board's Legislative Committee meeting.

Supervisor Connolly asked unanimous consent that the Board direct staff to prepare documentation on the economic consequences of those proposed bills for distribution at the Board's Legislative Committee meeting on Friday, January 17, 2003. Without objection, it was so ordered.

A brief discussion ensued.

### 41. **2003 COMMUNITIES THAT CARE YOUTH SURVEY** (Tape 4)

Supervisor Mendelsohn raised the issue of the 2003 Communities that Care Youth Survey and the issue of the addition of sexual risk behavior questions. He asked unanimous consent that the Board direct staff to provide for Board review on January 27, 2003, the proposed survey as well as the previous survey administered in 2001 and its history. Without objection, it was so ordered.

An extensive discussion ensued.

# 42. REQUEST TO WAIVE THE FILING FEES FOR THE EXPANSION OF THE ROBINSON SECONDARY SCHOOL RESIDENTIAL PERMIT PARKING DISTRICT (RPPD) (BRADDOCK DISTRICT) (Tape 5)

Supervisor Bulova said that student parking on residential streets around Robinson Secondary School continues to be a serious problem and expansion of the Robinson RPPD is needed. Consequently, she forwarded to the Department of Transportation (DOT) a petition for the expansion of the Robinson RPPD on Concordia Street from Gadsen Drive to Holden Street. To proceed with the request, DOT needs Board approval to waive the filing fees.

Therefore, Supervisor Bulova moved that the Board direct staff to waive the fees and to proceed as expeditiously as possible. Supervisor Connolly seconded the motion, which carried by a vote of nine, Supervisor McConnell being out of the room.

# 43. RECOGNITION OF FOREST EDGE ELEMENTARY SCHOOL AND SIEMENS ENTERPRISE NETWORKS (HUNTER MILL DISTRICT) (Tape 5)

Supervisor Hudgins announced that Forest Edge Elementary School and Siemens Enterprise Networks have been recognized for their successful partnership with the Siemens Caring Hands Foundation Community Excellence 2002 Chairman's Award, which provides a \$5,000 donation to Forest Edge Elementary School. The two have been partners since 1991 and have benefited hundreds of Forest Edge Elementary School students.

Supervisor Hudgins moved that the Board direct staff to invite representatives of both Forest Edge Elementary School and Siemens to appear before the Board for recognition of their outstanding contributions. Chairman Hanley seconded the motion, which carried by a vote of nine, Supervisor McConnell being out of the room.

### 44. NATIONAL LAW ENFORCEMENT OFFICE MEMORIAL FUND CALENDAR (Tape 6)

Supervisor Gross said that the National Law Enforcement Officer Memorial Fund Calendar commemorates the nearly 16,000 law enforcement officers who have been killed in the line of duty all across the country. The Commonwealth of Virginia is ranked eighteenth in the number of fallen officers. In 2001, there were 230 officers killed, including 72 who died in the September 11 terrorist attacks, the deadliest day in law enforcement history.

Supervisor Gross noted that "Living Legends" are highlighted on each page. The June 2003 calendar page pays tribute to Virginia's Lieutenant Brian Boykin, Assistant Commander of the Mason District Police Station. Lieutenant Boykin has served Fairfax County since 1986, and has developed nationally recognized community policing programs, such as the Survival Techniques and Education for Youth program. A firm believer of the motto, "if you are not part of the solution, you are part of the problem," Lieutenant Boykin developed a nationally recognized program for improved community police relations while on assignment to the National Organization of Black Enforcement Executives. He is a founder of the Fairfax County Black Law Enforcement Officers' Association and serves on a national task force with the United States Attorney's Office which oversees and develops training programs to eradicate racial profiling in law enforcement.

# 45. ARTICLE FROM PUBLIC MANAGEMENT MAGAZINE ENTITLED "THE PRIVATE SECTOR COULD TAKE A LEAF FROM OUR BOOK" (Tape 6)

Supervisor Gross said last year the County of Fairfax earned an A<sup>-</sup> for being the best managed county in the nation. She noted that an article from the December 2002 edition of *Public Management* magazine entitled "The Private Sector Could Take a Leaf From Our Book," discusses public versus corporate management after the revelations of Enron and WorldCom Corporations, among others.

Supervisor Connolly noted that the County received the highest grade accorded any of the 40 counties in the US.

A brief discussion ensued with input from Anthony H. Griffin, County Executive.

### 46. <u>CERTIFICATE OF RECOGNITION FOR MS. SANDRA CHISHOLM</u> (LEE DISTRICT) (Tape 6)

Supervisor Kauffman stated that he attended a bi-district meeting of the United Methodist Church where a \$1 million grant was awarded from the United Methodist Church's Commission on Relief that will benefit a number of faith-based service providers in the Northern Virginia area.

Supervisor Kauffman noted that Sandra Chisholm, Faith Liaison, provided the data necessary to complete the grant application.

Therefore, Supervisor Kauffman asked unanimous consent that the Board direct staff to invite Ms. Chisholm to appear before the Board to recognized for her efforts. Without objection, it was so ordered.

A brief discussion ensued.

### 47. **BUDGET IMPLICATIONS FROM THE STATE** (Tape 6)

Supervisor Connolly distributed to Board Members a document entitled "State Allocation Change from Previous Fiscal Year (in millions \$)" and noted that the combination of estimated State reductions and the impact on the County and cumulatively from Fiscal Year (FY) 2002 - FY 2004 is \$46.666 million of revenue that the County was receiving and will not be receiving from the State.

Supervisor Connolly announced that the Legislative Committee will be meeting every week starting January 17, 2003, at 4 p.m.

A brief discussion ensued with input from Anthony H. Griffin, County Executive.

Chairman Hanley raised the issue of the proposal to allow, require, deputize, recruit, or draft local treasurers and Commissioners of Revenue to be Department of Motor Vehicle agents.

A brief discussion ensued.

### 48. **ADOPT-A-FAMILY PICK-UP SITES** (Tape 6)

Supervisor Connolly said that every year his office, along with many others in the County, participates in the annual Adopt-a-Family program sponsored by the Office of Partnerships. The Adopt-a-Family Program was established in 1988 to help working low-income families provide special holidays. The program typically serves over 300 families during the holiday season.

Supervisor Connolly noted that in previous years the pick-up location for the families has been the Government Center but recently, due to security concerns

regarding wrapped packages, the location was moved to Heritage Fellowship United Church of Christ in Reston. He expressed his concern that low-income residents, many of whom depend on public transportation from areas such as Falls Church, Baileys Crossroads, Route One, and other locations have difficulty traveling to Reston and transporting their gifts home to their families.

Therefore, Supervisor Connolly moved that the Board direct the Office of Partnerships to review this issue of arranging additional sites to allow better access for constituents. Supervisor Gross seconded the motion and it carried by a vote of nine, Supervisor McConnell being out of the room.

### 49. <u>INFORMATION TECHNOLOGY RECYCLING DAY SCHEDULED</u> (Tape 6)

Supervisor Connolly noted that if residents' New Year's resolutions include cleaning out old obsolete computer equipment, then they should mark their calendars for Saturday, January 11, when EcoStewards Alliance, KeepItGreen, and the Burke Presbyterian Church will co-sponsor a computer recycling day. Old computer components can be dropped off at the church parking lot at 5690 Oak Leather Drive in Burke, between 9 a.m. and 2 p.m. There is a \$7 charge for all monitors, to defer the cost of refurbishing, but all other equipment is free. Donations, which are tax deductible, will go to support services for disabled residents. Sponsors invite everyone to enjoy a complimentary cup of hot chocolate while there. Participants should make a list of each donated item with its fair-market value to keep for tax deduction purposes. KeepItGreen recommends looking on the ebay website or checking other sources for current selling prices of used equipment.

#### 50. **SULLY PLANTATION (SULLY DISTRICT)** (Tape 6)

#### (R) Supervisor Frey moved adoption of the following Resolution:

Whereas Sully, the 1794 home of Northern Virginia's first Congressman Richard Bland Lee and a Fairfax County historical treasure, was saved by Act of Congress in 1959 from demolition during construction of Washington Dulles International Airport;

And whereas, pursuant to the same Act of Congress title to the buildings known as "Sully" was transferred to the Fairfax County Park Authority by the federal government so the Park Authority could preserve and protect Sully, and display Sully to the public as a part of the history of Fairfax County and our nation;

And whereas, Sully is one of the most significant historic sites in Fairfax County and is visited by tens of thousands of visitors yearly who are able to tour a notable example of Federal period architecture and experience how Sully's residents lived in the eighteenth century;

And whereas, under the stewardship of the Fairfax County Park Authority, Sully has been added to the National Register of Historic Places and became one of the first county museums in the United States to achieve prestigious accreditation by the American Association of Museums;

And whereas, the land for Sully and approximately 68 acres of vacant adjacent airport property are owned by the Federal Aviation Administration and have been severed from the airport by the expansion of Route 28 and its evolution into a limited access highway;

And whereas, development of the airport property adjacent to Sully for airport purposes could result in significant adverse consequences relative to the Fairfax County Park Authority's preservation and protection of Sully, as well as its ability to present Sully to the public;

And whereas, extensive archaeological research conducted by the Fairfax County Park Authority and supported by the Sully Foundation has located many additional cultural resources on the land occupied by Sully and the adjacent airport land, including research to support accurate reconstruction of long-demolished Sully farm and slave quarter structures on both properties;

And whereas, the opening of the Air and Space Museum on the west side of Route 28 from Sully is expected to greatly expand the visitation to Sully and require additional facilities to meet public demand;

And whereas, the current construction of the Route 28/Barnsfield Interchange requires relocating the entrance to Sully, which should be completed with minimum impact on Sully's cultural resources, and could seriously impact cultural resources if the airport property adjacent to Sully on the east side of Route 28 is used for airport purposes;

Now therefore be it resolved that the Board of Supervisors endorses all efforts to transfer the approximately 100 acres of Federal Aviation Administration land on the east side of Route 28 to the Fairfax County Park Authority to ensure protection of these priceless resources and the enjoyment of Fairfax County citizens and visitors in perpetuity.

Supervisor Connolly seconded the motion.

Following discussion, the question was called on the motion and it carried by a recorded vote of nine, Supervisor Bulova, Supervisor Connolly, Supervisor Frey, Supervisor Gross, Supervisor Hudgins, Supervisor Hyland, Supervisor Kauffman, Supervisor Mendelsohn, and Chairman Hanley voting "AYE," Supervisor McConnell being out of the room.

### 51. **RECESS/CLOSED SESSION** (Tape 6)

Supervisor Bulova asked to amend the motion to include staff's amendment to the ESRC proposal outlined as Attachment C in the Board Agenda Item dated January 6, 2003, along with Attachment A. Supervisor Hudgins seconded the amendment.

Following discussion with input from Ms. Leavitt, Mr. Ormsby, and Mr. St. Clair, and speaker number four, Dana Eddy, Chairman, ESRC, Supervisor Bulova moved a substitute motion to table, and refer Attachments A and C to the ESRC. Supervisor Hudgins seconded the motion and it **FAILED** by a recorded vote of seven, Supervisor Bulova and Supervisor Hudgins voting "AYE," Supervisor Hyland being out of the room.

The question was called on Supervisor Bulova's amendment to include Attachment C, along with Attachment A and it **FAILED** by a recorded vote of

seven, Supervisor Bulova and Supervisor Hudgins voting "AYE," Supervisor Hyland being out of the room.

Supervisor Mendelsohn amended his main motion to adopt the proposed amendments to the PFM as recommended by the ESRC and outlined as Attachment A, and refer Attachment C to the ESRC for review and recommendation, and this was accepted.

Following discussion, the question was called on the main motion, as amended, and it <u>CARRIED</u> by a recorded vote of eight, Supervisor Connolly, Supervisor Frey, Supervisor Gross, Supervisor Hudgins, Supervisor Kauffman, Supervisor McConnell, Supervisor Mendelsohn, and Chairman Hanley voting "AYE," Supervisor Bulova voting "NAY," Supervisor Hyland being out of the room.
