  He was Secretary Anne Holton's father and Senator Tim Kaine's father-inlaw. He was also a true statesman who fought for civil rights and helped
  reshape Virginia politics, leading by example in integrating Virginia's
  schools
- John "JR" Rutherford, who passed away last month. He was a Park Authority archeologist with the County for more than 20 years and was involved in building and maintaining GIS databases and maps; was the cultural resource representative on many park master plan teams, including large scale projects such as Laurel Hill and Sully Woodlands; and was also a major author and implementor of the Cultural Resources Management Plan.
- Bernice Colvard, who passed away recently. She was a longtime historian for the League of Women Voters. She captured the history of women in elected office and was a long-time resource for information on voting, suffrage, and all matters that occurred at the workhouse.
- Melvin Cotner, who passed away earlier this month. He was Lord Fairfax for the Mason District in 2018 at the age of 90; participated in the Falls Church Community Service Council, the Seven Corners Children's Center, and was a charter member of the Human Services Council.
- Johnny Artis, who passed away earlier this month. He was a local music legend who regularly performed at local venues including Fairfax County's various concert series.

# 8. <u>CERTIFICATE OF RECOGNITION REQUEST FOR THE FRANCONIA MUSEUM</u> (10:42 a.m.)

Chairman McKay relinquished the Chair to Vice-Chairman Gross and jointly, with Supervisor Lusk, asked unanimous consent that the Board direct staff to prepare a Certificate of Recognition for the Franconia Museum in celebration of its 20<sup>th</sup> anniversary, to be presented in the Board Room. Without objection, it was so ordered.

# 9. RENEWAL AND EXTENSION OF THE REDISTRICTING ADVISORY COMMITTEE (RAC) (10:42 a.m.)

(BAC) Chairman McKay stated that the Board first approved a resolution in early 2021 to initiate the reapportionment process and charged the RAC with this task. While the original work of the Committee is complete and its original charter closed, in a letter dated November 1, 2021, Paul Berry, Chairman, RAC, he wrote "I strongly encourage a community-driven process that evaluates the names of magisterial districts [...] to bring greater equity to bear in Fairfax County."

In coordination with Chairman Berry, and jointly with Supervisor Walkinshaw, Chairman McKay moved that the Board renew and extend the Charter of the RAC, to complete the suggested work of evaluating the names of magisterial districts until March 1, 2022, in line with the Attorney General's review of the County's final redistricting plan, and report to the Board.

In addition, understanding that this is new work presented to the Committee and not all its original members may be able to continue this work. Chairman McKay further moved that the Board:

- Direct all appointing individuals and organizations to ask their appointees if they would like to be reappointed. Should that individual no longer wish to serve, a letter declining reappointment should be received so that a replacement can be found
- Submit to the Clerk all the names by November 23, 2021, whether for reappointment or replacement. A final vote on the committee's membership will be taken by the Board at the December 7, 2021, meeting, as part of the vote on Boards, Authorities, Committees, and Commissions. This mirrors the process taken to originally appoint the RAC
- Direct the County Executive to identify appropriate staff, agencies, and resources to carry out this Committee

Vice-Chairman Gross seconded the motion.

Following discussion regarding the possibility and timing of changing the Supervisor District names, the question was called on the motion and it carried by a vote of nine, Supervisor Herrity being out of the room.

Vice-Chairman Gross returned the gavel to Chairman McKay.

# 11. NO BOARD MATTERS FOR SUPERVISOR GROSS (MASON DISTRICT) (10:50 a.m.)

Supervisor Gross announced that she had no Board Matters to present today.

# 12. <u>LIMITING THE PURCHASE AND USE OF GAS-POWERED LEAF</u> <u>BLOWERS ON COUNTY PROPERTIES</u> (10:50 a.m.)

Supervisor Walkinshaw stated that the use of gas-powered leaf blowers presents a number of problems, most prominently their extreme and penetrating noise levels and the highly toxic emissions from the out-of-date two-stroke engines that they often use. Many gas-powered leaf blowers reach noise levels of 65 to 80 decibels at 50 feet away, enough to cause permanent hearing damage and/or tinnitus. Their engines are incredibly inefficient, releasing as much as 30 percent of oil/gasoline mixture they burn as aerosol. They emit 23 times more carbon monoxide than a Ford pickup truck.

This year, Supervisor Alcorn requested an accounting of how many gas-powered leaf blowers are owned and operated by County agencies. Additionally, the Board's recently-adopted Community-wide Energy and Climate Action Plan calls for the transition to electric vehicles and leaf blowers to achieve the County's emissions reduction goals. Fairfax County Public Schools have begun a pilot project at three schools to test the feasibility of switching to electric-powered tools on all of the District's 1,700 mowable acres.

County agencies work with the Department of Procurement and Material Management on product specifications when making purchases of leaf blowers. Agencies also place orders independently for products, and some agencies use third-party contractors for landscaping services. Due to the multifaceted nature of the acquisition and use of leaf blowers, a countywide policy would be necessary to institute the changes across departments and to express commitment to a cleaner and quieter County.

Therefore, jointly with Chairman McKay, Supervisor Alcorn, and Supervisor Storck, Supervisor Walkinshaw moved that the Board:

#### • Direct staff to:

- Report with a plan to discontinue the purchase of gas-powered leaf blowers as soon as is practical
- Update its procurement processes to incentivize electric use by awarding extra points to contractors which use electric leaf blowers and landscaping equipment
- Direct the Office of Environmental and Energy Coordination, the Office of Public Affairs, and the Department of Public Works and Environmental Services work to inform residents about the environmental hazards of gaspowered leaf blowers and the alternatives to grass and leaf collection. This work would include an announcement of what the County will be doing to limit and phase out gas-powered leaf blowers, as well as promotional pieces to be posted on the relevant County websites where information about leaf collection and lawn maintenance is listed. Supervisor Alcorn and Supervisor Storck jointly seconded the motion and it carried by a vote of nine, Supervisor Herrity voting "NAY."

#### 13. **LETTER TO GOVERNOR-ELECT GLENN YOUNGKIN** (10:57 a.m.)

Supervisor Walkinshaw stated that at this time of year the Board spends a great deal of time working on its draft Legislative Program and Human Services Issue Paper, highlighting legislative priorities for the upcoming 2022 General Assembly (GA) session, which begins in January. In fact, later today the Board will be holding a public hearing on those draft documents. Additionally, as the Board is aware, last week the voters of the Commonwealth elected a new Governor, Glenn Youngkin. When a new Virginia Governor is elected, the County typically shares some of its budget priorities with them, as they begin crafting their legislative agenda in advance of the first legislative session.

Virginia has an unusual budget process for new Governors – it is actually the departing Governor, in this case Governor Ralph Northam, who will propose the official introduced budget to the 2022 GA in December. It is then that the incoming

Governor-elect Youngkin will work with the 2022 GA on the budget throughout the session, as well as make legislative decisions about the final budget after the session has concluded. He will also be the Governor who implements the 2022-2024 biennium budget.

Supervisor Walkinshaw stated that as Virginia enters this transition period and the change of leadership in Richmond, the County congratulates Governor-elect Youngkin on his election and urges him to uphold the spirit of cooperation that the Board has enjoyed with the Commonwealth's Governors for many years. It is also important that the County highlight its State budget priorities, and suggest areas where there may be common ground, including increased State funding support for K-12 public education, transportation, mental health, the environment, and affordable housing, among others. Given that Governor-elect Youngkin is from the County, it is the Board's hope that it 'will be able to work with him on a wide range of budget issues that are vital to the County.

Therefore, Supervisor Walkinshaw moved that the Board direct staff to send the letter attached to his Board Matter, under the Chairman's signature, to Governor-elect Youngkin requesting his consideration of the County's budget priorities. Chairman McKay seconded the motion.

Following discussion regarding a typo in the draft letter and topics discussed by Governor-elect Youngkin while campaigning, the question was called on the motion and it carried by a vote of nine, Supervisor Herrity abstaining.

#### 14. **BIPARTISIAN INFRASTRUCTURE PACKAGE** (11:02 a.m.)

Supervisor Walkinshaw announced that the House recently passed the \$1-trillion package and he highlighted some items that were included as part of the package.

#### 18. **PROCLAMATION REQUEST FOR GINA LYNCH** (11:07 a.m.)

Supervisor Storck stated that Gina Lynch, Chair of the Fairfax County Animal Services Advisory Commission (ASAC) and Mount Vernon representative, was recently recognized by the Virginial Animal Control Association (VACA) with the 2021 Presidents' Award. This award is presented to a community member who has made a difference in the community by assisting animal control on a local level. Supervisors in the Animal Protection Police felt that not only was her 20 plus years of dedicated service to ASAC worthy of this nomination, but also her relentless pursuit for justice in criminal cases against those who abuse animals. Last year she met with Steve Descano, Commonwealth Attorney, on several occasions and was able to convince him that animal abuse and cruelty cases needed to be prosecuted in the County.

Supervisor Storck stated that Ms. Lynch is the go-to for all things animal related in his office and Countywide, whether it's adoption, rabies clinics, Trap-Neuter-Return program, or wildlife, the County can always count on Ms. Lynch to have the right answer and to help in any way asked, and with a smile on her face. Supervisor Storck thanked Ms. Lynch for her service to animals and their humans in the community.

Therefore, Supervisor Storck asked unanimous consent that the Board direct staff to prepare a Proclamation, signed by the Chairman and Mount Vernon District Supervisor, to be presented to Ms. Lynch in honor of her outstanding efforts in animal services in the County, to be presented outside of the Board Room. Without objection, it was so ordered.

#### 19. **IN-PERSON EARLY VOTING INFORMATION CLARITY** (11:09 a.m.)

Supervisor Storck stated that each year, the County makes great efforts to ensure all of its citizens receive timely, accurate voting information and have a variety of options and locations for doing so. Supervisor Storck applauded the Elections Office for the work they do to organize and staff satellite offices to make voting accessible for everyone.

Many thousands of citizens successfully voted at the Mount Vernon Governmental Center these past couple of months. Regrettably, each year, hundreds of citizens arrive at the Governmental Center to absentee vote at the incorrect time and/or date. Each of them cites the voting hours of the main Government Center (12000 Government Center Parkway) as the reasoning for their error and they often leave very unhappy and frustrated. Supervisor Storck stated his belief that this can be significantly remedied by altering the election card to better clarify and distinguish between the "Government Center" and the "Governmental Centers" dates and times. The names of the locations and their election card positioning next to each other make it too confusing for the typical voter to distinguish between the Centers.

Therefore, Supervisor Storck asked unanimous consent that the Board direct the Office of Public Affairs to work with the Office of Elections, and the directly impacted District offices, to consider alternate language to the Early Voting section of the election card as it is being developed and prior to its printing. Without objection, it was so ordered.

#### Discussion ensued regarding:

- Inclusion of all District offices, even those where voting is not offered
- Sunday voting options for the community
- Increasing the size of the flyer to adequately include all the information

#### 20. <u>ADOPTION OF THE AUDITOR OF THE BOARD'S SEPTEMBER 2021</u> <u>QUARTERLY REPORT</u> (11:17 a.m.)

Supervisor Storck stated that the Board has received the Auditor of the Board's September 2021 Quarterly Report. The report included the following study areas, recommendations, and managements' concurrence:

- Fairfax County Department of Transportation Cash Proffers Study:
  - Assess aged proffer balances, project and financial activity to evaluate projects as going concerns or actions, such as: repurposing, escheating, or returning funds to developers
  - Assess inactive or not located developers and related proffer balances to determine if projects remain going concerns
  - Enhance proffer and escrow internal tracking to differentiate between these two financial instruments to ensure proper treatment of funds
  - Procure and maintain all proffer statements to support the related projects
- Community Services Board Revenue Analysis Study:
  - Enhance financial processes to improve healthcare revenue cycle, such as: patient facing and back-office billing functions, benchmarking, and consistently collecting patient insurance information upfront
  - Liaise with County Counsel and other appropriate parties to document and execute the Cities of Falls Church and Fairfax Shared Services agreements which includes billing methodologies

- Construct and document the operational costs for health care services provided to the Cities of Falls Church and Fairfax. This captured cost information should assist staff with financial management thereby allowing for a better alignment between cost and negotiated rates with insurance companies. The by-product of this process will be a reduction in claims processing and disallowed claims
- Assess adjustments/write-offs and identify root causes to reduce reoccurrences

Supervisor Storck moved that the Board adopt the Auditor of the Board's September 2021 Quarterly Report. Supervisor Palchik seconded the motion and it carried by unanimous vote.

# 21. PROCLAMATION REQUEST FOR THE COMMISSION FOR WOMEN (11:19 a.m.)

Supervisor Palchik stated that this year marks 50 years since the Commission for Women was established by the Board for the purpose of advising the Board on ways to eliminate violence against women and end gender and sex-based discrimination against all women and girls in the County.

The Commission has become a vital force in the County due to its strong advocacy work toward helping establish the Turning Point Suffrage Memorial, pursuing the passage of the Equal Rights Amendment and supporting paid family medical leave. It has established robust partnerships with organizations including the Campaign for a Family Friendly Economy, Domestic and Sexual Violence Services, League of Women Voters of the Fairfax Area, and the National Association of Commissions for Women, which have been pivotal in advancing the work of promoting gender equality and honoring women and girls. It remains committed to diversity, equity, and inclusion, to best serve community members who are historically marginalized, underserved, unheard and underrepresented.

Therefore, jointly with Supervisor Gross and Supervisor Smith, Supervisor Palchik asked unanimous consent that the Board direct the Office of Public Affairs to prepare a Proclamation, to be presented to the Commission for Women, for recognition and in honor of its 50<sup>th</sup> anniversary and ongoing efforts to obtain equity for women and girls in the County, to be presented outside of the Board Room. Without objection, it was so ordered.

#### 22. <u>RESOLUTION OF RECOGNITION REQUEST FOR HOLMES RUN</u> <u>ACRES</u> (11:24 a.m.)

Supervisor Palchik stated that this year marks the 70th Anniversary of Holmes Run Acres, a community born with unique architecture, a beautiful natural setting, and

a strong sense of community. All anniversary events will be held during 2022, in hopes that the restrictions of the pandemic will be behind us, and all will be able to celebrate with the Holmes Run Community in-person.

Holmes Run Acres began in 1945 when Herman Schmidt, a Washington Investor and Owner of a 122-acre tract, filed a Deed of Declaration naming the tract Holmes Run Acres. Development began in 1950 and the houses were constructed by three builders: the Luria Brothers (Gerald and Eli), Gaddy Construction Company, and Andre Bodor. In 1957, there were 326 homes in Holmes Run Acres. Today that number stands at 365 and while the community is larger, the spirit of Holmes Run Acres remains.

Holmes Run Acres was designed with unique contemporary architecture to save trees and blend into the Virginia countryside. That intentionality is evident, as viewed through the work of the Holmes Run Acres Civic Association, who have spent years carefully documenting their history and producing Holmes Run Nature guides, cookbooks, poetry books, art collections, gardening tips, and archives. The work of the civic association and engaged neighbors helped lead to her first Board Matter, as launching the Department of Planning and Development to work with the community and her office in reviewing and preparing for a possible Historic Overlay District, expected to be completed later this calendar year.

In addition, Holmes Run Acres boasts an extensive array of community events from 'Day in the Park' to egg hunts, garden tours, and arts and craft exhibits. The association organizes fundraisers for community organizations and views the wellbeing of Woodburn Elementary School as a communal responsibility. They take great pride in looking out for their neighbors and checking in on one another. Holmes Run Acres continues to exemplify an active and caring community in the Providence District, and in the County.

Therefore, Supervisor Palchik asked unanimous consent that the Board direct staff to prepare a Resolution of Recognition for the Holmes Run Acres community for its 70<sup>th</sup> Anniversary, to be presented outside of the Board Room. Without objection, it was so ordered.

# 23. PROCLAMATION REQUEST DESIGNATING JANUARY 2022 AS "NATIONAL HUMAN TRAFFICKING AWARENESS MONTH" IN FAIRFAX COUNTY (11:27 a.m.)

Supervisor Herrity stated that January 2022 will mark "National Human Trafficking Awareness Month." Human traffickers use fear and intimidation to keep trafficking victims silent, which makes raising awareness vitally important to ending this horrific crime. Trafficking is nefarious in its many forms and morphs to adapt to circumstances, even the pandemic. According to the Polaris Project, some forms of trafficking have moved to online methods over the last two years. We have seen this uptick in cyber trafficking here in the County. Victim recruitment is also increasing online. In 2020, 59 percent of online victim recruiting in active

trafficking cases occurred on Facebook, according to the Human Trafficking Institute's 2020 Federal Human Trafficking Report. It is critical to continue to educate residents on the signs of trafficking, what to do to protect themselves and those around them, and work to make the County a nonpermissive environment for all forms of exploitation.

As people educate themselves and others on human trafficking, there is a need to publicly recognize the many forms it can take. Supervisor Herrity stated that in March 2019, he asked the Board to form an interdepartmental work group to focus on the issue of over 80 illicit massage businesses (IMBs) operating in the County. These IMBs hide in plain sight among legitimate businesses and make up one of the largest and most networked markets in the United States sex trafficking industry. While the pandemic response has delayed that effort, Supervisor Herrity stated that he is eager to see the progress that will come out of this work group and other efforts to stop trafficking in the region.

Over the last two years, law enforcement agencies have arrested multiple traffickers operating in the Northern Virginia area. In many of these cases there was a connection to gang activity, specifically MS-13, taking advantage of the most vulnerable. According to the Polaris Project's 2019 data report, the top three risk factors for trafficking vulnerability are substance abuse concerns, runaway homeless youth, and recent migration/relocation. All these factors exacerbated by the pandemic cause youth to be more vulnerable to gang affiliation and trafficking. In efforts to raise awareness of human trafficking, the County needs to continue to crack down on the gangs that prey on immigrant communities, runaways, and those with drug addictions, while providing preventative services especially for children.

Recognizing Human Trafficking Awareness Month in the County will reiterate the County's commitment to preventing human trafficking, and its across-the-board consequences for victims, their families, and the community.

Therefore, Supervisor Herrity asked unanimous consent that the Board direct staff to prepare a Proclamation designating January 2022, as "Human Trafficking Awareness Month" in the County, recognizing the tireless efforts of staff and County partners who have worked to raise awareness, aid survivors, and bring traffickers to justice. Without objection, it was so ordered.

# 24. REQUEST FOR A PERSONNEL COMMITTEE MEETING PRIOR TO THE DECEMBER BREAK (11:31 a.m.)

Supervisor Herrity requested that a Personnel Committee meeting be held prior to the Board's December break to discuss department staffing concerns.

## 25. <u>JOINT CAPITAL IMPROVEMENT PROGRAM (CIP) COMMITTEE</u> REPORT (11:32 a.m.)

Supervisor Smith stated that at the Board and School Board retreat on February 3, 2020, the genesis for establishing a joint Board/School Board CIP Committee was initiated. Chairman McKay presented a Board Matter on February 11, 2020, on the areas that the Board and School Board could collaborate on and at the February 25, 2020, Board meeting, the creation of the Joint CIP Committee was announced, including that the Sully District Supervisor and the Dranesville District Supervisor would represent the Board on this Committee.

On September 24, 2020, the first Joint CIP Committee meeting took place with representatives from the School Board and the Planning Commission. Laura Jane Cohen, Springfield District Representative, and Abrar Omeish, Member-at-Large, represented the School Board and Tim Sargent, Member-at-Large, and Phillip Niedzielski-Eichner, Providence District, represented the Planning Commission as ex-officio members.

After a year of meetings that included excellent presentations and information from staff and robust conversations on how to move forward, the Joint CIP Committee produced a report that contains recommendations and suggestions for going forward. The report will be presented at the Board's joint budget meeting with the School Board on November 23, 2021. Supervisor Smith stated that, in advance of that meeting, the report is attached to her Board Matter.

Supervisor Smith thanked the staff that assisted in that effort and mentioned that each person is listed in the "Acknowledgements" section of the report.

#### 26. **ADMINISTRATIVE ITEMS** (11:39 a.m.)

Supervisor Gross moved approval of the Administrative Items. Chairman McKay seconded the motion.

Supervisor Palchik called the Board's attention to Admin 12 – Authorization for the Fairfax County Police Department (FCPD) to Apply for and Accept Grant Funding from the Department of Criminal Justice Services (DCJS), Combating Hate Crime Grant Program: Round 2 and asked to consider this item separately. This was accepted.

Supervisor Foust called the Board's attention to <u>Admin 10 – Authorization to Advertise a Public Hearing to Consider Amendments to Article 14 of Chapter 4 of the Fairfax County Code to Revise Low-Income Real Estate Tax Exemption <u>Eligibility Requirements and Establish a Real Estate Tax Deferral Program</u> and discussion ensued regarding line 41 of the draft ordinance (Attachment Two of the Board Agenda Item) and moved to amend it as follows:</u>

• "...the value of the dwelling and the land in an amount not to exceed <u>five</u> acres upon which that dwelling is located, <u>subject to the condition that said</u> land cannot be subdivided under approved zoning at any time during the then current calendar year."

Supervisor Herrity seconded the motion. Discussion ensued, and Chairman McKay clarified, for the public, that this amendment is for the scope of the advertisement, not what is being approved.

Following further discussion regarding senior tax relief and the fiscal impact analysis, the question was called on the motion and it carried by unanimous vote.

Supervisor Foust called the Board's attention to line 224 of the draft ordinance: "...or (2) taxation based on 125% of the mean assessed value of all residential properties in Fairfax County for the applicable tax year" and moved to advertise it, as drafted by staff, with the possibility of deleting it. Chairman McKay seconded the motion.

Following discussion, with input from Jaydeep Doshi, Director, Department of Tax Administration (DTA), and Elizabeth Teare, County Attorney, regarding the motion, 401(k) and tax relief, Supervisor Foust withdrew his motion, and this was accepted.

Discussion continued, with input from Justin Nejad, Management Analyst, Revenue Collection Division, DTA, regarding 401(k) and the net combined financial worth.

The question was called on the motion to approve Administrative Items 1-11, as amended, with the exception of <u>Admin 12</u> and it carried by unanimous vote, Supervisor Alcorn, Supervisor Foust, Supervisor Gross, Supervisor Herrity, Supervisor Lusk, Supervisor Palchik, Supervisor Smith, Supervisor Storck, Supervisor Walkinshaw, and Chairman McKay voting "AYE."

  ON THE PROPOSED LEGISLATIVE PROGRAM TO BE PRESENTED TO
  THE 2022 VIRGINIA GENERAL ASSEMBLY (3:11 p.m.)
- (O) A Certificate of Publication was filed from the editor of the *Washington Times* showing that notice of said public hearing was duly advertised in that newspaper in the issues of October 22 and October 29, 2021.

A brief discussion ensued, with input from Claudia Arko, Legislative Director, regarding the legislative program.

Supervisor Walkinshaw, Chair of the Legislative Committee, presented a brief synopsis of the proposed legislative program, noting the following:

- The language on the Draft Legislative Program highlighted in yellow has been added since the Board's last Legislative Committee meeting on October 26, 2021. The new language is in response to direction that the Board provided to staff at that meeting
- As the Board begins working with the newly elected Governor Glenn Youngkin, his administration, and the General Assembly (GA) it will continue to emphasize these priorities, while also focusing on our shared goals and areas of common ground
- State revenue has continued to fluctuate in recent years, but due to the substantial injection of federal funds, including American Rescue Plan Act funds, the State is in a considerably stronger financial position than was expected at this time last year. This presents an opportunity to make critical investments in K-12 education, human services, and other shared state and local programs after years of state underfunding. State budget will be a

major area of focus in the 2022 session as the General Assembly continues to respond to the COVID-19 pandemic and works on a full two year budget for the 2022-2024 biennium

- As in previous years, the program features State support for education as a
  top priority and urges the State to fully meet its responsibility to adequately
  fund K-12, including restoration of full funding for cost of competing funds
- The Board's regional transportation priority statement encourages the GA to fully restore funding to the Northern Virginia Transportation Authority in an amount equal to what was diverted some years ago, and encourages the GA to build upon the successful enactment of the significant transportation revenues by the 2013 and 2020 GA's to ensure sufficient funding for transportation needs
- The Human Services issue paper highlights the County's interest in a number of Human Services programs and includes three priorities:
  - State funding and actions to increase the availability of affordable housing options
  - Sustainable State funding for diversion programs that connect people who come into contact with the justice system for nonviolent offenses for treatment
  - Increase State support to address the ongoing substance use disorder epidemic
- Two items under consideration as initiatives this year:
  - Allow Fairfax County Park Authority to resale electricity through electric vehicle charging stations
  - Reduce barriers for localities seeking to participate in virtual net metering through the States existing Municipal Net Metering Pilot Program. Net metering programs are of particular interest to local governments because they allow eligible customers to offset their power consumption by receiving credit for renewable power return to the energy grid. The County has long been committed to addressing the impacts of climate change and recently adopted a declaration committing to becoming carbon neutral by 2040. These initiatives would be a critical part of the County's efforts to reduce fossil fuel emissions

Supervisor Walkinshaw noted that the last Legislative Committee meeting for the year will be November 23, 2021, to finalize the Legislative Program in preparation for Board adoption on December 7, 2021. In addition, there will be some discussion

regarding various federal issues, and as mentioned at the previous Committee meeting, additional language surrounding building codes and energy efficiency.

A brief discussion ensued, with input from Ms. Arko, regarding the program.

Following the public hearing, which included testimony by six speakers, discussion ensued, and Supervisor Walkinshaw addressed issues raised by the speakers regarding military surviving spouse tax exemption and gas powered leaf blowers.

Following discussion, regarding gas powered leaf blowers, Supervisor Alcorn asked unanimous consent that the Board direct staff to check with the two GA sponsors of the Bill to see if that is something the County could support. Without objection, it was so ordered.
