At a regular meeting of the Board of Supervisors of Fairfax County, Virginia, held in the Board Auditorium of the Government Center at Fairfax, Virginia, on Tuesday, January 25, 2022, at 9:34 a.m., there were present:

BOARD MATTERS

1. **MASKS REQUIRED** (9:34 a.m.)

Chairman McKay stated that, in accordance with CDC guidance, masks continue to be required for everyone who enters a County facility. Therefore, everyone in the Board Auditorium today must wear a mask at all times, including while speaking or taking photos.

2. <u>ABSENCE OF PROVIDENCE DISTRICT SUPERVISOR DALIA PALCHIK</u> (9:35 a.m.)

Chairman McKay stated that Supervisor Palchik will not be participating in the meeting today and announced the birth of her first child, Sivan Esther Friedman on January 17, 2022.

3. **MOMENT OF SILENCE** (9:35 a.m.)

With reference to the January 6, 2021, insurrection at the Nation's Capital, Chairman McKay recognized the one-year anniversary of that day to remember the officers who lost their lives in the days after the insurrection; and asked everyone to remember the first responders, elected officials, Capitol Hill staff, and those who live with the physical and emotional scars from the insurrection.

The Board asked everyone to keep in thoughts the family and friends of:

- Willis "Bill" Burton, who passed away recently. He was the County's first Chief Fire Marshall; helped construct the Fire and Rescue Academy; and was credited with purchasing the first County-owned fire apparatus
- Carolyn Ford, who passed away recently. She served the County for 17 years, most recently with the Fairfax Falls Church Community Services Board (CSB)
- Paulette Whiteside, who passed away recently. She served the County for 28 years
- Sara Florez, who passed away recently. She served the County for eight years, most recently with the CSB
- Senator Harry Reid, who passed away recently. He was one of the greatest Senate majority leaders and passed landmark legislation that made the nation stronger and safer
- Jeff Waters, who passed away recently. He was the co-owner of White Hall Farm, a local fixture in the Springfield District. He was dedicated to his family and farm

- Ed Moore, who passed away recently. He was a member of the Clifton Lions Club; a business community leader; and was a retiree from the County school system
- Jack Rust, who passed away recently. He had a decorated legal career; was a dedicated public servant who was twice elected to the Virginia General Assembly; and served as the Commissioner of Accounts for the Fairfax Circuit Court
- Rufus Phillips III, who passed away recently. He was a longtime McLean resident who was elected Dranesville District Supervisor in 1971 where he led the development of the County's Planning and Land Use system. He also had a distinguished career with the Central Intelligence Agency where he earned the agency's Intelligence Medal of Merit
- Victor Kimm, who passed away recently. He was a pillar of the McLean community who spent 29 years volunteering with Share of McLean, a nonprofit organization dedicated to helping those less fortunate; and was the recipient of the 2010 Outstanding Community Citizen by the McLean Chamber of Commerce
- Joel Gonzalez, who passed away recently. He succumbed to his injuries after being struck by a vehicle
- Dr. Thomas Lovejoy, who passed away last month. He was a University Professor in the Department of Environmental Science and Policy and George Mason University; and was known as the "Godfather of Biodiversity" because he was the first to use the term biodiversity. He was also one of the foremost experts on biodiversity in the Amazon and was credited with establishing the Biological Dynamics of Forest Fragments project in Brazil and founding the Amazon Biodiversity Center
- Linda Singer, who passed away recently. A Reston resident since 1975, she
 was the founding president of the Terraset Elementary School Parent
 Teacher Organization and was also the Lake Anne Elementary librarian.
 Her recognitions include Restonian of the Year, Lady Fairfax for the Hunter
 Mill District, and the Martha Pennino Award for Community Service
- Anne Andrews, who passed away recently. She was a Mount Vernon District resident who founded the Mount Vernon District Route One Task Force for Human Services; led the taskforce for over 40 years; and was engaged to make a difference. Her recognitions include 1990 Lady Fairfax for the Hunter Mill District and 2008 Fairfax County Citizen of the Year

7. **REPORT ON GENERAL ASSEMBLY ACTIVITIES** (10:49 a.m.)

Supervisor Walkinshaw, Chairman of the Board's Legislative Committee, presented the report on General Assembly activities, noting the following:

- As of January 23 2,364 bills and resolutions have been introduced in the 2022 General Assembly – many of which were discussed at the Legislative Committee meeting. The Committee's positions on specific bills are outlined in the memo and tracking chart included in the Committee's report
- A key area of focus this session will be the 2022-2024 biennium budget. The County continues to advocate for increased K-12 funding, as well as increased funding for a variety of Human Services programs and services, public safety, environmental

initiatives, and transportation, among others. The Board will get additional updates from staff as the budget process progresses

- A wide variety of bills have been introduced this session, including numerous bills that would reduce County revenue, change County services and operations, or restrict the County's land use authority. As the Board is aware, the November elections brought change to the General Assembly and the Governor's mansion resulting in many bills that would undo some of the critical reforms enacted over the last two years including legislation this Board's supported in areas such as increasing access to voting and gun safety. Staff will continue to provide updates on these key issues throughout the legislative process
- The Legislative Committee received the following status updates on the Board's County initiatives this year:
 - 1. The Bill which would reduce barriers for localities seeking to participate in virtual net metering through the State's municipal net metering pilot program.
 - 2. The Bill which would allow the Fairfax County Park Authority to resell electricity through electric vehicle charging stations

These-bills have been referred to the House Commerce and Energy Committee, where they await consideration.

• The Committee reviewed a number of transportation bills as well as bills relating to absentee voting and elections, taxation, land use, and health and human services. Legislative staff will continue to keep the Board updated on these issues throughout the legislative process

Supervisor Walkinshaw noted that the next meeting of the Legislative Committee will be held in the Board Auditorium on January 28, 2022, at 4p.m.

Supervisor Walkinshaw also noted that the annual reception will be held in Richmond at the Credit Union House of Virginia on February 16, 2022, at 5:30 p.m.

Supervisor Walkinshaw moved adoption of Legislative Committee Report Number One. Chairman McKay seconded the motion and it carried by a vote of eight, Supervisor Herrity voting "NAY," Supervisor Palchik being absent.

10. <u>10 A.M. – PUBLIC HEARING ON THE FISCAL YEAR (FY) 2022 MID-YEAR</u>
<u>REVIEW TO AMEND THE APPROPRIATION LEVEL IN THE FY 2022</u>
<u>REVISED BUDGET PLAN</u> (10:57 a.m.)

(SAR) A Certificate of Publication was filed from the editor of the *Washington Times* showing that notice of said public hearing was duly advertised in that newspaper in the issues of January 7 and January 14, 2022.

Christina Jackson, Chief Financial Officer and Director, Department of Management and Budget, outlined the *FY 2022 Mid-Year Review* Package.

Following the public hearing, which included testimony by one speaker, Chairman McKay relinquished the Chair to Vice-Chairman Gross and moved approval of the Mid-Year Package including Supplemental Appropriation Resolution AS 22200 and Amendment to the Fiscal Planning Resolution AS 22902, for FY 2022 adjustments. This approval includes the FY 2022 Mid-Year Review Package as

presented at the Board meeting on December 7, 2021, as well as the following General Fund adjustments:

- The appropriation of \$5 million in one-time funding to be used toward affordable housing production and preservation to further progress for one of the highest priorities of the Board
- The appropriation of \$1,534,174 in one-time funding to be placed in the County's General Fund Pandemic Reserve, to continue to provide the County flexibility to respond to the Covid-19 Pandemic. With this adjustment, the balance in the Pandemic Reserve stands at \$22.53 million

With these adjustments, as outlined, the General Fund Balance for the *FY 2022 Mid-Year Review* is \$0. Supervisor Foust seconded the motion. Following discussion regarding the motion, the question was called on the motion and it carried by a vote of eight, Supervisor Alcorn, Supervisor Foust, Supervisor Lusk, Supervisor Smith, Supervisor Storck, Supervisor Walkinshaw, Vice-Chairman Gross and Chairman McKay voting "AYE," Supervisor Herrity voting "NAY," Supervisor Palchik being absent.

Vice-Chairman Gross returned the gavel to Chairman McKay.

ADDITIONAL BOARD MATTERS

11. <u>CERTIFICATE OF RECOGNITION REQUEST FOR ERIN WARD</u> (11:10 a.m.)

Chairman McKay relinquished the Chair to Vice-Chairman Gross and asked unanimous consent that the Board direct staff to prepare a Certificate of Recognition for Erin Ward, Deputy County Attorney, in recognition of her retirement, to be presented out of the Board Room. Without objection, it was so ordered.

12. PROCLAMATION REQUEST DESIGNATING FEBRUARY 2022, AS "BLACK HISTORY MONTH" (11:10 a.m.)

Chairman McKay asked unanimous consent that the Board direct staff to prepare a Proclamation designating February 2022, as "*Black History Month*" in the County, to be presented out of the Board Room. Without objection, it was so ordered.

13. **MASKING AT SCHOOLS** (11:11 a.m.)

Chairman McKay stated that on January 15, 2022, Inauguration Day, an Executive Order making masks optional for students in Virginia's public K-12 schools was issued by Governor Youngkin.

Considering this Executive Order, and in the interest of full transparency, it is important for the Board to be aware of the recommendations of Virginia medical experts and other health professionals. Chairman McKay referenced the documents attached to his written Board Matter. The Virginia Chapter of the American Academy of Pediatrics strongly recommends that children "continue to wear masks in school while rates of COVID-19 infection remain high." In addition, a letter from the Health Directors of Fairfax, Loudoun, Prince William, and Arlington counties and the City of Alexandria firmly endorses multiple mitigation measures, including vaccinations, masking, physical distancing, testing, and quarantine, because "no one single measure is perfect." They also however, "stress the importance of maintaining universal indoor masking in our schools." These practices are crucial if the County wants to continue to keep schools open and minimize staff and student absenteeism.

Chairman McKay said here in the County, the Board is committed to keeping schools open and have spent two long years slowing the spread of COVID-19 to facilitate that. The County has followed the science and our trusted health professionals. As of January 20, more than 80 percent of all County residents have received one vaccine dose and there are more than 300 vaccination sites across the County. School age kids who have received at least one vaccine dose include: 46.7 percent of children 5-11 years, 90.1 percent of those 12-15 years, and 94.6 percent of those 16-17 years. In addition, through targeted outreach and mitigation efforts, the County is closing the gap that existed early in the pandemic, wherein the County's Hispanic and Black populations experienced higher rates of COVID-19 infection than other racial and ethnic groups in the County.

Thanks to these efforts, so far in the 2021-22 school year, Fairfax County Public Schools (FCPS) has not had to close a single school due to COVID-19. Following a year and a half of virtual learning, winter weather complications, and considering nationwide staffing shortages, the County has enough challenges to overcome. As an elected body, it is the Board's duty and that of the Fairfax County School Board to prioritize health and safety to the best of its abilities, including to ensure the best education for students. Furthermore, it is in this Board's interest that economy continues to thrive. For that to happen, schools and businesses need to be able to stay open.

There is no evidence to support changing the approach now. The County's layered mitigation strategy has resulted in a low rate of in-school transmission of 1.1 percent in the County according to an October 2021 report and FCPS reported 1,300 cases of COVID-19 in January alone. All efforts should be focused on reversing this trend. Additionally, the County is in the midst of a 30-day state of emergency order issued to help address the major strain on Virginia hospitals caused by Omicron. It is inconceivable to lift masking requirements while in this state of emergency, which was supported by Governor Youngkin and, in fact, reissued less than a week ago by Governor Youngkin.

Beyond all of these considerations, it is unclear that the Governor has the authority to lift masking requirements under current state law. As a result, FCPS is leading a lawsuit of seven school districts to reinforce their local authority. Among other things, SB1303, passed during the 2021 session of the General Assembly, states: "For the purposes of this act, each school board shall [...] provide such in-person instruction in a manner in which it adheres, to the maximum extent practicable, to any currently applicable mitigation strategies for early childhood care and education programs and elementary and secondary schools to reduce the transmission of COVID-19 that have been provided by the federal Centers for Disease Control and Prevention." The CDC guidance for COVID-19 prevention in K-12 schools states: "[The] CDC recommends universal indoor masking by all students (ages 2 years and older), staff, teachers, and visitors to K-12 schools, regardless of vaccination status."

The Board wants to be able to return to "normal" as soon as possible and would love to be able to take masks off and no longer be concerned about the spread of COVID-19. This is not a question of being "pro" or "anti" masks. As someone with two kids in the school system, Chairman McKay stated that he looks forward to the day that schools return to "normal," but not until it is safe to do so. Instead of making political decisions, the Governor and his team should instead establish metrics to inform school districts when it will be safe to lift mask mandates.

Therefore, Chairman McKay moved to:

- Support the Fairfax County School Board and Superintendent in their plan to continue to require masking of students, teachers, and staff at all FCPS facilities at this critical time
- Approve the letter (attached to his written Board Matter) to the Governor, encouraging him to develop metrics in coordination with local health directors and school districts to achieve the mutual goal of eliminating masks, when it is safe to do so
- Direct the legislative team update the Board on any legislation that seeks to alter SB1303 or current masking requirements in schools, including the following legislation that has been filed in the General Assembly: HB514, HB1036, and HB1038
- Direct the Office of Public Affairs continue to work with the Northern Virginia Regional Commission on communicating the importance of a layered mitigation approach to COVID-19, including the importance of booster shots and wearing masks while community transmission remains high

Supervisor Lusk seconded the motion.

Following discussion on the Governor's actions and the current use of masks, the question was called on the motion and it carried by a vote of eight, Supervisor Herrity voting "NAY," Supervisor Palchik being absent.

14. <u>PUBLIC OUTREACH STRATEGY ON THE RENAMING PROCESS</u> (11:34 a.m.)

(BAC) Chairman McKay stated that the Redistricting Advisory Committee began its work last week with a charge to evaluate the names of magisterial districts in the County.

While the Committee works to thoroughly analyze materials and conduct its own outreach to inform the ultimate recommendations to the Board, this Board, too, has a vital role to play in this multi-step and public-led process.

On January 11, 2022, the Committee passed a resolution on informing and engaging the general public on the renaming process, purpose, and benefits. This resolution called on the Board to adopt a separate comprehensive public outreach plan on the process and on any recommended changes.

Therefore, jointly with Supervisor Walkinshaw, Chairman McKay moved that the Board direct the Office of Public Affairs work to develop a public outreach strategy on the renaming process that includes social media, electronic communications to County residents, and a public comment period on any recommended changes. This outreach should be coordinated with the Supervisors whose district may be impacted by the proposed recommendations on strategies to do outreach within their districts. It should also be conducted following the committee's own outreach and after their recommendations are given to the Board. Supervisor Walkinshaw seconded the motion and it carried by a vote of eight, Supervisor Herrity being out of the room, Supervisor Palchik being absent.

15. **TRAFFIC CONTROL AT GREAT FALLS PARK** (11:37 a.m.)

Chairman McKay stated that the Great Falls Citizens Association (GFCA) has been actively engaged with the Board, the George Washington Memorial Parkway (GWMP) office of the National Park Service (NPS), and the Virginia Department of Transportation (VDOT) on traffic congestion at Great Falls Park for the past seven years.

A 2017 NPS Congestion Assessment (CA) study of Great Falls Park documents the traffic problems that are occurring and provides recommendations for addressing them. Over the last four years, GFCA has discussed these recommendations with NPS and explored other alternatives.

While NPS and VDOT have introduced several measures, including prepayment of fees and advance notifications about conditions at the park, annual visitation continues to grow and traffic control by the United States Park Police (USPP) remains key in addressing congestion on local roads.

In June 2021, GFCA reached out to Congresswoman Wexton requesting that new dedicated annual funding be included in the Department of Interior appropriations bill for traffic management beginning in FY 2022. GFCA also spoke with Senator Warner's office about this issue. Unfortunately, the timing was such that nothing

could be done by either the House or Senate for the current fiscal year and that the focus should be on funding the FY 2023 budget.

In response to a November 2021 letter sent to Pamela Smith, Chief, USPP concerning traffic control at the intersection of Georgetown Pike and Old Dominion Drive, GFCA was advised that: (i) traffic control could only be done by officers on overtime because of staffing limitations; (ii) this overtime cost was not factored into the USPP FY 2022 budget submission; and (iii) the USPP will not be able to reprogram funds from its current budget plan to accommodate the traffic control request. GFCA was also advised that its request that funding be included in the FY 2023 budget submission for traffic control would be evaluated during the FY 2023 budget formulation process.

As the County is already four months into FY 2022 and the FY 2023 budget process is currently underway, it is important that the County voice its support for including \$100,000 in the USPP budget for traffic control at Great Falls Park as it directly affects many constituents, drivers from other jurisdictions who use Georgetown Pike as a commuter route, and visitors to the area. Great Falls is not only a park for metropolitan Washington, but also a tourist attraction that brings in revenue to Northern Virginia. Living with the problem of traffic congestion, or ignoring it, is no longer an option.

Therefore, jointly with Supervisor Foust and Supervisor Walkinshaw, Chairman McKay moved that the Board:

- Send the letter (attached to his written Board Matter) to Congresswoman Wexton and Senator Warner requesting that the USPP include \$100,000 in its FY 2023 budget submission for the specific purpose of providing traffic control at Great Falls Park as part of its regular duties
- Urge the USPP to work with NPS headquarters to identify whether there are funds in the FY 2022 NPS budget that might be redirected to ensure that traffic control at Great Falls Park continues this fiscal year

Supervisor Foust seconded the motion and it carried by a vote of nine, Supervisor Palchik being absent.

Vice-Chairman Gross returned the gavel to Chairman McKay.

16. **REQUEST FOR DISCOUNTED DISPOSAL RATES** (11:40 a.m.)

Supervisor Gross stated that the Department of Public Works and Environmental Service (DPWES) has received requests from The Salvation Army and the Virginia Department of Transportation (VDOT) for reduced disposal rates on the material that is delivered to Fairfax County disposal facilities. Current DPWES policy does not waive fees for any entity, including governmental and non-profit agencies, without clear direction from the Board.

In a NIP Memo to the Board, dated December 14, 2021, County Executive Bryan Hill outlined the substance of the requests. The Salvation Army accepts donations of used furniture and other household items, from about 15,000 homes in the County. However, after recycling the majority of the 4,000 – 5,000 tons donated, about 700 tons of material cannot be used and must be taken to a disposal facility. The Salvation Army currently is paying \$66 per ton tipping fee and is seeking a reduction or waiver of the tipping fee to help with its activities of waste diversion and recycling.

Similarly, VDOT collects material that is dumped illegally on VDOT right-of-way. VDOT also pays the \$66 per ton tipping fee, and state funding for removal of large dumped items is not included in VDOT's maintenance budget. VDOT has been working with DPWES to find a reasonable solution. For both entities, DPWES has recommended a reduction in the tipping fee to the County's internal cost of \$40 per ton, about a one-third reduction. The fee reduction would have a minimal cost impact to the Solid Waste Management Program.

Therefore, Supervisor Gross moved that the Board approve the recommended reduction of tipping fees to \$40 per ton for the Salvation Army and VDOT. Supervisor Lusk seconded the motion and it carried by a vote of nine, Supervisor Palchik being absent.

17. <u>METROPOLITAN WASHINGTON COUNCIL OF GOVERNMENTS</u> (COG) RESOLUTION TO ADDRESS MENTAL HEALTH STIGMA (11:42 a.m.)

Supervisor Gross stated that earlier this month, the COG Board of Directors adopted a resolution that encourages its member jurisdictions to work together, via COG's Human Services Policy Committee, on which we represent Fairfax County, to collaboratively address and combat mental health stigma via enhancing awareness, improving access to care, and support and increase culturally competent providers from diverse backgrounds and ages. A copy of the Resolution is attached to her written Board Matter.

Some of the recommendations in the COG resolution already are being accomplished in Fairfax County, but the interjurisdictional collaboration may need to be more clearly defined. Therefore, jointly with Supervisor Lusk, Supervisor Gross asked unanimous consent that the Board direct:

- Staff to disseminate the COG Resolution among the appropriate agencies in Fairfax County Government
- The County Executive to prepare a brief assessment of the County's work in these subject areas, which can be provided through a memo or a committee agenda item. The assessment also will be shared with the COG Human Services Policy Committee at a future meeting

Without objection, it was so ordered.

18. <u>AUTHORIZATION FOR A COMPREHENSIVE PLAN AMENDMENT</u> FOR 6446 EDSALL ROAD (MASON DISTRICT) (11:44 a.m.)

Supervisor Gross stated that the approximately 3.7-acre property located at 6446 Edsall Road, on the east side of 1-395, is currently planned for retail and other commercial uses and is developed as a Bowl America location. This site is in an area developed with multi-family housing and is adjacent to an on-ramp for 1-395. A developer has approached the county about redeveloping the property with multi-family housing. Supervisor Gross stated her belief that this presents an opportunity to consider a change in use for the property that is complementary to the existing multi-family neighborhoods in the area.

Therefore, to facilitate the potential re-planning effort of this property, Supervisor Gross moved that the Board authorize an amendment to the Comprehensive Plan for Tax Map Parcel Number 81-1 ((6)) 2 to allow for the consideration of multi-family residential use at an appropriate density. The Comprehensive Plan analysis should include, as a priority, mitigation of highway related noise, consistent with County Policy. The Plan Amendment will be reviewed concurrently with an application to rezone the property, once such an application is submitted. This motion should not be construed as a favorable recommendation on these applications by the Board and does not relieve the applicant from compliance with the provisions of any applicable ordinances, regulations, or adopted standards. This action in no way prejudices the substantive review of the applications. Supervisor Lusk seconded the motion and it carried by a vote of eight, Supervisor Foust being out of the room, Supervisor Palchik being absent.

19. NO BOARD MATTERS FOR SUPERVISOR WALKINSHAW (BRADDOCK DISTRICT) (11:46 a.m.)

Supervisor Walkinshaw announced that he had no Board Matters to present today.

20. TRASH COLLECTION SERVICE (11:46 a.m.)

Supervisor Alcorn stated that he would like for the Board to discuss trash collection service in the County at a future Environmental Committee meeting.

(NOTE: Later in the meeting, there was additional discussion regarding this issue. See Clerk's Summary Items #25 and #28.)

21. NO BOARD MATTERS FOR SUPERVISOR FOUST (DRANESVILLE DISTRICT) (11:46 a.m.)

Supervisor Foust had no Board Matters to present today.

22. <u>AUTHORIZATION OF COMPREHENSIVE PLAN AMENDMENT AT</u> 6900 RICHMOND HIGHWAY (BEACON OF GROVETON INTERIM PARK) (LEE DISTRICT) (11:48 a.m.)

Supervisor Lusk said the approximately 0.6-acre property located at 6890 Richmond Highway currently is used as an interim park but planned and zoned for approximately 70,000 square feet of office and retail uses. This approval was part of a mixed-use development with the adjacent apartment building in Land Unit D within the Beacon/Groveton Community Business Center and Commercial Revitalization District. The site has been entitled for the commercial use since 2009, but has not been constructed. The Economic Development Authority's recent market analysis of the Richmond Highway Corridor shows no market demand for office use in the next ten years in the Beacon Groveton area. A proposal also came through a few years ago for the interim park to become a permanent park, which was incorporated in the Embark study and the Plan, but that also has not come to fruition.

The property owner is now proposing the development of senior, affordable housing of around 60 to 70 units, as an alternative to the approved commercial use on the park site. This would not increase the overall planned floor area ratio (FAR) of the development. Understanding the need for affordable housing in the County, especially for low income older adults, he stated his belief that this proposal is worth considering and will require a comprehensive plan amendment and rezoning.

Therefore, Supervisor Lusk moved that the Board direct staff to consider a comprehensive plan amendment for an affordable, independent living facility on Tax Map Parcel 93-1((1))98A. Alternative, community-serving, ground-floor uses may be considered in the review as well. The Plan Amendment should be reviewed concurrently with an application to rezone the property once such amendment is submitted. This motion should not be construed as a favorable recommendation of these applications by the Board and does not relieve the applicant from compliance with the provisions of any applicable ordinances, regulations, or adopted standards. This action in no way prejudices the substantive review of the applications. Supervisor Alcorn seconded the motion. Following discussion regarding the motion, the question was called on the motion and it carried by a vote of nine, Supervisor Palchik being absent.

23. CHILD SAFETY SEAT INSTALLATION PROGRAM (11:54 a.m.)

Supervisor Lusk said, as many of us understand firsthand, there are few undertakings more stressful than installing your child's car seat for the first time. Parents and caregivers throughout the County rely on first responders to assist them in safely installing their children's car seats. While the County's program to assist parents install and inspect car seats was previously administered jointly by the Fairfax County Fire and Police Departments, it is now under the sole jurisdiction of the Police Department (FCPD), while a separate program is administrated by the Sheriff's Office.

These programs are currently run independently of each other and face serious challenges due to geography and staff availability. As the Board is aware, FCPD has been faced with staffing issues which have contributed to a shortage of officers, and there is currently a critical deficit of officers with the required training to properly install car seats. This has resulted in excessively long wait times for parents trying to schedule an appointment for a trained officer to assist with the fitting of their children's car seats – Recognizing that this backlog is not due to the actions of the Fairfax County Fire, Police, or Sheriff's Departments, but has been caused by external factors and exacerbated by the COVID-19 pandemic.

Following consultation with representatives from the Police, Fire, and Sheriff's Departments, Supervisor Lusk said he, Supervisor Alcorn, and Supervisor Walkinshaw, believe that a more centralized and coordinated effort is needed to improve the County's car seat installation services, and are pleased that the public safety staff they have consulted with enthusiastically agree.

Therefore, jointly with Supervisor Alcorn and Supervisor Walkinshaw, Supervisor Lusk moved that the County Executive assign the appropriate staff to convene a working group to study possible steps which can be taken to improve the County's current car seat installation program. In addition to the Fairfax County Police, Fire, and Sheriff's Departments, the group should include members of the Office of the County Attorney, the Department of Emergency Management and Security, and a small number of County residents who have familiarity with the program. The group will:

- Explore alternative solutions, including but not limited to a hybrid model where day-to-day car seat installation appointments are offered at County facilities while the Police, Fire, and Sheriff's Departments jointly hold regularly scheduled workshops at various locations throughout the County to improve accessibility, as well as the possibility of partnering with outside organizations such as car dealerships or hospitals to offer car seat fitting services by trained employees
- Investigate the option of incorporating car seat inspection training into the
 existing public safety academy curricula, certifying administrative staff at
 public safety facilities in car seat installation, and potential legislative
 solutions which could impact car seat safety training
- Report its findings to the Public Safety Committee for additional consideration after a three-month period

Supervisor Walkinshaw seconded the motion.

Following discussion, with input from Bryan Hill, County Executive, regarding the timeframe, Supervisor Lusk amended his motion that the County Executive report to the Board as soon as possible. This was accepted.

Following additional discussion regarding the motion, the question was called on the motion and it carried by a vote of nine, Supervisor Palchik being absent.

24. REQUEST TO WAIVE FEES FOR SPRINGFIELD GLOBAL LIONS CLUB 2022 FLEA MARKETS (12:01 p.m.)

Jointly with Supervisor Gross, Supervisor Lusk stated that they are requesting a waiver of the application fees for permits associated with the flea markets held by Springfield Global Lions Club. The Board has approved waiver requests for the Lions annually since 1994. The Springfield Global Lions Club flea market on its fourth year will run twice a month from April to October 2022 on Sundays. Supervisor Lusk said the club has expressed appreciation for permission to allow this in the past and are again requesting a waiver.

All net proceeds from these flea markets are returned to the community. The Springfield Global Lions Club supports organizations such as ECHO, Koinonia, local Food Banks, and other multiple local Lions organization serving the community and assists indigent citizens in need of prescription eyeglasses and hearing aids.

Therefore, jointly with Supervisor Gross, Supervisor Lusk moved that the Board direct staff to waive the application fees for the permits associated with the Springfield Global Lions Club 2022 flea markets. Supervisor Gross seconded the motion and it carried by a vote of nine, Supervisor Palchik being absent.

25. <u>DISCUSSION ON TRASH COLLECTION SERVICE</u> (12:03 p.m.)

(NOTE: Earlier in the meeting, Supervisor Alcorn presented a Board Matter regarding this issue. See Clerk's Summary Item #20.)

Supervisor Storck stated he also agrees that there needs to be discussion regarding the Solid Waste issue. He noted that the Environmental Committee will be meeting in February, and it already has a full agenda, but he looks forward to hopefully having some discussion regarding this issue.

(NOTE: Later in the meeting, Supervisor Herrity presented a Board Matter regarding this issue. See Clerk's Summary Item #28.)

26. MOUNT VERNON'S 35TH ANNUAL TOWN MEETING (12:04 p.m.)

Supervisor Storck stated that once again this year, he is fortunate to have the opportunity to continue a Mount Vernon tradition established by my predecessor in 1988, the annual Mount Vernon Town Meeting. The Town Meeting will be back in person this year at Mount Vernon High School and residents can also join from their homes by streaming on Channel 16 and Facebook. The morning will begin with an exhibit hall of County and community service providers, followed by a question and answer (Q&A's) session with local leaders and special recognitions.

Supervisor Storck said he is pleased that Congressmen Don Beyer and Gerry Connolly, Chairman Jeff McKay, County Executive Bryan Hill, George Washington Parkway Superintendent Charles Cuvelier, and Mount Vernon School Board Representative Karen Corbett Sanders will be presenting and answering questions from residents.

Supervisor Storck invited his colleagues and County residents to join him for this annual event on the Saturday before the Super Bowl, February 12, with the exhibit hall opening at 7:45 a.m., and the program from 9:30 a.m. til noon. Again this year, there will be COVID-19 monitoring and CDC recommended safeguards taken, so the format will be adjusted, as needed.

Therefore, Supervisor Storck asked unanimous consent that the Board direct the Office of Public Affairs to advertise the Town Meeting on its various communications platforms. Without objection, it was so ordered.

Chairman McKay complimented Supervisor Storck on the Town Meeting Flyers which he attached to his Board Matter.

27. <u>INTRODUCTION OF NEW STAFF (MOUNT VERNON DISTRICT)</u> (12:07 p.m.)

Supervisor Storck introduced his new Mount Vernon District Office Manager, Madeleine Carcamo Reyes, and shared a brief history of her accomplishments. On behalf of the Board, he warmly welcomed her to the Board Auditorium.

28. **TRASH COLLECTION SERVICE** (12:08 p.m.)

(NOTE: Earlier in the meeting, Supervisor Alcorn and Supervisor Storck presented Board Matters regarding this issue. See Clerk's Summary Items #20 and #25.)

With regard to the trash collection service issue, Supervisor Herrity said that he broached the subject in a recent newsletter and received feedback from his constituents. Supervisor Herrity stated that he will forward those suggestions to Solid Waste staff.

29. RESOLUTION REQUEST TO RECOGNIZE WEST SPRINGFIELD LITTLE LEAGUE (WSLL) FOR ITS 50TH ANNIVERSARY (SPRINGFIELD DISTRICT) (12:09 p.m.)

Supervisor Herrity said the WSLL started its first season as an independent league in 1972, splitting off from what is now the Central Springfield Little League following a tremendous population explosion in the West Springfield area and the growth of the league. WSLL began its independent league with over 600 players and has grown steadily since then. WSLL has served as an example of a successful Little League Team that in 50 years has accomplished so much while at the same time serving as a community outlet for County youth to participate in and gain early sports experience in baseball.

In 1993, WSLL and the Central Springfield Little League jointly fielded their first Challenger baseball team for children with physical and mental disabilities. At that time, they had only nine ball players. Since then, it has grown to over 250 players and has been recognized by Little League Baseball as having the largest Challenger Baseball program in the world. In 2001, Springfield Challenger played T-ball at the White House in front of President George Bush.

Springfield Challenger was honored again on August 29, 2009, when the team was invited to play at the 2009 Little League World Series in Williamsport, Pennsylvania.

Also of special note is that in addition to the many teams they field every year, the WSLL All-Star teams won all three District titles in 2007 and 2009. No other league in District 9 has won all three titles in a single year.

WSLL started with the support and dedication of a handful of individuals and has grown into one of the largest, best-organized sports programs in the area. It is still entirely a volunteer organization led by individuals who believe in the community youth. WSLL has continued to operate throughout the pandemic, offering a critical outlet for students to play, grow, and learn foundational lessons about character and teamwork.

Therefore, jointly with Supervisor Lusk, Supervisor Herrity asked unanimous consent that the Board direct staff to prepare a resolution, with dual signature, recognizing West Springfield Little League's 50th Anniversary and its contributions to the community to be presented at its 50th Anniversary Ceremony in the spring. Without objection, it was so ordered.

30. RECOGNITION OF LAURA GRAPE, EXECUTIVE DIRECTOR, NORTHERN VIRGINIA WATER SOIL AND CONSERVATION DISTRICT(NVWSCD) BOARD OF DIRECTORS (12:11 p.m.)

Supervisor Herrity recognized Laura Grape, for her years of service as the Executive Director on the NVWSCD Board of Directors. The Board made some important steps forward during her ten-year tenure, including coordinating with the Northern Virginia Clean Water partners, performing climate adaption analysis to determine communities at risk of sea level rise and storm impact, identifying and implementing regional land conservation priorities, and initiating Plant NOVA natives campaign to promote the value of native plants. She is going to work for the Park Authority, after her prior service in the Department of Public Works and Environmental Services, NOVA Parks, Northern Virginia Regional Commission, and the Health Department.

31. <u>RECOGNITION OF BURKE LAKE AND OAK MARR GOLF CENTERS</u> (12:12 p.m.)

Supervisor Herrity congratulated the Park Authority and staff at Burke Lake Park for being recognized by Golf Range Association of America's Magazine as one of the Top 50 Public ranges in the country. This is the fourth time Burke Lake Golf Center is celebrating this distinction.

The Oak Marr Golf Center was also recognized in the top 50 for the second time. Supervisor Herrity stated that the County is very fortunate to have such outstanding parks.

32. <u>RESOLUTION REQUEST TO RECOGNIZE GEORGE MASON UNIVERSITY'S (GMU) 50TH ANNIVERSARY (12:12 p.m.)</u>

Supervisor Herrity announced that GMU will be celebrating its 50th Anniversary this year. It is ranked among the US World News and World Report's best national colleges and the most diverse university in Virginia. It is a tier one research university and six GMU programs earned the top 100 best colleges ranking, including engineering, which rose 16 spots in the past year, with an enrollment of 39,000 students representing 130 countries. GMU continues to make higher education affordable to all in the community. It also continues to be an invaluable community partner in so many areas from providing counseling and resources to the business community, partnering with the schools, supporting regional sports development, and most recently its nursing program doing the vaccinations in the Conference Room at the Government Center.

Therefore, Supervisor Herrity asked unanimous consent that the Board direct staff to prepare a Resolution, with dual signatures, recognizing George Mason University's 50th Anniversary, to be presented at its upcoming anniversary celebration.

Following discussion, Chairman McKay asked to amend the request to include the signatures of Supervisors who geographically represent GMU, and this was accepted. Therefore, without objection, it was so ordered.

33. PROCLAMATION REQUEST RECOGNIZING WESTERN FAIRFAX CHRISTIAN MINISTRIES (WFCM) 35 YEAR ANNIVERSARY (12:14 p.m.)

Supervisor Smith stated that this year marks the 35 Year Anniversary of WFCM, a non-profit that serves nearly 4,000 residents annually. WFCM serves as the anchor health and human services organization in Western Fairfax County providing basic needs services as well as longer-term support through in-house programs and partnerships.

WFCM was formed on March 6, 1987, by 12 congregations in Centreville, Chantilly and Fairfax seeking to collaborate and serve residents in need. During its 35-year history WFCM has been in several locations in Western Fairfax including the Keener Insurance Agency building in Centreville.

Currently, WFCM partners with over 750 local households, 38 local congregations, 36 local businesses, Fairfax County Government and several grantors and organizations in the community. This past year WFCM provided over \$1.1 million

in emergency housing assistance and over one million pounds of food to residents in Western Fairfax County.

Therefore, Supervisor Smith asked unanimous consent that the Office of Public Affairs prepare a proclamation, to be presented outside the Board Room, to recognize and honor Western Fairfax Christian Ministries for its outstanding service to the community. Without objection, it was so ordered.

34. RESOLUTION REQUEST TO PROCLAIM FEBRUARY 8, 2022, AS "WE LOVE FAIRFAX COUNTY PUBLIC SCHOOLS (FCPS) DAY" IN FAIRFAX COUNTY (12:16 p.m.)

Supervisor Smith stated that, as the Board knows, Fairfax County Public Schools plays an integral role in the lives of County residents. From the educational opportunities, to sparking a zeal for learning, to learning respect for others and being in a rich diverse environment County students grow and are enriched in the FCPS System.

The County has an amazing group of teachers and support staff that provide a safe and nurturing learning environment. These individuals dedicate themselves to educating young men and women who will flourish in the community.

The last couple of years have been particularly challenging to say the least. She urged all County residents to express support for the educators and staff in FCPS schools.

Therefore, jointly with Chairman McKay, Supervisor Palchik, and Supervisor Storck, Supervisor Smith asked unanimous consent that the Board declare February 8, 2022, as "We Love FCPS Day" in Fairfax County and direct staff to prepare a resolution to be presented outside the Board Room. Without objection, it was so ordered. A brief discussion ensued regarding the request.

35. <u>CEREMONIAL BYWAY — ESTABLISHING VALLUVAR WAY ON</u> BRENTWALL DRIVE (SULLY DISTRICT) (12:19 p.m.)

Supervisor Smith stated that Members of the Tamil community, a community of 10,000 plus that reside in the County, reached out to several members of the General Assembly, as well as her office, to establish a street named Valluvar Way. Thiru Valluvar was a celebrated Tamil poet and philosopher. Supervisor Smith said she has been working with Delegate Dan Helmer's Office and staff from the Department of Transportation (DOT) to establish a Ceremonial Byway for Valluvar Way on Brentwall Drive in the Sully District.

Delegate Helmer plans to introduce a bill to establish this Ceremonial Byway, and needs the concurrence of the locality to do so. Supervisor Smith stated her understanding that the County is on a tight timeline and staff will need to prepare a Resolution for the Board to vote on. Furthermore, it is her understanding that staff can prepare an item for the February 8 Board meeting.

Therefore, jointly with Chairman McKay, Supervisor Smith moved that the Board direct staff to:

- Prepare an item for a resolution to create a Ceremonial Byway for Valluvar Way
- Communicate to Delegate Helmer's Office the Board's intention to support the Resolution

Chairman McKay seconded the motion. Following a brief discussion regarding the motion, the question was called on the motion and it carried by a vote of nine, Supervisor Palchik being absent.

36. PROCLAMATION REQUEST TO RECOGNIZE HEALTH FOR HUMANITY YOGATHON (SULLY DISTRICT) (12:20 p.m.)

Supervisor Smith stated that the Hindu Swayamsevak Sangh, USA Inc, also known by its initials as HSS, is a non-profit socio-cultural organization which offers a structured value education program aimed at character building, honing leadership skills and community service. Through their sister-organization, the Sewa Annapurna, they provided hot meals to various homeless shelters throughout the Northern Virginia area.

HSS launched its "Health for Humanity Yogathon" as an annual event in 2007 to create awareness about yoga and its advantages in achieving a healthy body, mind, and spirit. The Surya Namaskar (Sun Salutation) yoga routine integrates simple postures of well-balanced movements along with an easy breathing technique in an effort to boost health benefits for everyone, from beginners to seasoned yoga enthusiasts.

Over the past several years, 18,000+ participants from 38 States took part. In the year 2020, the HSS conducted many programs in different locations across Virginia, including schools in Fairfax and Loudoun VA, to encourage students to participate. Ultimately, more than 400+ students benefited from this program in 2020.

This year, the HSS is conducting its annual "Health for Humanity Yogathon" from January 15–30, 2022. Therefore, Supervisor Smith moved that the Office of Public Affairs prepare a proclamation to be presented outside the Board Room to recognize HSS's continued service to the community and to congratulate the HSS on its Health for Humanity Yogathon. Chairman McKay seconded the motion and it carried by a vote of seven, Supervisor Herrity and Supervisor Lusk being out of the room, Supervisor Palchik being absent.

Supervisor Alcorn moved to defer the public hearing to Re-Purpose Developer Contributions to Fairfax County for Transportation Projects until <u>March 8, 2022</u>, <u>at 4 p.m.</u> Chairman McKay seconded the motion and it carried by a vote of nine, Supervisor Palchik being absent.

Cathy Muse, Director, Department of Procurement and Material Management presented the staff report.

Following the public hearing, which included testimony by three speakers, Ms. Muse presented the staff recommendation.

Supervisor Walkinshaw moved adoption of the Prevailing Wage Ordinance dated December 8, 2021, amending Chapter 2 of the Fairfax County Code by adding Article 3, Payment of Prevailing Wage for Work Performed on County Construction Contracts, Sections 2-3-1 and 2-3-2 and accept only the redline edits to the definition of County Construction Contract at Section 2-3-1(c). The December 8, 2021, Ordinance is Attachment 1 to the Agenda Item for today's public hearing and appears at pages 322-324 of the Board Agenda. The motion was multiply seconded.

Supervisor Walkinshaw asked unanimous consent that the Board direct staff to report to the Board regularly with the progress of the contract renewals to ensure compliance. Without objection, it was so ordered.

Discussion ensued, with input from Carey Needham, Deputy Director, Building Design and Construction Division, Department of Public Works and Environmental Services, and Ms. Muse, regarding the contracts and expectations.

Discussion continued, regarding the contract renewals, and with Board Members expressing their views/concerns and support/non-support of the motion.

Following further discussion, with input from Patty McCay, Assistant County Attorney, who noted, for the record, that the Ordinance appears on pages 324-326, instead of pages 322-324, of the Board Agenda, Supervisor Walkinshaw restated the correction in his motion.
