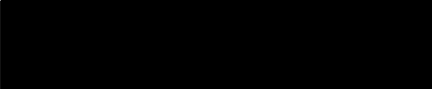
ORDERED that Defendant's Motion is DENIED for the reasons set forth in the Court's Letter Opinion of July 25, 2019.

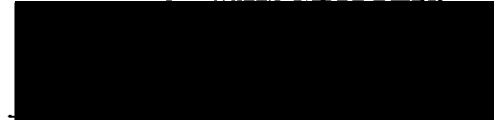
