Several years ago, after several police shootings in Portland, the Oregon legislature mandated that each county devise a "more standardized and transparent" system for dealing with officer-involved shootings. Included was a directive that each county conduct annual "community outreach and education" on law enforcement's use of deadly force. For 2011's public education requirement, Lane County produced a video that communicated basic facts about deadly force; it was posted online to be available when officials couldn't comment publicly on the specifics of an ongoing investigation.
