A reduced cost rabies clinic is available at the Sully Government Center in the James McDonnell room tomorrow.

#### Please note:

- 1. Dogs, cats, and ferrets will be vaccinated at the clinic.
- 2. Dogs MUST be on leashes. Cats and ferrets MUST be in carriers.
- All pets will receive a 1-year rabies vaccine. To obtain a 3-year vaccine, bring your
  pet's rabies certificate showing your dog's current rabies vaccination and expiration
  date.
- 4. Only rabies certificates will be issued (no tags).
- 5. The cost of each vaccination is \$15.00; cash and check only.
- 6. 2016 County Dog Licenses will be sold at each clinic at additional cost of \$10.00 each.

## Fairfax County's Environmental Vision Update

What's your vision for our environment in 2024? Fairfax County wants your help to update the Board of Supervisors' <u>Environmental Vision</u>.

While it is not an action plan, this vision is important because it helps to guide the county's environmental <u>sustainability initiatives and programs</u>.

"Our environmental vision is based on two key principles," says Board of Supervisors

Chairman Sharon Bulova. "First, we must conserve our limited natural resources. Second, we are committed to providing the resources needed to protect our environment."

You can make your thoughts known on changes, additions or updates to this vision through a short, online survey and three public meetings in July.

#### Take Environmental Survey

June 30 will be the last day to take the survey. It will help to identify environmental issues that are the greatest concern to the community and any updates that may be needed. Survey results will be summarized, and they will be posted on the project's web page, as well as presented at three public meetings.

### **Updating the Current Vision**

The current vision is organized into six major core service areas:

- Growth and land use
- Air quality and transportation
- Water quality
- Solid waste
- Parks/trails/open space
- Environmental stewardship

The update will take about a year to complete, starting with the survey and public meetings this summer. County staff will gather feedback and recommendations in a report that will be available to the public early next year for public comment. It's anticipated that the board will adopt its final, updated vision in 2017.
